Dear Chair Gates and Vice Chair Tam,

My name is Neal A. Palafox MD MPH. I was born and raised in Hawaii, a resident of Hawaii and work for the John A. Burns School for Medicine, University of Hawaii. I actively work with four COVID-19 response teams for the in the State of Hawaii, have worked an lived in the Republic of the Marshall Islands for 9 ½ years, and have worked with the Enewetak community in Ocean View for over 15 years. The views in this testimony are my own, and do not necessarily represent the State institutions where I am employed or which I work.

#### SB 2883 is intended to:

#### DESIGNATE MARCH 10 AS ENEWETAK ATOLL (MARSHALL ISLANDS) LIBERATION DAY

Enewetak Atoll , one the most North Western Atolls in the Republic of the Marshall islands , was occupied by the Japanese Military between 1914 through 1944. Fierce combat raged on different parts of Enewetak atoll between the Japanese and American forces during February 1944 as part of a major strategic encounter in the World War II Pacific war arena. After 2 weeks of ground combat and air bombing the American Forces prevailed liberating the Enewetak peoples. March 10<sup>th</sup> was the official designated liberation day, the 10<sup>th</sup> symbolizing coming out of their hiding in great fear for more than 10 days of the raging battle for Enewetak .

Enewetak then was used as one of two atolls in the Marshall Islands for above ground US Nuclear Weapons testing between 1946 to 1958. The island landscape was forever changed as a result of nuclear destruction, the Enewetak peoples were moved to accommodate the testing, and the northern part of Enewetak atoll currently remains contaminated with radioactive particles from the nuclear testing.

When they could, many of the Enewetak peoples began to resettle in a safer environment. Over many years the families found themselves settling in the lava fields of Ocean View , Hawaii Island --- located in Ka'u the Southern tip of Hawaii Islands. . There were no electrical lines, running water, or sewer facilities in this area when they began to settle their Enewetak community the 1990's , and there still is are no electrical lines, running water , or city sewage facilities for their community in 2022. Together they worked and evolved as a community and now thrive.

Recognizing March 10th as Liberation Day , the State of Hawaii and the Enewetak community recognizes their resilience , ie the positive adaptation of the Enewetak individuals and the community to an environment of adversity. The community has found a path to self- determination and reconciliation in its world view since the Japanese Occupation.

The Enewetak Community has kept its identity and cultural practices which has promoted its ability to thrive. As the community develops and further integrates into Hawaii's larger community, there is much to be learned about their resilience and ability to thrive in great adversity. The Enewetak community assets should be formally recognized, celebrated, and held up as a model from which to learn.
