1 **Department Position:** The Department of Health (Department) PROVIDES COMMENTS

2 supporting the intent of SCR225 and SR218. These measures would require the Department of

3 Human Services to issue guidance on lesbian, gay, bisexual, transgender, queer, plus (LGBTQ+)

4 specific training for Intimate Partner Violence (IPV) agencies.

5 **Department Testimony:** LGBTQ+ people are more vulnerable to IPV than non-LGBTQ+

6 people due to social stigma that comes with being a sexual and gender minority. According to

7 the "Hawai'i Sexual and Gender Minority Health Report" (2017), Lesbian, Gay, Bisexual and

8 Questioning youth were about twice as likely to have experienced dating violence in the previous

9 year as their heterosexual peers and the "Hawai'i Sexual and Gender Minority Health Report"

10 (2018) presented data showing that 50% of Transgender youth in Hawai'i had reported "being

11 raped or assaulted by a romantic partner" in the prior year.

12 There are different means by which LGBTQ+ people are victimized by IPV than non-LGBTQ+

13 members of the community. LGBTQ+ may have fewer resources to escape the IPV due to

14 families and communities who reject them. LGBTQ+ people are less likely to seek help for IPV

15 due to uninformed providers who provide services in heterosexist, harmful ways. The lack of

- 1 supportive services for LGBTQ+ victims of IPV exacerbates mental health issues such as
- 2 depression, anxiety, and suicidality, which disproportionately affect LGBTQ+ youth and adults.
- 3 Specific LGBTQ+ training of service providers such as those providing services to victims of
- 4 IPV is a critical component of providing appropriate services to meet the needs of this population
- 5 and thereby reducing the negative physical and mental health effects of IPV. These trainings are
- 6 readily available and free through many sources such as The National LGBTQIA+ Health Center
- 7 (https://www.lgbtqiahealtheducation.org/courses/intimate-partner-violence-in-lgbtq-
- 8 <u>communities/</u>) and locally through the Hawaii State Coalition Against Domestic Violence
- 9 (https://www.hscadv.org/).
- 10 The Child and Adolescent Mental Health Division Safe Spaces Committee and the Department
- of Health Sexual and Gender Minority Workgroup offer the Department of Human Services
- 12 support in researching and crafting appropriate guidelines on LGBTQ+ training for Intimate
- 13 Partner Violence agencies if the Department of Human Services needs assistance with such
- 14 guidelines.

DEPARTMENT'S POSITION: The Department of Human Services (DHS) appreciates the intent of these resolutions and provides comments.

PURPOSE: These resolutions request the Department of Human Services to develop LGBTQ+ specific training guidelines for intimate partner violence agencies that serve and assist LGBTQ+ survivors, to obtain input for the training guidelines from relevant advocates and professionals; and that the intimate partner violence agencies that serve and assist LGBTQ+ survivors are requested to receive the training guidelines developed by the Department of Human Services to address the needs of LGBTQ+ survivors.

For the Legislature's information, several local and national organizations provide training to serve and assist LGBTQ+ survivors. For example, the Hawaii State Coalition Against

Domestic Violence recently completed a series entitled "Exercising Cultural Humility with the Lesbian, Gay, Bisexual and Transgender Communities." The series included the following learning objectives: create safety plans that cater to survivors of LGBTQ+ abusive relationships with sexual violence components, describe how organizations can be trauma-informed, provide better environments to LGB&T survivors, and analyze resources and skills to help LGB&T survivors navigate social and judicial systems. Other local and national organizations sponsor and support training events and resources.

Additionally, the Department's ShakaTown.Org website for former foster youth has a resource page to support Lesbian, Gay, Bisexual, Transgender & Queer Youth (LGBTQ) Children, Youth, And Families, see https://shakatown.com/lgbtq/resources.

The Department will work with organizations interested in developing or compiling the relevant curriculum.
