In consideration of SENATE CONCURRENT RESOLUTION 243 ENGAGING, ENDORSING, ACCEPTING, AND ADOPTING THE NEW YORK DECLARATION ON FORESTS TO ACHIEVE THE UNITED NATIONS PARIS AGREEMENT AND THE 2030 AGENDA FOR SUSTAINABLE DEVELOPMENT, SPECIFICALLY SUSTAINABLE DEVELOPMENT GOAL 15, LIFE ON LAND.

Senate Concurrent Resolution 243 encourages the State to endorse, accept, and adopt the New York declaration on forests to achieve the United Nations Paris Agreement and the 2030 agenda for sustainable development, specifically Sustainable Development Goal 15, Life On Land. The Department of Land and Natural Resources (Department) supports this measure as it complements ongoing Department initiatives.

The New York Declaration on Forests aims to half the loss of natural forests by 2020 and strives to end it by 2030. Currently, the Department is working toward the 30×30 Watershed Initiative to protect 30% of Hawaii's priority watershed forests by the year 2030. The Department would require additional financial investment in order to achieve the goals of the New York Declaration on Forests including funding for additional forest health measures including early detection and rapid response to forest diseases such as rapid ohia death, watershed fences, invasive species control, and wildfire management and mitigation.

Sustainable Development Goal 15 is core to the Department's terrestrial mission to ensure the conservation, restoration, and sustainable use of terrestrial ecosystems and cultural and historic resources, in partnership with others from the public and private sectors.

Aloha, Chair Gabbard, Vice Chair Nishihara, and Members of the Committees on Agriculture and Environment:

The Environmental Caucus of the Democratic Party of Hawaii strongly supports SCR 243.

The NYDF outlines ten global targets related to protecting and restoring forests, which, if realized, have the potential to reduce annual carbon emission by 4.5 to 8.8 billion tons of CO2 – the equivalent of the annual emissions of the United States. The ten goals of the NYDF are: (1) stop forest loss; (2) eliminate deforestation from agricultural activities; (3) reduce non-agricultural deforestation; (4) support alternatives to deforestation for subsistence farming, fuel, and other basic needs; (5) restore forests; (6) qualify forest conservation and restoration targets for 2030 as part of the 2030 Agenda SDGs; (7) reduce emissions from deforestation and forest degradation in accordance with global climate agreements; (8) provide financing for forest action; (9) reward countries and jurisdictions that reduce forest emissions; and (10) strengthen governance, empower communities, and recognize the rights of indigenous peoples. Thus, adopting the NYDF would accelerate progress with new partnerships to achieve the United Nations Paris Agreement and the United Nations 2030 Agenda.

This Resolution urges the federal leaders and the nation to embrace the goals of the NYDF and the 2030 Agenda and make sustainable development the centerpiece of national social and sustainable policies with is sorely needed.
