A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. There is appropriated out of the general
2	revenues of the State of Hawaii the sum of \$200,000,000 or so
3	much thereof as may be necessary for fiscal year 2022-2023 for
4	the school facilities authority to expand access to pre-
5	kindergarten to eligible children of the State. The school
6	facilities authority may expend the moneys appropriated in this
7	section on:
8	(1) The construction of new school facilities;
9	(2) The renovation, improvement, and expansion of existing
10	school facilities to increase pre-kindergarten student
11	capacity; and
12	(3) Any other costs the school facilities authority deems
13	appropriate to increase pre-kindergarten student
14	capacity within the State.
15	The sum appropriated shall be expended by the school
16	facilities authority for the purposes of this Act; provided that
17	the appropriation authorized by this Act shall not lapse at the

- 1 end of the fiscal biennium for which the appropriation is made;
- 2 provided further that all moneys from the appropriation
- 3 unencumbered as of June 30, 2024, shall lapse as of that date.
- 4 SECTION 2. This Act shall take effect on July 1, 2022.
