### A BILL FOR AN ACT

RELATING TO LITTER CONTROL.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that litter is a 2 continuing problem in the State. In addition to being visually 3 unappealing along roadways and in public spaces, litter is the 4 cause of many environmental issues, such as the contamination of 5 local waterways and the ocean. The legislature further finds 6 that cleaning the environment is essential to the life and 7 survival of the State and the planet. Properly maintaining a 8 clean environment reduces pollution, preserves the biosphere, 9 protects endangered species, and conserves natural resources. 10 The cleanliness of a state represents that state's mentality, 11 and Hawaii, with its abundance of natural resources, ought to be 12 a frontrunner in promoting a clean and healthy environment to 13 protect and preserve its unique natural resources.

14 The legislature also finds that anti-litter campaigns are a 15 proven and effective way to raise public awareness and promote 16 civic responsibility toward the reduction of litter in the 17 State. Currently, the department of transportation administers

1 the adopt-a-highway program, which is a public service program 2 that allows environmentally conscious citizens to contribute to 3 a cleaner Hawaii by using volunteers to pick up litter along the 4 State's highways. The existing program requires a program 5 participant to clean a two-mile portion of a state highway for a 6 minimum of two years, pick up litter on that highway at least 7 four times per year, and provide safety training for their 8 volunteers. The legislature believes that reducing the minimum 9 years a program participant must agree to clean up litter on a 10 state highway to one year will promote increase participation 11 from more organizations and people. 12 Accordingly, the purpose of this Act is to: 13 Require the department of transportation to reduce the (1)14 minimum number of years an adopt-a-highway program 15 participant must agree to clean up litter on a highway 16 from two years to one year; and 17 (2) Appropriate funds for the department of transportation 18 to establish an anti-litter campaign. 19 SECTION 2. The department of transportation shall amend 20 the requirements for the adopt-a-highway program to reduce the
