

A BILL FOR AN ACT

RELATING TO NOISE POLLUTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 Section 1. The legislature finds that noise pollution is a
- prevalent and increasing problem in the State. Exposure to 2
- 3 excessively loud and unabated noises can result in
- physiological, psychological, and economic damage. There is a 4
- continuous and increasing bombardment of noise in the urban, 5
- suburban, and rural areas. 6
- The legislature further finds that excessively loud 7
- vehicles, such as motor vehicles with after-market modifications 8
- to engine or exhaust systems, are a significant source of noise 9
- pollution in the State. These excessively loud vehicles impair 10
- the peace and tranquility that is part of the beauty of the 11
- Hawaiian islands and constitute a public nuisance. 12
- Citizens of Hawaii are entitled to a healthy and peaceful 13
- environment. They have the right to be free from noise 14
- 15 pollution that may be hazardous to their health or welfare.
- Regulatory efforts have been made to protect this right under 16
- chapter 342F, Hawaii Revised Statues, and administrative rules 17

- 1 adopted thereunder. In addition, section 46-17, Hawaii Revised
- 2 Statutes, authorizes any county to adopt ordinances regulating
- 3 noise, among other things. The legislature finds, however, that
- 4 existing regulatory measures are not effectively enforced and do
- 5 not adequately address noise pollution emitted by excessively
- 6 loud vehicles.
- 7 Accordingly, the purpose of this Act is to direct the
- 8 department of health to promulgate rules for the control,
- 9 prevention, and abatement of noise pollution emitted by
- 10 excessively loud vehicles in the State.
- 11 SECTION 2. Section 342F-30.5, Hawaii Revised Statutes, is
- 12 amended to read as follows:
- "[+] §342F-30.5[+] Noise control. (a) By June 30, 1996,
- 14 the department shall adopt a state community noise code pursuant
- 15 to chapter 91, which recognizes differences in noise level
- 16 standards in urban and non-urban areas of the State and noise
- 17 level standards of each county.
- 18 (b) By June 30, 2023, the department shall adopt rules
- 19 pursuant to chapter 91 for the control, prevention, and
- 20 abatement of noise pollution emitted by vehicles in the State.

1	These rul	es shall regulate the emission of noise by the measure
2	of decibe	ls. In addition:
3	(1)	No person shall operate a vehicle that emits noise in
4		excess of the decibel limitation or limitations
5		adopted pursuant to this subsection;
6	(2)	No owner of a vehicle shall allow a vehicle to emit
7		noise in excess of the decibel limitation or
8		limitations adopted pursuant to this subsection; and
9	(3)	No person shall sell or offer for sale a vehicle that
10		emits noise in excess of the decibel limitation or
11		limitations adopted pursuant to this subsection.
12	Any count	y may adopt a rule or ordinance that places stricter
13	limitatio	ons on vehicles than are promulgated by the department
14	pursuant	to this subsection. To the extent of a conflict, the
15	more restrictive requirement shall apply.	
16	(c) In the event of any conflict between this section and	
17	section 46-17, section 46-17 shall govern."	
18	SECTION 3. Section 342F-31, Hawaii Revised Statutes, is	
19	amended to read as follows:	
20	"[+]	§342F-31[] Rules; specific. The director may
21	establish	n by rule[÷



1	(1) The control of vehicular noise; and
2	(2) Other specific areas for control of excessive
3	noise, thereby allowing for varying conditions."
4	SECTION 4. Statutory material to be repealed is bracketed
5	and stricken. New statutory material is underscored.
6	SECTION 5. This Act shall take effect upon its approval.
