# A BILL FOR AN ACT

RELATING TO THE OFFICE OF HEALTH CARE ASSURANCE SPECIAL FUND.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that establishing the
- 2 ceiling of the office of health care assurance special fund
- 3 through the state budget process provides greater flexibility to
- 4 the legislature to review spending proposals and allows the
- 5 department of health to avoid an artificial fiscal ceiling. The
- 6 legislature further finds that the office of health care
- 7 assurance special fund can be used to offset increasing
- 8 operational expenses, upgrade and expand the department of
- 9 health's management information system for the health care
- 10 facility licensing program, implement and upgrade a web-based
- 11 portal for a robust industry-wide background check system for
- 12 criminal history and registry checks on health care facility
- 13 licensees and employees, fund state licensing surveyor and
- 14 support positions where general funds were eliminated or
- 15 reduced, and fund other contracts for inspection services.
- 16 The purpose of this Act is to remove the ceiling of the
- 17 office of health care assurance special fund.

- 1 [Not more than \$327,000 of the special fund may be used during
- 2 any fiscal year for the activities carried out by the office of
- 3 health care assurance.
- 4 (c) [Any amount in the special fund in excess of \$387,500
- 5 on June 30 of each year shall be deposited into the general
- 6 fund. Moneys in the special fund may be used during any fiscal
- 7 year for the activities carried out by the office of health care
- 8 assurance."
- 9 SECTION 2. Statutory material to be repealed is bracketed
- 10 and stricken. New statutory material is underscored.
- 11 SECTION 3. This Act shall take effect on July 1, 2060.
