A BILL FOR AN ACT

RELATING TO CONCESSIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to provide the 2 department of transportation flexibility and discretion to provide fair and important relief to all concessions who are 3 4 struggling in times of unpredictable crisis to remain in place 5 and provide services to passengers, including those on a 6 holdover or revocable permit who may have not been able to 7 receive relief granted to those operating under lease 8 agreements. 9 SECTION 2. Section 102-10, Hawaii Revised Statutes, is amended to read as follows: 10 11 "§102-10 Modification of contract terms. [#] Notwithstanding any other law to contrary, if during the term of 12 13 the contract [4], including [contracts which have] any type of 14 lease, holdover, revocable permit, or formalized agreement that has been executed [and are] or is presently in force [+], there 15 has been a reduction of fifteen per cent or more in the volume 16 of business of the concessionaire for a period of sixty days or 17

more, computed on the average monthly gross income for the 1 eighteen months just prior to the period or as long as the 2 3 concessionaire has been in the business, whichever period is shorter, and such reduction as determined by the officer letting 4 5 the contract is caused by construction work conducted during the 6 period of time on, or within or contiguous to, the public 7 property upon which the concession is located by either the 8 state or county governments, or both, the officer, with the 9 approval of the governor in the case of a state officer and the 10 chief executive of the respective county in the case of a county officer, may modify any of the terms of the contract, including 11 the agreed upon rent, for a period which will allow the 12 concessionaire to recoup the amount lost by such reduction; 13 provided that if the contract includes provisions allowing 14 modification for the above contingencies, this section shall not 15 be applicable thereto; provided further that this provision 16 shall not apply to any particular concession if the application 17 18 thereto may impair any contractual obligations with bondholders of the State or counties or with any other parties." 19

20 SECTION 3. Statutory material to be repealed is bracketed21 and stricken. New statutory material is underscored.
