
A BILL FOR AN ACT

RELATING TO CORAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the commercial use
2 of coral contributes to the decline and degradation of the
3 State's coral reefs. The import and export of coral for
4 jewelry, curios, and other products lead to overharvesting and
5 risks damage to vulnerable reef ecosystems. The legislature
6 recognizes that while stony corals are legally protected in
7 Hawaii, the sale, import, and export of coral jewelry in the
8 State still threaten coral reefs and reef ecosystems in Hawaii
9 and other parts of the world.

10 Accordingly, the purpose of this Act is to prohibit the
11 sale, import, harvest, or export of coral products, with certain
12 exceptions.

13 SECTION 2. Chapter 187A, Hawaii Revised Statutes, is
14 amended by adding a new section to part I to be appropriately
15 designated and to read as follows:

16 "§187A- Sale, import, harvest, or export of coral
17 products; prohibited. (a) It shall be unlawful for any person



1 to import into, export from, sell in, harvest, or offer for sale
2 in the State any coral product.

3 (b) This section shall not apply to:

4 (1) Coral products imported, exported, sold, harvested, or
5 offered for sale for the purposes of:

6 (A) Research or scientific identification by an
7 accredited museum or university;

8 (B) Rehabilitation or restoration of historic and
9 culturally significant Hawaiian sites;

10 (C) Cultural practices and sacraments performed by
11 native Hawaiians;

12 (D) Use as limestone or construction materials,
13 cosmetics, or medicines;

14 (E) Education; or

15 (F) Harvesting by the State pursuant to a special
16 activity permit for non-commercial purposes; and

17 (2) Coral products or harvesting expressly authorized by
18 federal law or federal permit for non-commercial
19 purposes.

20 (c) As used in this section:

21 "Coral" means a species of the phylum Cnidaria, including:



1 (1) All species of the orders Antipatharia (black corals),
2 Scleractinia (stony corals), Gorgonacea (horny
3 corals), Stolonifera (organpipe corals and others),
4 Alcyonacea (soft corals), and Coenothecalia (blue
5 coral) of the class Anthozoa; and

6 (2) All species of the order Hydrocorallina (fire corals
7 and hydrocorals) of the class Hydrozoa;

8 provided that "coral" does not include jellyfish or man o' war.

9 "Coral product" means any product, including curios,
10 jewelry, and other novel commercial products, that is made from
11 dead coral or coral skeleton."

12 SECTION 3. No later than December 31, 2024, the department
13 of land and natural resources shall amend its administrative
14 rules in accordance with chapter 91, Hawaii Revised Statutes,
15 and this Act.

16 SECTION 4. This Act does not affect rights and duties that
17 matured, penalties that were incurred, and proceedings that were
18 begun before its effective date.

19 SECTION 5. New statutory material is underscored.

20 SECTION 6. This Act shall take effect on July 1, 2050.
