# A BILL FOR AN ACT

RELATING TO PRISON REFORM.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The Hawaii Revised Statutes is amended by
2	adding a new chapter in title 32 to be appropriately designated
