- 1 SECTION 1. Act 209, Session Laws of Hawaii 2018, section
- 2 4, as amended by section 1 of Act 128, Session Laws of Hawaii
- 3 2019, is amended as follows:
- 4 1. By amending subsection (a) to read:
- 5 "(a) Contracts entered into by the agencies designated by
- 6 the governor pursuant to the ohana zones pilot program shall be
- 7 exempt from the requirements of chapters 6E, 46, 92, 103D [and],
- 8 103F, 104, 171, 205, 205A, 206E, 343, and 346, and sections 37-
- 9 41, 37-74(d)(1), 40-66, 102-2, 103-2, 103-53, 103-55, 105-1
- 10 through 105-10, and 464-4, Hawaii Revised Statutes."
- 11 2. By amending subsection (f) to read:
- "(f) The pilot program shall cease to exist on June 30,
- **13** [2023.] 2026."
- 14 SECTION 2. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ or so
- 16 much thereof as may be necessary for fiscal year 2022-2023 for
- 17 the ohana zones pilot program established pursuant to Act 209,

- 5 The sum appropriated shall be expended by the office of the
- 6 governor for the purposes of this Act; provided that the
- 7 governor shall transfer the expenditure authority to designated
- 8 executive branch departments or agencies within a reasonable
- 9 time.
- 10 Notwithstanding any other law to the contrary, the governor
- 11 may transfer all or a portion of the appropriation in this
- 12 section to the governor's designated executive branch agencies
- 13 for expenditures incurred in implementing the ohana zones pilot
- 14 program.
- The governor's designated executive branch agencies may
- 16 expend any appropriation transferred pursuant to this section
