A BILL FOR AN ACT

RELATING TO THE ADVICE AND CONSENT OF THE SENATE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 26-31, Hawaii Revised Statutes, is 1 2 amended to read as follows: 3 "§26-31 Selection and terms of single executives as heads 4 of departments [-]; selection of deputy directors and deputy 5 chairs of departments. (a) Except as otherwise provided by the 6 Constitution of the State or by this chapter, each principal 7 department shall be headed by a single executive, who shall be 8 nominated and, by and with the advice and consent of the senate, 9 appointed by the governor, for a term to expire at the end of 10 the term for which the governor was elected. A vacancy 11 occurring during a term shall be filled for the unexpired 12 balance of the term, subject to the provisions of Article V, 13 section 6 of the Constitution of the State. The governor may 14 remove a single executive from office at any time, except that 15 the removal of the attorney general shall be subject to the 16 advice and consent of the senate.
