A BILL FOR AN ACT

MAKING EMERGENCY APPROPRIATIONS TO THE DEPARTMENT OF DEFENSE RELATING TO COVID-19 EXPENDITURES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. This Act is recommended by the governor for immediate passage in accordance with article VII, section 9, of 2 the Constitution of the State of Hawaii. 3 SECTION 2. The legislature finds that the impact of the 4 5 SARS-CoV-2 virus and resulting coronavirus disease 2019 6 (COVID-19) has been devastating to global, national, and state 7 economies. 8 The Coronavirus Aid, Relief, and Economic Security Act 9 (CARES Act), Public Law 116-136, was enacted on March 27, 2020, 10 to address the extensive health and economic fallout of the COVID-19 pandemic and provided federal funds to support the 11

12 State's COVID-19 relief efforts. With the expiration of federal 13 CARES Act funds, the State finds that additional funds are 14 needed to continue funding critical COVID-19 response programs 15 and activities for the remainder of fiscal year 2020-2021.

Should any project or program paid for by state funds under this Act later become eligible for federal 5 reimbursement, the federal reimbursement funds shall be 6 deposited into the general fund. 7 SECTION 10. This Act shall take effect on July 1, 2050; 8 provided that all funds appropriated pursuant to this Act that 9

10 are unallotted or unencumbered shall lapse as of June 30, 2022.
