
HOUSE CONCURRENT RESOLUTION

RECOGNIZING THE HISTORIC, CULTURAL, AND STRATEGIC CONNECTIONS
AMONG THE PEOPLES OF OCEANIA, OF WHICH HAWAI'I IS A PART,
AND URGING GREATER COLLABORATION WITH GOVERNMENTS OF
NATIONS AND PROGRAMS AND TRAINING TO COMBAT DISCRIMINATION
AGAINST PACIFIC ISLAND COMMUNITIES.

1 WHEREAS, the Oceania region in the Pacific Ocean
2 constitutes what has been described by renowned Tongan scholar
3 Epeli Hau'ofa as a "sea of islands", with interconnections of
4 history, culture, and strategic interests; and

5
6 WHEREAS, some historians argue that civilizations in
7 Oceania did not consider the boundary of their islands as being
8 limited to their shorelines but rather to a perceived space in a
9 much broader sense of space that extended far across the sea and
10 sky; and

11
12 WHEREAS, the diverse cultures and peoples of Oceania have
13 significant deep and historic ties among one another, such as
14 the contemporary theory that originally, Pacific Island peoples
15 migrated from Taiwan and Southeast Asia; and

16
17 WHEREAS, other commonalities include an Austronesian
18 linguistic background, hundreds of years of trade across the
19 Pacific prior to western contact and similar understandings of
20 spirituality such as the concept of mana, as well as similar
21 cultural practices such as the use and preparation of taro; and

23 WHEREAS, the geographical and anthropological descriptions
24 of Melanesia, Micronesia, and Polynesia are western
25 categorizations of the Pacific Islands that by themselves do not
26 fully capture the complex and diverse nature of cultures in
27 Oceania; now, therefore,

1 BE IT RESOLVED by the House of Representatives of the
2 Thirty-first Legislature of the State of Hawaii, Regular Session
3 of 2022, the Senate concurring, that this body recognizes the
4 historic, cultural, and strategic connections among the peoples
5 of Oceania, of which Hawai'i is a part; and

6
7 BE IT FURTHER RESOLVED that this body recognizes the
8 contributions and accomplishments of the people from Pacific
9 Island nations and territories in the State of Hawai'i, and
10 condemns racial and cultural discrimination, violence, and
11 defamation against these individuals; and

12
13 BE IT FURTHER RESOLVED that this body urges the Governor
14 and executive departments to collaborate and exchange best
15 practices with the corresponding government officials of these
16 nations on commonly shared policy issues such as combating sea
17 level rise; strengthening ecological protection; furthering
18 natural disaster mitigation and economic development; managing
19 tourism, rural or remote access to healthcare and other
20 necessities, and agricultural production; and promoting
21 indigenous rights; and

23 BE IT FURTHER RESOLVED that this body urges the Governor to
24 implement programs and training to combat discrimination against
25 Pacific Island communities; and

27 BE IT FURTHER RESOLVED that certified copies of this
28 Concurrent Resolution be transmitted to Hawai'i's congressional
29 delegation; Governors of Guam, American Samoa, Commonwealth of
30 the Northern Mariana Islands, Papua, and New Guinea; Government
31 President of New Caledonia and French Polynesia; Prime Minister
32 of the Cook Islands; Administrator Superior and Assembly
33 President of Wallis and Futuna; Consulates General and heads of
34 state of the Republic of Palau, Republic of the Marshall
35 Islands, Federated States of Micronesia, Commonwealth of
36 Australia, Independent State of Papua New Guinea, New Zealand,
37 Democratic Republic of Timor-Leste, Republic of Fiji, Solomon
38 Islands, Republic of Vanuatu, Independent State of Samoa,
39 Republic of Kiribati, Kingdom of Tonga, Tuvalu, Republic of
40 Nauru, Niue, French Republic, and Republic of Indonesia;

42 of Health; Director of Public Safety; Superintendent of
