## HOUSE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF ACCOUNTING AND GENERAL SERVICES, IN COORDINATION WITH THE DEPARTMENT OF AGRICULTURE, TO IMPLEMENT BIRTH CONTROL STRATEGIES TO CURTAIL THE PIGEON POPULATION AT THE STATE CAPITOL AND SURROUNDING AREAS.

WHEREAS, pigeons have established themselves in areas 1 2 throughout the State Capitol and surrounding areas; and 3 WHEREAS, significant areas of the State Capitol rotunda 4 5 have been overwhelmed with pigeons and pigeon excrement; and 6 7 WHEREAS, State Capitol is the center of Hawaii government and, after a few years of being closed due to the COVID-19 8 9 pandemic, will soon be reopened to the public; and 10 WHEREAS, despite current bird population control methods to 11 help reduce the pigeon population, such as trapping and 12 poisoning, pigeons are rapid breeders and appear to have 13 increased their population significantly at and near the State 14 15 Capitol; and 16 17 WHEREAS, while poisons pose a threat to the environment and 18 other animals, including pets, contraceptives are a safer, preferable, long-term solution for controlling feral bird 19 20 populations; and 21 22 WHEREAS, nicarbazin is a nonhazardous drug proven to be an effective contraceptive for a variety of bird species; and 23 24 25 WHEREAS, OvoControl P, a general use pesticide containing 26 nicarbazin, is approved and registered by the United States 27 Environmental Protection Agency to prevent the breeding of 28 pigeons and other avian species; and 29

1 WHEREAS, as a humane and nonlethal control method, 2 OvoControl P was used successfully by several businesses in Waikiki, including the Honolulu Zoo and International Market 3 4 Place, to abate their pigeon populations; and 5 6 WHEREAS, the use of birth control strategies using methods such as OvoControl P to control the pigeon population in and 7 around the State Capitol will be of great benefit to promote a 8 higher quality of life and safety for all those who frequent the 9 10 State Capitol and surrounding areas; now, therefore, 11 12 BE IT RESOLVED by the House of Representatives of the 13 Thirty-first Legislature of the State of Hawaii, Regular Session 14 of 2022, the Senate concurring, that the Department of 15 Accounting and General Services, in coordination with the Department of Agriculture, is requested to implement birth 16 control strategies to curtail the pigeon population at the State 17 18 Capitol and surrounding areas; and 19 20 BE IT FURTHER RESOLVED that the Department of Agriculture 21 is requested to file a Special Local Needs or Section 24(c) 22 registration of the Federal Insecticide, Fungicide, and 23 Rodenticide Act, with the United States Environmental Protection 24 Agency to allow the use of OvoControl P as part of the birth control strategies to control the pigeon population at the State 25 Capitol and surrounding areas; and 26 27 28 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the Administrator of the 29 United States Environmental Protection Agency, Comptroller, and 30 31 Chairperson of the Board of Agriculture. 32 33 the M. 34 OFFERED BY:
