## HOUSE RESOLUTION

URGING THE COUNTIES TO MORE EFFECTIVELY AND MEANINGFULLY COORDINATE THEIR POLICE ENFORCEMENT AND PUBLIC AWARENESS EFFORTS WITH THE STATE AND WITH HUMANE SOCIETIES AND OTHER ANIMAL WELFARE ORGANIZATIONS CONCERNING THE DANGERS POSED BY UNLEASHED DOGS TO HUMANS AND TO OTHER ANIMALS IN PUBLIC AREAS.

WHEREAS, in Act 30, Session Laws of Hawaii 2021, the 1 Legislature found that dog bites are among the top reasons for 2 emergency room visits, ranking higher than injuries occurring on 3 motorcycles, to pedestrians, and from qunshots; and 4 5 WHEREAS, section 142-74, Hawaii Revised Statutes, creates a 6 7 civil action for an incident when a dog attacks another animal, and also allows for counties to promulgate their own ordinances 8 for enforcement of county animal control policy, whether in park 9 areas or on other public lands; and 10 11 WHEREAS, section 142-75 Hawaii Revised Statutes, creates a 12 13 civil action for a dog attack on humans, and also allows for counties to promulgate their own ordinances for enforcement of 14 county animal control policy, whether in park areas or on other 15 public lands; and 16 17 WHEREAS, unleashed dogs potentially pose a serious danger 18 not only to humans but also to other pet animals; and 19 20 21 WHEREAS, serious bodily injury to a person such as by laceration would constitute felony assault if performed by a 22 person but only constitutes a misdemeanor for the dog owner if 23 the result of a dog bite; and 24 25 WHEREAS, an attack by an unleashed dog on a leashed dog can 26 easily result in serious injury or death to the leashed animal, 27 as well as potentially serious injury and emotional distress to 28 any person attempting to prevent or disengage the attacking 29 animal from causing harm; and 30 31

1 WHEREAS, all counties require by ordinance or 2 administrative rule that, with the exception of a limited number 3 of enclosed public off-leash dog parks, all dogs must be on a 4 leash in public areas, including on all public sidewalks and 5 roadsides; and 6

WHEREAS, a substantial majority of all state parks and 7 recreation areas, as well as a majority of all county parks and 8 recreation areas, prohibit all pet animals generally, including 9 both leashed and unleashed dogs, and despite clearly posted 10 signs prohibiting animals, many persons bring dogs to such 11 areas, creating a potentially dangerous situation for park users 12 13 who have a reasonable expectation that lawful prohibitions on animals will be enforced; and 14

16 WHEREAS, humane societies or other animal welfare 17 organizations in each county are authorized to provide animal 18 control, impoundment, and destruction services under certain 19 circumstances in coordination with county police departments for 20 incidents involving dog-on-animal and dog-on-human attacks; and 21

WHEREAS, for a person who has been bitten by a dog or whose 22 23 animal has been bitten by a dog, and who chooses to contact 24 authorities to seek criminal or civil remedies, the delineation 25 of roles and enforcement authority among county police departments, state park enforcement authorities in the case of 26 state parks, and the humane societies or any other animal 27 28 welfare organization can be unclear and confusing, and often 29 results in the appearance of one enforcement authority assigning 30 responsibility or blame to a different authority without providing meaningful assistance to the affected person; and 31 32

33 WHEREAS, increased education of the public concerning leash laws, sanctions for violations of prohibitions on animals in 34 certain parks and recreation areas, possible civil and criminal 35 penalties in the event of dog-on-animal or dog-on-human attacks, 36 and the actual roles of county or state law enforcement 37 authorities and humane society or other animal welfare 38 organization control officers would increase public confidence 39 40 in enforcement and make public areas safer; now, therefore, 41

1 BE IT RESOLVED by the House of Representatives of the Thirty-first Legislature of the State of Hawaii, Regular Session 2 of 2022, that the City and County of Honolulu, County of Maui, 3 County of Hawaii, and County of Kauai are strongly urged to 4 strengthen their efforts to meaningfully enforce all laws, 5 ordinances, and administrative rules regarding off-leash animals 6 in public spaces so as to better protect the public and pet 7 8 animals; and

BE IT FURTHER RESOLVED that the City and County of Honolulu, County of Maui, County of Hawaii, and County of Kauai are strongly urged, with respect to state parks within their jurisdictions, to pro-actively coordinate their county police department efforts with the enforcement officers of the Division of State Parks of the Department of Land and Natural Resources; and

18 BE IT FURTHER RESOLVED that the county police departments 19 of each of the counties are urged to strengthen their efforts to coordinate animal control services with each of the authorized 20 21 humane societies or animal welfare organizations within their 22 jurisdiction and, in the case of a dog attack on a human or dog attack on another animal, that all complainants requesting 23 assistance receive an immediate and clear explanation of the 24 25 delineation of roles among all enforcement authorities and entities, including explanation of any lawful impoundment or 26 27 destruction procedures and potential civil or criminal remedies under state or county law; and 28

BE IT FURTHER RESOLVED that the City and County of
Honolulu, County of Maui, County of Hawaii, and County of Kauai,
together with any humane societies or animal welfare
organizations authorized within their jurisdictions for purposes
of animal control, are strongly urged to undertake public
awareness activities bringing attention to the dangers posed by
unleashed dogs to humans and other animals; and

38 BE IT FURTHER RESOLVED that certified copies of this 39 Resolution be transmitted to the Chairperson of the Board of 40 Land and Natural Resources, Director of the Department of Parks 41 and Recreation of the City and County of Honolulu, Director of 42 the Department of Parks and Recreation of the County of Maui,
