HOUSE RESOLUTION

REQUESTING THE DEPARTMENT OF EDUCATION TO IMPLEMENT SENSORY ROOMS FOR CHILDREN DIAGNOSED WITH AUTISM SPECTRUM DISORDER IN ALL SCHOOLS.

WHEREAS, the National Institute of Mental Health describes 1 autism spectrum disorders as a group of developmental disorders 2 3 that affects communication and behavior and is said to be a "developmental disorder" because symptoms generally appear in 4 5 the first two years of life; and 6 7 WHEREAS, without the proper care and management at a young 8 age, children diagnosed with an autism spectrum disorder may 9 have difficulty communicating and interacting with other people and will experience symptoms that hurt their ability to function 10 properly in school, work, and other areas of life; and 11 12 13 WHEREAS, the Department of Education tracks the number of students eligible for the Individuals with Disabilities 14 15 Education Act services under the autism spectrum disorder category and based on the official December 2019 count, the 16 number of students with autism spectrum disorder is two thousand 17 eighty-eight; and 18 19 WHEREAS, a sensory room is a therapeutic space with a 20 variety of equipment that provides students with special needs 21 with personalized sensory input; and 22 23 24 WHEREAS, sensory rooms also help students calm and focus 25 themselves so they can be better prepared for learning and interacting with others; and 26 27 28 WHEREAS, installing sensory rooms in Hawaii's public schools will help children learn to self-regulate their 29 behaviors and improve their focus, allowing them to achieve 30 31 success in the classroom; now, therefore, 32
