
HOUSE RESOLUTION

REQUESTING THE CITY AND COUNTY OF HONOLULU TO PURCHASE CERTAIN
TAX MAP KEY PARCELS TO BE USED FOR ADDITIONAL PARKING AND
OTHER COMMUNITY NEEDS, AS DEEMED NECESSARY BY THE CITY AND
COUNTY OF HONOLULU.

1 WHEREAS, the City and County of Honolulu has been
2 experiencing a steady increase in the number of residents and
3 visitors over the past decade; and
4

5 WHEREAS, the Island of Oahu experienced a population growth
6 rate of 6.6 percent from 2010 to 2020, the highest of all the
7 counties, and, for the first time ever, its population reached
8 over 1,000,000; and
9

10 WHEREAS, in 2019, the State experienced a record high
11 number of visitors, reaching 10,400,000; and
12

13 WHEREAS, since 2019 the number of visitors declined due to
14 the coronavirus disease pandemic; however, with vaccination
15 rates increasing throughout the nation, the State is seeing an
16 increase in the number of visitors that could soon reach
17 pre-pandemic numbers; and

19 WHEREAS, the existing infrastructure of the City and County
20 of Honolulu is insufficient to support the increase of residents
21 and visitors; and
22

23 WHEREAS, lack of parking and insufficient outdoor spaces
24 for community activities in the City and County of Honolulu
25 continue to be a problem for residents and visitors; and

27 WHEREAS, there are lands in the City and County of Honolulu
28 that can be better utilized to address the community needs of
29 the City and County of Honolulu; now, therefore,
