A BILL FOR AN ACT

RELATING TO SEX TRAFFICKING PREVENTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that sex trafficking is a 2 form of modern-day slavery. According to a 2018 report 3 published by Arizona state university and the Hawaii state 4 commission on the status of women, one of every eleven adult 5 male residents of Hawaii are online sex shoppers. The report 6 also estimated that there were 74,362 potential sex buyers in 7 Moreover, during the coronavirus disease 2019 pandemic, Hawaii. 8 a service provider for sex trafficking victims in Hawaii 9 reported seeing a three hundred per cent increase in demand for 10 services, which included trauma-informed care.

11 The legislature further finds that education ends 12 exploitation. By empowering students to protect themselves from 13 harm and build healthy relationships; training school staff in 14 how to respond to at-risk youth in a trauma-informed manner; and 15 creating sexual health programs that include information about 16 sex trafficking, schools can equip students with the knowledge
