## A BILL FOR AN ACT

RELATING TO IDENTIFICATION CARDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the federal REAL ID 2 Act of 2005, Pub. L. No. 109-13, requires states to comply with 3 federally mandated eligibility criteria in issuing driver's 4 licenses and identification cards, which are often referred to 5 as "REAL ID compliant". However, the REAL ID Act specifically 6 allows states to issue driver's licenses and identification 7 cards that do not comply with the requirements of the REAL ID 8 Act.

9 The legislature recognizes that many residents who are 10 young adults, elderly, houseless, undocumented immigrants, or 11 lawfully present non-immigrants do not drive and are unable to 12 meet the stringent requirements for a REAL ID compliant 13 identification card. These residents are therefore unable to 14 access state-issued identification.

15 The legislature further finds that the coronavirus disease 16 2019 (COVID-19) pandemic has exacerbated the already difficult, 17 but necessary, process of proving one's identity. Restaurants,

theaters, public libraries, and other public venues now require
valid proof of vaccination and identity for entry. Prior to the
COVID-19 pandemic, state office buildings, including the Queen
Liliuokalani and Princess Ruth Keelikolani buildings, required
valid proof of identity for entry.

6 The legislature notes that pursuant to Act 172, Session 7 Laws of Hawaii 2015, the limited purpose driver's license, limited purpose provisional driver's license, and limited 8 9 purpose instructional permit were made available to individuals 10 who otherwise satisfy the requirements for a driver's license, provisional driver's license, or instructional permit except for 11 12 the individual's refusal to provide satisfactory proof of authorized presence in the United States under federal law. 13 The 14 legislature believes that a similar limited purpose 15 identification card would benefit the residents of the State by: 16 (1) Helping emergency personnel, including police and 17 emergency response teams, to better identify persons 18 in distress and other persons that these emergency 19 personnel encounter; (2) Providing access to public services to individuals 20

4 Application for renewal of an identification card (b) 5 issued after November 1, 1998, for an individual eighty years of 6 age or older may be done by mailing in or electronically 7 submitting a completed application and fee, if there is no 8 change in name and citizenship status. The director shall adopt 9 rules to allow for renewal by mail or electronic methods for individuals with physical or intellectual disabilities for whom 10 application in person presents a serious burden [-], or for any 11 individual who desires to renew a limited purpose identification 12 card. For an individual who has a letter from a licensed 13 14 primary care provider certifying that a severe disability causes 15 the individual to be homebound, the director shall adopt rules allowing for application for renewal of an identification card 16 17 under this section by means other than in-person appearance. A 18 non-compliant identification card shall be issued in accordance 19 with section 286-301.5 for renewal applications not made in 20 person. A limited purpose identification card shall be issued 21 in accordance with section 286-A.
