BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 141, Hawaii Revised Statutes, is 2 amended by adding a new section to part I to be appropriately 3 designated and to read as follows: 4 "<u>§141-</u> Healthy soils program; special fund; 5 established. (a) The department of agriculture shall establish 6 a healthy soils program. The healthy soils program shall: 7 (1) Create a statewide soil health assessment with a list 8 of practices specific to the State and that are most 9 effective in improving soil health and building soil 10 carbon stocks; 11 (2) Provide farmers with education and technical 12 assistance to implement farm management practices that contribute to healthy soils; 13 14 (3) By , establish standards that apply to the 15 healthy soils program and are based on the findings of 16 the greenhouse gas sequestration task force 17 established pursuant to section 225P-4 relating to

1		minimum levels of soil carbon and water content and
2		required soil health practices; and
3	(4)	Subject to available funding, issue awards and other
4		financial incentives to implement farm management
5		practices that contribute to healthy soils.
6	(b)	The long-term goals of the healthy soils program shall

8	(1)	Deadlines by which all awards issued by the department
9		of agriculture shall meet the standards established
10		pursuant to subsection (a)(3);
11	(2)	Deadlines by which a plan for all state lands leased
12		for agricultural use shall be required; and
13	(3)	Programs incentivizing small farmers, ranchers, and
14		landowners to take carbon negative actions on their

16	<u>(c)</u>	There is established a healthy soils program special
17	fund to b	e administered by the department of agriculture and
