# A BILL FOR AN ACT

RELATING TO A DEPARTMENT OF ENVIRONMENTAL PROTECTION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that, unlike most states,
Hawaii has no executive-level department dedicated to the
mission of environmental protection and implementing the
environmental policy goals enacted by the legislature. Instead,
these functions are dispersed among multiple departments having
differing missions that either do not focus on the importance of
environmental protection or have internal conflicts.

The legislature further finds that because the ongoing 8 9 climate crisis is one of the overarching issues of modern times, the protection of the State's environment and natural resources 10 11 is more critical than ever. Although almost all issues are 12 multi-jurisdictional, the legislature believes that creating an 13 executive-level department to unite this important work under 14 one administrative umbrella will lead to greater efficiency in 15 addressing Hawaii's environmental issues in a timely and 16 proactive fashion.

The working group shall consist of the following 12 (C) individuals: 13 14 (1) The chief energy officer, or the chief energy officer's designee; 15 16 (2) The chairperson of the board of land and natural 17 resources, or the chairperson's designee; 18 (3) The director of the office of planning and sustainable 19 development, or the director's designee; A representative of the office of the governor; 20 (4)

4	(d) The working group shall prepare and submit a report of
5	its findings and recommendations, including any proposed
6	legislation, to the legislature no later than twenty days prior
7	to the convening of the regular session of 2025.
8	SECTION 5. Statutory material to be repealed is bracketed
9	and stricken. New statutory material is underscored.
10	SECTION 6. This Act shall take effect upon its approval;
11	provided that sections 2 and 3 shall take effect on July 1,
12	2026.
