SENATE CONCURRENT RESOLUTION

COMMITTING TO PROVIDE GREATER PUBLIC ACCESS TO THE LEGISLATIVE
PROCESS BY ADOPTING RULES TO ALLOW FOR VIRTUAL TESTIMONY,
HEARING RECORDINGS, AND INTERNET BROADCASTS OF HEARINGS
BEYOND PERIODS OF CATASTROPHIC EVENTS.

1 WHEREAS, public access to the Legislature and the
2 legislative process allows for citizens of Hawaii to actively
3 engage with decisions impacting everyday life; and
4

5 WHEREAS, the Legislature has committed to providing greater
6 public access for citizens interested in the legislative
7 process, beginning with Act 331, Session Laws of Hawaii 1989, to
8 improve public access to legislative information; and
9

10 WHEREAS, Hawaii's unique geography as an archipelago of
11 islands poses significant challenges for residents from the
12 counties of Maui, Kauai, and Hawaii to actively participate due
13 to costly, time-consuming travel to attend hearings, and to
14 provide in-person, oral testimony; and

16 WHEREAS, the lack of remote hearing and testimony
17 procedures impacts approximately four hundred thousand residents
18 in the State; and

20 WHEREAS, the global coronavirus disease 2019 (COVID-19)
21 pandemic has created great challenges to all individuals
22 interested in participating in the legislative process; and
23

24 WHEREAS, with the onset of the COVID-19 pandemic, physical
25 access to the Capitol building, hearings, and live testimony has
26 been restricted due to social distancing guidelines; and

28 WHEREAS, during the emergency stay-at-home orders and
29 travel restrictions, legislators, staff, and members of the
30 public could not attend public meetings in person; and

1 WHEREAS, the COVID-19 pandemic forced the implementation of
2 emergency measures suspending certain requirements of the
3 State's sunshine law in order to allow boards and commissions to
4 continue meeting and conducting necessary business while
5 protecting participants' health and safety and expanding public
6 access to meetings throughout the State; and

8 WHEREAS, remote meetings can connect people in different
9 physical locations through the use of interactive conference
10 technology and thus enabled enhanced legislative and public
11 participation; and

13 WHEREAS, remote meetings could be safely held and allow
14 more people from different islands or parts of islands to
15 effectively participate, often during times when they would not
16 otherwise be physically able or authorized to leave their work,
17 homes, or schools to participate in an in-person meeting; and

18
19 WHEREAS, during the COVID-19 pandemic, remote meetings
20 helped to prevent the spread of disease, and even when there is
21 not an ongoing pandemic, remote meetings can be a way to protect
22 the health and safety of participants; and

23
24 WHEREAS, remote meetings allowed the elderly and
25 individuals who have disabilities or medical conditions that
26 would place them at greater risks during travel or attendance at
27 in-person public meetings to participate in the legislative
28 process; and

29
30 WHEREAS, in 2021, each house of the Legislature adopted
31 remote hearings and testimony rules that allowed members of the
32 public to continue participation through virtual conferencing
33 platforms; and

35 WHEREAS, the successful utilization of virtual attendance
36 and remote testimony procedures during the ongoing COVID-19
37 pandemic supports the continuation of pandemic-era rules to
38 allow for greater public access to the legislative process; now,
39 therefore,

41 BE IT RESOLVED by the Senate of the Thirty-first
42 Legislature of the State of Hawaii, Regular Session of 2022, the



1 House of Representatives concurring, that each house of the
2 Legislature is committed to providing greater public access to
3 the legislative process for citizens by adopting rules allowing
4 virtual testimony, recorded hearings, and hearings broadcasted
5 via the Internet, consistent with those that were implemented
6 during the COVID-19 pandemic, be continued as a regular
7 practice.
