SENATE RESOLUTION

REQUESTING THE DEPARTMENT OF BUSINESS, ECONOMIC DEVELOPMENT, AND
TOURISM TO CONDUCT A STUDY ON THE ECONOMIC IMPACTS OF
DOMESTIC OUT-OF-STATE STUDENTS.

1 WHEREAS, Hawaii is a tropical destination for tourists and
2 students alike; and
3

4 WHEREAS, as the State seeks to diversify its economy, it is
5 critical for businesses and industries to provide good jobs and
6 growth potential; and
7

8 WHEREAS, the education sector is capable of providing both
9 good jobs and growth potential; and
10

11 WHEREAS, in a report dated October 2020 and titled, "The
12 Economic Impact of International Students in Hawaii--2020
13 Update" (2020 Report), the Department of Business, Economic
14 Development, and Tourism analyzed the impact of international
15 students on Hawaii's economy; and
16

17 WHEREAS, the 2020 Report estimated that, in calendar year
18 2019, international students directly contributed \$185,000,000
19 to the state economy in living expenses and tuition, among other
20 economic activities; and
21

22 WHEREAS, the 2020 Report also estimated the "ripple
23 effect", or indirect economic impact, of international students,
24 as follows:
25

- 26 (1) \$381,200,00 in economic output generated, including
27 direct, indirect, and induced effects;

- 29 (2) \$29,200,000 in state taxes generated;

- 31 (3) \$168,400,000 in household income generated; and

- 33 (4) Nearly four-thousand jobs supported by international
34 student spending; and

1 WHEREAS, the 2020 Report illustrates the powerful economic
2 impact of international students in the State, and, by
3 implication, the powerful impact that other out-of-state
4 students likely have on the economy as well; now, therefore,


6 BE IT RESOLVED by the Senate of the Thirty-first
7 Legislature of the State of Hawaii, Regular Session of 2022,
8 that the Department of Business, Economic Development, and
9 Tourism is requested to conduct a study on the economic impacts
10 of domestic out-of-state students, i.e., non-international
11 students, on the state economy, in similar scope and form as the
12 2020 Report; and
13

14 BE IT FURTHER RESOLVED that in conducting the study, the
15 Department of Business, Economic Development, and Tourism is
16 requested to analyze the economic impacts of all domestic, out-
17 of-state students in the State, including four-year degree
18 students, two-year degree students, and short-term students; and
19

20 BE IT FURTHER RESOLVED that the Department of Business,
21 Economic Development, and Tourism is requested to submit a
22 report of its findings and recommendations, including any
23 proposed legislation, to the Legislature no later than twenty
24 days prior to the convening of the Regular Session of 2023; and

26 BE IT FURTHER RESOLVED that a certified copy of this
27 Resolution be transmitted to the Director of Business, Economic
28 Development, and Tourism.
