Aloha 'Īlio Rescue is a non-profit agency that provides a much needed and communitysupported public service by spaying/neutering and rehoming stray, abandoned and owner-surrendered dogs and educating the public about the responsibilities of pet ownership.

## II. Background and Summary

#### 1. A brief description of the applicant's background;

Aloha 'Īlio Rescue (AIR) was founded in 2010 in response to the overpopulation of dogs in east Hawai'i and quickly became a trusted and valued resource for the Island of Hawai'i. The rescue has grown from rehoming less than 200 dogs/year to more than 600 dogs in 2022. This work is accomplished with a small team of dedicated staff, fosters and volunteers.

Aloha 'Īlio takes in stray and abandoned dogs, as well as those whose owners can no longer provide for them because of financial or health hardships or death. Many of the dogs are brought directly to us, but some are transferred to us from Hawai'i County Animal Control (without compensation), as part of our partnership with them to alleviate the overwhelming burden on their limited facilities in East Hawai'i. All of the dogs that come through AIR are spayed or neutered, treated for parasites, provided with medical and behavioral care and kept up to date on vaccines until they go to their new homes. Applicants for adopting our dogs are interviewed make sure they understand the commitment involved in dog ownership and to gain insight into their situation and lifestyle in order to match them with the dog best suited to their household.

AiR maintains a database of all dogs and adoptive families, including medical procedures, medicines, vaccines and anti-parasitics, forms signed by owners surrendering animals and by adopters, as well as communications with adopters.

AIR also does community outreach and education regarding the spaying and neutering of pets, as well as how to humanely care for them. The rescue has garnered tremendous community trust in its 11 years of operation. It is largely supported by community donations and fundraising events and we have recently started to grow operating funds by opening an online retail store which has been met with enthusiastic support.

## 2. The goals and objectives related to the request;

The overarching goal is to better serve our community by 1) enhancing our fostering program 2) providing robust adoption counseling and 3) transporting more adoptable animals to our mainland partner shelters who have high adoption rates. The objective of these programs is to increase the number of dogs placed with loving families, reducing the overpopulation issues facing the Island of Hawai'i.

## 3. The public purpose and need to be served;

East Hawai'i is currently the least served by county animal control, as they do not have adequate facilities in place on this side on the island to intake and care for animals. They have only recently taken back the reins on animal control, after a disastrous contract awarded in 2020 to a no-kill sanctuary that took in less than a quarter of the number of animals sheltered in previous years. It fell to Aloha 'Īlio to take in much of the surplus of those abandoned, lost, hungry, scared, often breeding and even biting dogs. We now partner with county animal control, transferring in as many of the excess dogs as we can possibly handle, but there are many more that could use our help.

## 4. Describe the target population to be served

AIR primarily serves East Hawai'i communities, especially in the Puna and South Hilo Districts. This area has some of the highest rates of people living below poverty level in the nation. The Puna district has also been, for many years, the fastest growing district in the county, in large part due to the availability of relatively inexpensive land. Many families struggle to make ends meet and can easily become overwhelmed by the cost of caring for pets, especially with the cost of veterinary care. This often results in abandonment. AIR provides a safe place for these families to bring their pets, where they can be assured that the dog will be well cared for and rehomed in a timely and thoughtful manner with families that can better provide for them.

AIR also serves the needs of individuals and families needing the unique companionship and bonding experience of having a dog appropriate to their lifestyle and situation, while feeling good about helping a rescued animal instead of supporting dog breeders. More and more of these people are moving to the island, and our education programs are increasing the number of residents of this mindset. We do, however, in response to the overwhelming number of animals available for adoption, also ship dogs to adopters throughout the state and to facilities and adopters in the continental U.S., where there is less dog overpopulation pressure and more available adopters.

### 5. Describe the geographic coverage.

We expect that the majority of our intakes will continue to be primarily from East Hawai'i. We will, however, serve the entire Island of Hawai'i, and our adoption services will continue to serve the island as well as the nation.

# III. Service Summary and Outcomes

#### 1. Describe the scope of work, tasks and responsibilities;

**Foster program**: Fostering is the most effective way to open space in our shelter for more animals to be saved. Fostering also alleviates the behavioral and socialization issues that can stem from shelter environments for many dogs, giving them a better chance to be prepared for adoption. Fosters also often provide socialization and training that vastly increases the adoptability of the dog. In addition, fosters greatly expand the network of potential adopters by spreading the word of the availability of their fostered pet through their family, friends, acquaintances, coworkers and social media platforms. We intend to at least double our base of active fosters by having a foster coordinator who can provide the logistical support needed to sustain a robust pool of fosters.

Adoption counseling program: Adoption counseling seeks to make lifelong matches between people and pets. By gathering information about the potential adopter's household, lifestyle and expectations, the adoption counselor assists them in choosing the dog that is best suited to their needs and educates them about proper care, training and realistic expectations of both animal behavior and the costs associated with and the time required to own a pet. The adoption counselor also follows up with the adopter to make sure no problems are developing. Currently, if there are any potential red flags in an online application, Aloha 'Īlio Rescue must simply deny the application. AIR needs more resources to be able to truly engage with potential adopters, including home checks and, if the family has other pets, a phone call with their veterinarian's office. This will not only enhance the pet ownership experience for both the dog and the adopter, it will increase the number of adoptions and decrease the number of dogs that are later surrendered back to AIR or simply abandoned.

**Transport** to other islands and continental US: In addition to accepting adoption applications from other Hawaiian islands, AIR partners with several rescue organizations and shelters in Washington and Arizona, who have the resources and clientele to place dogs in stable, caring homes. In 2022, AIR transported about 70 animals to the mainland, and many more inter-island, and we seek to increase that number in 2023-2024. The work involved in transporting includes either working with other-island adopters or coordinating with partner organizations to select appropriate candidates, booking flights, obtaining medical certificates of good health, buying and preparing transport crates, and transporting the dogs to the airport; for mainland flights we need to take them across the island to Kona for direct flights. We currently own only one vehicle, a small cargo van that is 10 years old and has more than 100,000 miles on it. When this vehicle is in for service, which will be happening more and more often as it ages out, we have no mean of transporting funds for a new small cargo van, in addition to some of the expenses associated with this transport program.

AIR will complete the work within one year of receiving the funds.

- Michelle Lee is a retired non-profit administrator.

Daylynn Kyles has 13 years of experience running Aloha 'Īlio Rescue. Her love of dogs and knowledge of dog handling started with training dogs when she was 12 years old. She has run dog clubs throughout the state and on the continental U.S. In the course of running AIR, she has hired and managed numerous staff, always finding personnel that are dedicated to animal welfare and to providing individuals and families with the perfect canine companion. She has trained her staff to be extremely competent at their jobs. She has also built a network of dedicated and loyal fosters and volunteers. Born and raised in East Hawai'i, she understands the community's needs and can provide a vision for a facility that is uniquely suited to local needs. She has built relationships with local governance, humanitarian organizations and other animal rescue organizations so that everyone can work together in partnerships to best serve the community. Daylynn's deep roots in East Hawai'i allow her to engage with the people best suited to the tasks involved in accomplishing the goals of the organization, and for her voice to be heard in outreach and educational programs. She also manages AIR's social media, essential to the success of AIR's rehoming and fundraising efforts.

Tiffany Perreira is a veterinary technician and has worked in this field for 10 years. She has worked at AIR since 2019. She has an amazing connection with the animals, which translates to the best possible care for their well-being. Her duties include performing wellness checks, parasite prevention and minor medical services on intakes and transporting dogs to and from spay/neuter surgeries. She also manages the kennels, which includes supervising the kennel technicians and, along with the president, makes decisions about intakes (as there is nowhere nearly enough capacity to take all the requests for owner surrendered dogs). She has great communication skills, enabling her to train and supervise kennel technicians to a high level of competence in a short time.

Donna Cornwell has an extensive background in office administration and performs this task, as well as acting as an adoption specialist for AIR part-time.

Two full-time and three part-time kennel technicians take care of the dogs' needs and interact with the public in the course of adoptions.
