# **Background and Summary**

### **Executive Summary**

Bottles4College is a 501(c)(3) status Nonprofit Organization that collects recyclable cans and bottles to help protect the planet and help fund college scholarships for kids in Hawaii. The 4 pillars of belief of Bottles4College are: Education, Environment, Community, and Lifestyle.

#### Bringing Actionable Solutions to Social Issues:

The goal of Bottles4College is to create systems of actionable solutions for environmental and economical sustainability for the longterm wellbeing and health of our planet and people. For every 1 million cans and bottles recycled, it can equate to approximately \$50,000 of funding that can be awarded as college scholarships for Hawaii students. It also results to diversion of approximately 30 US Tons (weight can vary. Also, this weight does not include lids and other trash diverted from litter) of cans and bottles ending up in landfill or as ocean pollution.

Obtaining sufficient operational funding is imperative to sustain the program as a continuous system. Bottles4College has successfully shown that the initiative tying in environmental and economical sustainability is a cause Hawaii residents are extremely interested in supporting and supporters believe that the purpose of Bottles4College is achievable with its simple concept, great organization, and consider beneficial for the people of the State of Hawaii presently and into the future.

Cost of living is a high priority issue in Hawaii, enough to have phrases such as "priced out of paradise," a common headline. What if we are able to show the power of the collective effort of communities coming together as a whole to raise 5 cents at a time? Not only is every action taken for Bottles4College a positive impact for the environment, it is the symbol of hope if (what we consider) trash can turn into something as impactful as a higher education scholarship, that can literally change the course of a person's life for the better.

ENVIRONMENT

Malama for the Future

Older generations of Hawaii remember not finding micro plastic on the beaches of Hawaii. Nowadays, there's hardly a beach left without any micro plastic on Oahu. To think of what that can look like in 20 years is a real life nightmare.

Over 900 million cans and bottles of beverages are sold in the state of Hawaii each year, according to the Maui County (<u>https://www.mauicounty.gov/</u>). According to the state's waste management report dated December 2020, the recycling redemption rate for beverage containers in the State of Hawaii was 61.79% in 2020, down 16.93% since its height in 2009, currently leaving approximately 320 million beverage cans and bottles unaccounted for each year. Less than 2 years since the full establishment of Bottles4College, this grassroots initiative has recycled nearly 1,000,000 cans and bottles, diverting over 28 US Tons of cans and bottles from becoming landfill or ocean pollution. Many Bottles4College supporters recommenced recycling

efforts after learning about the program. Most significantly, this has helped Hawaii businesses to go green, including helping a hotel in obtaining green certificates or increasing the sustainability recycling efforts for a major attraction by over 400%.

Bottles4College has also attended and contributed in other clean-up efforts. Bottles4College has also provided over 100 hrs of community education, including educational booths at community events, guest speaking at Hawaii public schools and other events, and spreading the awareness toward environmental stewardship. Bottles4College has formed recycling partnership with

#### **EDUCATION**

Bottles4College has awarded community volunteer hours to Hawaii students and helping student meet community volunteer hour requirements for public high school graduation and aspire to higher educational goals.

Bottles4College is ready to commence the awarding of scholarships using the funds collected through recycling, but funding is essential so we can continue to award such scholarships and be a concreted system in Hawaii that can help both the environment and keiki simultaneously.

Raising the awareness and inspiration toward quality education is part of Bottles4College's mission, in order to help elevate the current and future generations. It is imperative to continue to inspire for bettering our society, as our society and world advances. There are many families that do not discuss nor think about higher education as even a choice nor option for their children due to the demands of high cost of living. This phenomena is anecdotally apparent in Hawaii public school classrooms, that Founder of Bottles4College, currently a 15 year old, high school Freshman, Genshu Price, felt and wanted to give more hope and aspiration to his peers growing up. Genshu leads speaking and teaching sessions at events and Hawaii school classrooms, effectively reaching to Hawaii's youth, influencing them from their own perspective on what they can do and engage in the community. If a program like Bottles4College could be a staple for Hawaii schools and communities, more kids will naturally think about education and possibly start to learn more at a younger age. According to the National Center of Education statistics in 2020, one in six adults in Hawaii struggle with reading English. It is morally devastating for all children attending schools when there are students in higher elementary grades chronically suffering from illiteracy. Bottles4College brings hope to the possibility for Hawaii families raising children to think beyond their own financial restrictions and hope for more and better for their future generations. Funding for Bottles4College will help us continue to expand on these efforts.

#### COMMUNITY

### The Collective Effort

Individual recycling is great and encouraged. But many become discouraged due to its time consuming demands and hardship of raising moneys 5 cents at a time. It is easy for many to start to dismiss the positive impact toward the environment without an effective system that enables community members to 1. think about recycling and 2. take action to recycle. When community members learn that they are a part of a large-scale effort that also feeds into a better cause of supporting the community, more have the incentive to take part in the effort. Through the efforts of Bottles4College mounting each individual's effort to sizable results, community members of Hawaii feel proud to be a part of the Aloha State.

One of the 4 pillars of Bottles4College is Community. Bottles4College is powered by the community and created to inspire and support the community. Bottles4College serves all ages from keiki to kupuna. Volunteers and supporters of Bottles4College has ranged from 4 years old to 80+ years old. Bottles4College stands for a beacon of hope and an actionable solution for community members of Hawaii to be able to take part in the collective effort to malama our environment and inspire for education.

The scholarship and education pillar of Bottles4College directly benefits school-aged students and their families that are looking to gain financial support toward higher education. The environment pillar of Bottles4College serves to malama our aina and the planet as a whole, with Hawaii's beautiful nature as the leading example to try to protect for the wellbeing of our world.

### Geographic coverage:

Bottles4College is based on the island of Oahu. We have gained support and conducted events or partnerships across the island. Notable public recycling drives took place in Kaneohe and Pearlridge, gathering community members from Windward to Leeward side. School partners geographically have included Honolulu, Windward (Kailua to Hauula), Mililani, and Ewa Beach. Business and Event partners have included various locations throughout Honolulu, Kailua, Kaneohe, Mililani, big surf events (North Shore and Waikiki), Kualoa, and Kahuku. The news of Bottles4College has been shared on all 3 local news channels, PBS Hawaii, and Olelo TV, and has traveled the world republished on countless local news via AP News. This has drawn international support and attention.

## LIFESTYLE

The 3 pillars above tie into a Bottles4College lifestyle. For sustainability to work, it has to become second nature to everyone's daily routines and habits - a part of their lifestyle. Being able to have funding will allow Bottles4College to partner with more schools, providing in-class education toward the environment, youth leadership, entrepreneurship, and aspiring for education. Hawaii residents tend to have strong affiliations with their alma mater, which then will positively feed back into the Community pillar of Bottles4College.

## III. Service Summary and Outcomes Describe the scope of work, tasks and responsibilities:

The basic scope of work, tasks and responsibilities of Bottles4College has been established with almost 2 years of full-time efforts to establish the program.

## **Projected Annual Timeline**

Just short of 2 full years since incorporating and operating Bottles4College as a full fledged endeavor, Bottles4College has been able to meet its first major milestone of recycling 1,000,000 cans and bottles. We understand the time and arrangements it will take to get achieve the high numbers of recycling. We are projected to reach the point of easily recycling 1,000,000 cans and bottles annually with funding that can cover basic costs and manpower help. Just with non-funded volunteer grassroots work of our small team, we currently recycle an average of 10,000 cans and bottles per week. Our larger goal will be to sustain recycling 2-4million cans and bottles each year.

## **Quality Assurance and Evaluation Plans**

Bottles4College keeps diligent detailed logs of recycling, community events, education outreach, and volunteer hours. Expense use has been extremely conservative until now due to not having funding, so overspending is not an issue. Continuous re-evaluation of operations is actively discussed and addressed by the Board members and key Volunteer members. This has already resulted in removal of unnecessary supplies, increasing reusable measures within the operations, such as storing sorted recyclables into reusable super sacks instead of single use plastic bags. Bottles4College has been met with the extreme challenges of the pandemic and inflation from the get-go, creating a resilient team and ongoing efforts of improvements for maximum efficiency for all parts of operations.

## **Measures of Effectiveness**

Bottles4College can provide measures of effectiveness through summaries of detailed logs. The main measure will be the amount of recycling deposited, which includes the full breakdown of funds collected, types of recyclables and their weights. Another major measure is the trash diversion chart that reflects the pounds of cans and bottles recycled by type. This does not include the lids and other trash removed by Bottles4College, but provides a sufficient number and trace of positive environmental impact made by the efforts of Bottles4College. Bottles4College also keeps track of education hours. This includes

List of community events and hours spent is also logged. All of the above can be summarized as a report. The summaries currently show that 2022 roughly doubled the numbers of year 2021. We know what can be possible as a completely grassroots initiative with no major funding support. With proper funding support, we can hope to surpass our goals and growth, while also now providing paid employment/contracted positions.

Being able to achieve awarding scholarships annually to Hawaii students will be another impactful measure of this program unlike any other waste diversion program. Bottles4College sincerely hopes to gain funding support in order to make this portion manifest in a sustainable manner to the organization.

# V. Experience and Capability Necessary Skills and Experience

Bottles4College has been able to reach successfully recycling close to 1,000,000 cans and bottles within the first 2 years of full-fledged operations. We now recycle an average of 10,000 cans and bottles a week with just our grassroots efforts.

The program has shown effective leadership and organization, consistently bettering the process and work towards efficient and cost-effective means with environmental sustainability in mind.

Bottles4College has implemented the use of reusable super sacks to store sorted cans and bottles into in an effort to eliminate use of brand new single use plastic trash bags. Environmental and economical consciousness is our very first priority in the founding of our operations, as it is our mission to carry out. So not only does the efforts of Bottles4College aim to meet that, our way of organization and operations are also based on it. Our observations and implementations has helped better other Hawaii businesses as well, enabling community events to recycle during their public events, and increase the number of recycling bins and recycling drives at Hawaii schools and businesses.

# 2. Facilities

Bottles4College partners with schools and businesses for site use when applicable and needed. These sites help us host large scale volunteer sorting events and recycling drives.

We currently have 1 pick up truck used for our operations. A vehicle addition will be the next step of growth and a low capital investment that can be made toward the program. This may be implemented with the use of funding available, or as a corporate partnership interested in supporting the cause.

The efforts of Bottles4College is supported by community businesses, such as Pearlridge Center being the site host for our 2021 New Year Collection Drive, which collected 3.5 US Tons of cans and bottles in just 2 days. Volunteers helped sort all the cans and bottles on site during the event. Site hosts has been providing space at no additional cost for usage, though the organization is responsible for all supplies, manpower, waste management, and insurance.

Eventually, we hope to secure a brick and mortar facility and even bigger goals of bringing onisland recycle processing capabilities. For now, the focus of Bottles4College is to completely establish this program and operational funding will allow us to spread our partnership with schools and more.

# VI. Personnel: Project Organization and Staffing

## 1. Proposed Staffing, Staff Qualifications, Supervision and Training

Bottles4College is currently maintained by 100% volunteer work.

The core team of Bottles4College brings ample management and supervision experiences from a wide range of managerial backgrounds with skillsets and knowhow of establishing procedures and manuals.

Our Founder, Genshu Price, is an effective youth leader, who is also learning the fundamentals of

businesses through this process. It has been an essential process for the core team to operate hands-on for the last 2 years establishing and improving each process and segment of the program. We are now completely familiar with the process, work and time needed for each portion of our program to be able to make this request to responsibly continue and expand our operations. Bottles4College now has programs where we teach the process of organizing and successfully executing recycling drives in Hawaii classrooms, such as for the leadership class at Kailua High School.

Bottles4College hopes to contract/employ 2-3 staff members to help carry out the operational management, which will help us increase partnerships, such as with hotels. Detailed training is available and all process of the operations is well established. Procedures and time needed for this operation is detailed below in charts.

Bottles4College is spearheaded by 15 year old, Genshu Price. Genshu is in 9th grade and started envisioning and manifesting Bottles4College when he was 10 years old. He has been the frontrunner of this organization and operations. He has learned the operations of Bottles4College from scratch, including putting in countless hours of sorting recycling, which now is approximately 10,000 cans and bottles a week. He has established relationships with many key community supporters and has been providing guest speaking at public events and in classrooms for fellow Hawaii students.

Volunteers, Residences, and Businesses

Bottles4College has established over 30 partnerships with Hawaii businesses and events Volunteers assist with the much needed manpower for sorting events.

### Additional Paid Help

Currently, Bottles4College does not have any paid positions. By securing operational funding, we are ready to add 2 working positions. Priorities of the work task is as follows:

- Collection, Sorting, and Depositing

This position is our number 1 priority to fund. This will allow time and efforts for our volunteers to continue the expansion of our program.

When we will be able to secure ongoing operational funding from various grants, we can

guarantee a payroll. For now, our plan is to pay out as individual contractors to minimize administrative expenses for the organization, such as worker's comp and insurance.

- Fundraising & Community Partnership Outreach:

Personnel to assist with communications to arrange and expand outreach for the organization. This will include setting up new partnerships, communications, and coordination for each event / partnership.

## 3. Compensation

There are currently no persons nor positions that receive compensation from Bottles4College. This is the main reason for the request for operational funding so we are able to fill roles necessary for full-time operations while compensating helpers.

A small hotel partnership can provide roughly 10,000 cans and bottles a month. That takes 1 x a week of pick up, 2-4 hours of sorting a week, and 1 x of deposit drop off at a recycling center. ## 4. Future Sustainability Plan

(a) Received by the applicant for fiscal year 2023-24

Bottles4College is a working model that immediately translated into actionable solutions for the wellbeing of our environment and people of Hawaii. Efforts towards fundraising, grants, and personal donations will continue to be made.

Expense use has been extremely conservative and maintained through personal donations made by private contributors.

By reaching our first big milestone of recycling 1,000,000 cans and bottles, we hope to have corporate partners interested in supporting our efforts monetarily.

Private foundation grants we have approached require 2-3 years of establishment, so we hope to be able to start to be eligible starting this year and on. This includes Aloha United Way and other larger organizations.

March 2023 will mark 2 full years of being established as a 501(C)(3) Nonprofit Organization.

Support will mean growth in more ways. The simple concept of Bottles4College allows operational needs to be straightforward, making it easier to grow with sufficient and controlled funding. With just 2-3 paid positions and addition of vehicles, Bottles4College will be able to amplify our mission and continuously raise the rate of recycling on island and give out college scholarships for Hawaii students.

Bottles4College has shown that grassroots efforts with great initiative can move mountains, starting at one can and bottles at a time. We have now raised close to \$50,000 at 5 cents at a time. Just this message is empowering for the community, who now faces challenges and hardships not only from rising costs, but from the detriments of the pandemic.

As with any real business, it is completely possible for the program to not be able to establish itself as an ongoing program for the state without sufficient funding. Obtaining operational funding beyond the community donations will give our organization the consistency to be able to perform and actually create a continuous system for the people of the state. Otherwise, it is entirely possible for this program to give out a scholarship from the efforts already made and have to end.

Hawaii is the state of Aloha. Unifying the community with Aloha being the way of life and common language is what we'd like to spread and perpetuate into the future and the world. To be successful ambassadors of Aloha, our community needs sustainable systems that continue to remind us these values. Though there are many great ideas and establishments in Hawaii, funding and stability is an issue for most. Bottles4College is a low-cost effective measure for the State of Hawaii to establish as a way to continue to inspire and aspire our people to live the Aloha way of life starting from a young age.
