Chozen-ji is a 501c3 religious nonprofit (church) incorporated and operating solely in Hawaii that has been offering training in leadership, spiritual, and self development since its founding in 1972 to the general public without discrimination on the basis of race, color, national origin, religion, creed, sex, age, sexual orientation, disability, or financial ability. These operations and mission are reflected in our organizational bylaws and policies, which are enforced by a governing board of uncompensated members without material conflict of interest.

Funds will not be used for entertainment or lobbying of elected officials, and state agencies will have full access to documentation related to any granted funds.

Daihonzan Chozen-ji / International Zen Dojo is requesting Grant In Aid funds for a capital improvements project that will support the expansion of leadership, spiritual, and self development programs for the general public.

II. Background and Summary

1. A brief description of the applicant's background;

Daihonzan Chozen-ji was founded in 1972 as a Rinzai Zen temple and monastery in Honolulu. It draws on a direct line of Zen training from Japan that is centuries old. At the same time, our approach to Zen through the body is innovative and unique. Using meditation, martial arts, and fine arts, we train strong, sensitive leaders who approach life's problems fearlessly. In this way, we fulfill our mission as a peace temple dedicated to improving Hawaii and the world.

Annually we serve approximately 500 people of all religions and backgrounds through individual and group training in martial arts, fine arts, and meditation. The majority of our participants are from Oahu, with a small number coming from neighbor islands and internationally. Chozen-ji has 8 core volunteer staff and one paid full-time staff.

2. The goals and objectives related to the request;

Following steady growth, demand for our programs is now exceeding the number of people who can live and train on site at Chozen-ji, especially in short term programs.

GIA funds will add to our capital campaign to build accommodations for long term housing to support a growing team of committed teachers anchoring Chozen-ji's day-to-day training and whose ability to live on the grounds will enable the proliferation of short term programs.

This housing will thus enable an additional 100-200 people to live and train at Chozen-ji annually. The population served will include local Hawaii residents, as well as people from outside of Hawaii participating in various training programs.

3. The public purpose and need to be served;

Whether the times are generally calm or chaotic, Zen training helps people to cultivate the clarity of mind and spiritual strength to be able to handle life's challenges effectively.

Under Chozen-ji's current leadership over the past five years, we have experienced unprecedented growth. Everything points to this demand continuing to grow. Today's unprecedented crises and challenges—pandemic, climate crisis, racial unrest, growing partisanship, etc—are sparking new recognition of the value of Zen training.

4. Describe the target population to be served; and

The population we serve has and will continue to include individuals from a variety of backgrounds, including those in non-profit, government, civil society, business, and the arts. Some are established leaders in their fields, seeking to "level up" in their work and in their lives. Others are young people in need the help of Zen training as a means to gain the wisdom, strength, and sensitivity to lead effectively—whether it is within an organization, in elected office, or simply within their families and communities.

In this way, Chozen-ji training is cultivating the next generation of leaders in Hawaii, as it already has for decades. This new housing will allow us to increase our impact even further for the benefit of Hawaii and the world.

Our regular programming also serves a fundamental need for community, and physical/emotional/spiritual development for a diverse audience. This includes children and seniors, who are served through our weekly classes in meditation and various martial and fine arts. We also offer a weekly seniors' class called Practical Zen: The Way of Aging Gracefully that helps students cultivate more physical balance, strength, and agility.

5. Describe the geographic coverage.

The programming that will be directly affected by the granting of GIA funds will occur in Hawaii, on our properties at 3565 and 3570 Kalihi Street.

Program participation will be open to the general public, though program

marketing through written communications, networking events, targeted outreach, etc will mostly target Oahu residents.

III. Service Summary and Outcomes

This capital campaign will raise the resources to develop long term housing to support a growing team of committed teachers anchoring Chozen-ji's day-to-day training and programs.

Our design provides for residential spaces including bathroom and laundry facilities, and a large outdoor communal space.

After a successful capital campaign, we completed the design phase of the project with a design-build contractor. Due to delays at the Department of Planning and Permitting, and the COVID-19 pandemic, it took over one year to receive permit pre-approval. In that time, costs have risen, precipitating our application now for GIA funds to meet the gap between funds raised and the expected final budget.

We anticipate breaking ground for the project in mid-2023.

2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

We have completed the design phase of the project and are currently awaiting permit approval. We anticipate breaking ground for the project this year, with occupancy and use beginning by early 2024.

This capital improvement project will be monitored in quality by the Department of Planning and Permitting, and by licensed architects and builders.

The programs that will be enabled by the capital improvement project will be monitored, evaluated, and approved by Chozen-ji staff, board

members, teachers, and volunteers. Through long term relationships with program participants, we are able to track their progress and ability to apply their Zen training to the leadership challenges in their lives. Many program participants return to Chozen-ji to revisit and advance their training over many months and years.

Daihonzan Chozen-ji was founded in 1972 as a Rinzai Zen temple and monastery in Honolulu. It draws on a direct line of Zen training from Japan that is centuries old. At the same time, our approach to Zen through the body is innovative and unique. Using meditation, martial arts, and fine arts, we train strong, sensitive leaders who approach life's problems fearlessly. In this way, we fulfill our mission as a peace temple dedicated to improving Hawaii and the world.

As part of our activities, we have a weekly class schedule that includes Zen meditation and various martial and fine arts. These are and always have been offered without fees so that they are accessible to the most people. Through these regular classes, students improve fundamental markers of their health and well-being—from improving biomarkers such as blood pressure and resting heart rate to cultivating more mental, physical and spiritual strength to persevere in chaotic and stressful situations.

In addition, Chozen-ji has been the site of many initiatives for the betterment of Hawaii. This includes addressing chronic houselessness on Oahu by supporting the community organizing efforts of houseless leaders like Twinkle Borge, who runs the houseless encampment Puuhonua O Waianae, and is currently constructing a privately funded 250-person, 20-acre traditional Hawaiian village in Waianae Valley. The volunteer group meetings that led to the purchase of those 20 acres on Waianae Valley Road took place at Chozen-ji, around our kitchen tables. We have also hosted several events and gatherings for the keiki of Puuhonua O Waianae and for houseless leaders from around Oahu. These leaders later went on to form the Oahu Lived Experience Council, an advocacy hui for Oahu's houseless to advise policymakers, nonprofits, and government officials working on houseless issues.

Back in the 1980s, Chozen-ji founder Tenshin Tanouye spearheaded the Aloha Spirit poster campaign, a spinoff of efforts—again, originating around the kitchen tables at Chozen-ji—to enshrine Native Hawaiian leader Pilahi Paki's definition of the Aloha Spirit into state law. In 2022, Chozen-ji re-issued the Aloha Spirit posters, this time with quotes from prominent Native Hawaiian spiritual leaders like Pilahi Paki, Nana Veary, and Edith Kanakaole, and with designs by Kuhao Zane of Sig Zane.
