

The Friends of the Palace Theater is a community -based non-profit organization established in 2002. Its mission is to "revitalize, restore, and sustain Hilo's historic theater as a venue that will educate, entertain and inspire our diverse community".

The Palace Theater is the largest downtown venue in Hilo, and contributes significantly to the vitality of Hilo's business district. It has served many generations as a cultural gathering place, and as a popular fund-raising

space for other community non-profits. It is a showcase for Hawaii's performing artists, local and international filmmakers, and for communitybased, multi-cultural events. In 1992, the building was placed on both the State and National Historic Registers.

The goals and objectives related to the request;

The <u>overall goal</u> of this project is to maintain the increased comfort in the theater realized as a result of the 2021 installation of an air conditioning system, while at the same time defraying the escalating costs of electricity required for normal operations, and particularly that necessary to run the air conditioning.

<u>Objective</u>: The proposal for which funds are being sought is the best design for the theater, balancing cost with the unique load profile that a theater running air conditioning at night with power stored in batteries during the day creates.

In FY15/16, a photovoltaic system consisting of 81 panels was installed at the Palace Theater. Prior to this installation, bills from HELCO averaged \$1500 per month. Once the 81 PV panels were installed, electric bills were reduced by 50% (an average of \$750 per month.)

Operating from a robust 'Long-Range Plan' to strategically restore and preserve the theater for future generations, the long-term goal of upgrading the theater and increasing patron comfort through air conditioning was realized in 2021. However, this increased electric bills by over 4 times the monthly cost (up to \$3000 per month).

With the installation of the proposed 59.250 KW Solar system, it is anticipated that electric costs will be reduced by 75%, back to approximately \$750 per month.

The Public Purpose and need to be served;

Today, the public is looking for places to meet and gather that are as welcoming and comfortable as possible. The audience expects to watch a film, musical, or concert in optimal conditions, to fully enjoy the emotion of this collective ritual, and to want to return to it. This goal has been met through the installation of air conditioning at the Palace Theater in 2021, by far the most requested upgrade by patrons and performers alike.

The public purpose and need of this current request for an electrical 'energy' upgrade is to ensure that the Palace Theater and its programs can continue to be enjoyed into the future.

Application for Grants

The theater lost a great deal of its normal box office income during the mandatory shuttering of performance venues during the Covid-19 pandemic. It became a leader in innovation by pivoting to a virtual platform, and many of the recorded performances ("Live from the Empty Palace") have been picked up by PBS Hawaii. Now, as the pandemic restrictions are lifted, there is a significantly increasing demand for inperson performances. The staff have successfully put together a full roster of performances based on community feedback, but the escalating cost of electricity as a result is threatening to make this unsustainable.

The proposed project will reduce electric costs sufficiently to allow for the in-person programs to continue at the level demanded by the public.

Describe the target population to be served; and

Palace Theater programs are developed to engage a diverse audience of 25,000-30,000 annually from local community members to visitors from other locales.

In addition to patrons that come to enjoy performances at the Palace Theater, another key target population is the group of long-time performers who support the Palace as well as newer performers who find the Palace a welcoming venue to showcase their talents when they are starting out. Since many of the productions at the theater are presented in collaboration with other local groups, there is a high degree of community integration in each season's programs.

The Board of Directors wishes to continue year -round programming, with the theater being active nearly every night, and people of all ages, cultures, and walks of life coming to events. The long-term goal of Air Conditioning has now been met and audience numbers have increased; the goal now is to defray some of the escalating energy costs for the Palace Theater operations.

Describe the geographic coverage.

The Palace Theater is the largest venue of such historic significance and of its type on the east side of Hawaii Island. In addition, due to its attention to the emerging needs of visitors to the island, its geographic service area now extends to the mainland, as well as parts of Asia and Europe, as visitors come to experience the authentic Hawaiian performances for which the Palace Theater is renowned

#### III. Service Summary and Outcomes

Provision Solar Inc. will install a complete, turn-key solar electric (PV) system at the Palace Theater. All engineering, materials, and installation labor are included in the Provision proposal, as well as the coordination and procurement of all necessary building permits and interconnection to the utility grid. The system comes with monitoring and a 5- year warranty on workmanship.

Primary system components to be installed by Provision include: -150 Tesla T395H PV Module -5 SolarEdge Technologies SE11400H Inverter -150 SolarEdge technologies P400 DC Optimizer

These primary system components come with both material and performance guarantees. Provision is an expert in the field of solar solutions to individuals, businesses and commercial applications.

The work is projected to be completed in 9-10 months. Monthly Progress reports to the Board of Directors will ensure additional oversight during the installation.

Project Schedule:

Months 1 and 2: site evaluation, preliminary engineering and system schematic preparation, and document preparation

Month 3: finalization of engineering, preparation of permits packages – electrical, building and grading, and submission of permit packages to County of Hawaii.

Month 4: ordering of major components, site preparation

Month 5: start -up of array construction, electrical rough-in inspection

Months 6 and 7: Completion of array construction, installation of converters and hook-up to AC electrical distribution system

Month 8 and 9: complete electrical, final electrical and building inspections, HELCO inspection and approval to interconnect, execution of NEM Plus contract

Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results; and

<u>Quality Assurance</u>: The completion of the solar electric system will be overseen by Provision Solar Inc., a longstanding integral part of the Hilo/Big Island community. Incorporated in 1998, Provision has designed and installed solar electric systems for residential, commercial and government applications.

The company has deep roots in the solar industry. The co-owners have each been engaged in the solar industry since the 1970's, and are considered experts in their field.

Monthly progress reports to the Board of Directors will ensure that the work is proceeding as agreed, in a timely manner and that funds are being used for the purpose for which they were allocated. The Board of Directors will also monitor the equipment being used, to ensure that it is new and not refurbished.

<u>Evaluation</u>: The success of the project will be evaluated by the reduction in electricity costs both initially, and over time. In addition, the Board will evaluate the overall quality of materials and workmanship.

The Friends of the Palace Theater Board of Directors has demonstrated a decade of successful fundraising for the 98-year old building, raising and investing over \$1M on various physical upgrades to meet ADA requirements, retrofit the building to withstand seismic threats, add a new metal roof, rebuild the performance stage, convert stage lighting to LED for energy conservation, completely upgrade the sprinkler system to achieve maximum fire safety, and restore the damaged, façade, among other upgrades. The theater projection system is also fully digital to meet the latest requirements in movie screening. These Board-led efforts have improved the theater both internally and externally, while at the same time creating employment within the community and enhancing audience safety and enjoyment.

Recent projects have included the restoration of the building's façade and marquee (funded by Historic Hilo Preservation Grant), the installation of gates to protect the building's entryways, and the repaving of the lane and parking lot to improve safety. The installation of Phase 1 of the air conditioning system and the upgrading of the sprinkler system were supported by Atherton Family Foundation and GN Wilcox Trust. These projects all occurred in FYs 2020/2021 and 2021/2022.

The Palace Theater is a 98-year- old building in downtown Hilo. Although it was left empty for many years, the stewardship of the Board of Directors over the last 20 years has ensured its structural soundness, and renewed its vibrancy as a viable and sustainable venue for performing arts.

Oversight of the work will be managed on a monthly basis by the Board of Directors.
