The Hawaii Aquatics Foundation (HAF) is dedicated to improving the healthy development of Hawaii's children and families by promoting, providing, and supporting aquatic injury prevention education and research. HAF is an IRS 501(c)(3) tax-exempt nonprofit organization that was established in 2017. The

Hawaii Aquatics Academy (HAA), the education branch of HAF, is a leader in the statewide effort to provide comprehensive aquatic safety education content and services to Hawaii's schools and communities.

In addition to our youth aquatic safety education services, HAF performs research to support the advocacy and development of a broad range of aquatic injury intervention initiatives. Our data-driven research has been used to affirm long-standing local assumptions, consistent with national studies, that children and families in Hawaii's lower-income areas are at a disadvantage with respect to personal aquatic safety competencies and the protective factors they provide.

HAF's headquarters are located on the Palama Settlement campus. Since 2018, HAF has partnered with Palama Settlement to provide during-school-hours aquatic safety and swim skill instruction programming to local schools. Our partnership goal is to significantly expand programming to include year-round "parent-and-tot" early childhood education, lifeguard training and certification for career pathway education programs, and family and kupuna fitness programs.

#### 2. The goals and objectives related to the request;

This request will be used to perform a major renovation and modernization of the Hawaii Aquatics Foundation's home pool at Palama Settlement. The Palama pool plays a vital role in the low-income urban community as the only publicly accessible facility offering a high volume of free aquatic safety instruction, learn-to-swim lessons, and other aquatic activities, such as early childhood and kupuna fitness programs. The objectives of this capital improvement project are:

- perform much needed long-term maintenance, code, and ADA upgrades
- replace old pump equipment with energy efficient models which utilize photovoltaic panels and energy storage
- install solar panels for pool and shower water heating to enable year-round programming for early childhood and kupuna participants who require warmer water
- install an automated pool cover to reduce annual water and chemical evaporation costs by 50%
- add features beneficial and specific for early childhood, family, and kupuna programs

#### 3. The public purpose and need to be served;

Consistent with long-standing local assumptions, The Aspen Institute's 2019 "State of Play - Hawaii" report, sponsored by the Liliuokalani Trust, stated that "The inability to swim has become a marker of poverty, with too few programs offering swim lessons. Too few lifeguards at beaches and pools, limit access to an array of water sports." HAF and Palama Settlement seek to overcome these barriers and provide a safe environment for all ages to experience and enjoy aquatic activities.

#### 4. Describe the target population to be served; and

The target population that will benefit from this Capital Improvement Plan includes multiple generations and demographics within the neighboring Palama and Kalihi areas. Over 5,000 K-12 students are located within a two-mile radius of the facility. In addition, the renovated pool facility will also be used to provide services to families, keiki, and kupuna.

#### 5. Describe the geographic coverage.

The proposed project is located on the Island of Oahu at 810 N. Vineyard Blvd., Honolulu, HI 96817 for the benefit of Kalihi/Palama schools, neighborhoods, and surrounding communities.



This includes 7+ years of experience in quality assurance activities along with government contracts management and program support. Since 2014, the Vice President has also served as the President of an Association of Apartment Owners which has provided oversight to large capital improvement projects, such as pool deck, roof replacement, full plumbing replacements, and spalling repairs for a 120 unit condominium.
