- Creation of Communities of Care based on the Model Code of Ethics for Educators, including high school students, teacher preparation student teachers and faculty, and in-service teachers to support emerging teacher candidates to avoid early career burn out and increase teacher retention in Hawaii public schools;
- Scholarships to students intending to become teachers in Hawaii public schools.

II. Background and Summary

1. A brief description of the applicant's background:

The HEA was formed in 1921 to help Hawaii educators in their fight for better pay and work conditions. Since its founding, the HEA has been dedicated to affirming the professionalism of all of Hawaii's teachers, administrators, and higher education faculty.

HEA was the original advocacy organization and for nearly 50 years represented the education community before the Territorial and State Legislatures. During the State Constitutional Convention of 1968, HEA was the first to testify in support of public collective bargaining. HEA played a major role in the establishment of the Hawaii State Teachers Association (HSTA), the Hawaii Government Employee Association (HGEA) Unit 6, and the University of Hawaii Professional Assembly (UHPA). With the formation of the unions, HEA shifted its focus to promoting educator excellence and professional development.

HEA continues its mission by supporting the Teaching as a Career (TAAC) program and professional development opportunities and scholarships for Hawaii educators through its Excellence in Teaching and Learning initiatives.

- 2. The goals and objectives related to the request;
 - To provide a vehicle for promoting the profession of teaching by supporting and enhancing existing and developing new Teaching as a Career (TAAC) clubs, CTE Education Pathways, and Education Academies in Hawaii public DOE and Charter high schools.
 - To motivate and encourage Hawaii high school students to pursue a career in teaching.
 - To inspire students in University of Hawaii system to enroll in coursework and programs that prepare them for a position in Hawaii public schools;
 - To involve Hawaii community stakeholders to support and participate in the Teaching as a Career (TAAC) Symposium, to highlight the importance of quality teaching.

3. The public purpose and need to be served;

One of the most pressing and critical needs of the State, the teacher shortage, will be addressed by:

- Supporting existing and creating new clubs, pathways, and academies in Hawaii public high schools;
- Creating excitement among high school students about a career in education while they
 are still in high school, connecting them to other students across the country via
 Educators Rising membership and conferences;
- Creating networks of support for these high school students via a series of symposia on Oahu, Maui, Kauai, and Hawaii Island;
- Forming Communities of Care to support these emerging pre-service teachers as they enter Hawaii teacher preparation programs and become "home grown" Hawaii public school teachers dedicated to serving their own communities.

The grant will be used to support the organization of new Teaching as a Career (TAAC) Clubs and Career and Technical Education (CTE) Education Pathways and Academies in Hawaii Department of Education and Hawaii Charter Schools, as well as the continued operation and enhancement of existing clubs, pathways, and academies.

It will also be used to form a solid foundation for aspiring teachers, to create a Community of Care for these individuals to avoid early career "burn out" and retain quality teachers who will serve in their own Hawaii communities.

Professionally prepared educators are needed at all levels to provide a quality public education to ensure a literate, well prepared population to carry Hawaii into a successful, prosperous future.

Even before the COVID pandemic, Hawaii was in crisis mode with a teacher shortage. The HSTA reported that 60,000 keiki were not taught by a qualified teacher, that the exit rate of teachers leaving Hawaii has increased by more than 70 percent since 2012, and that over 1,000 vacancies were filled with emergency hire teachers or long-term substitutes.

Long lasting effects of Covid resulted in pandemic-related fatigue and could be driving educators away from the job.

More than 50% of new teachers leave the DOE within the first five years of their employment. No enterprise can survive this rate of turnover. The community must come to grips with the fact that the shortage of public-school teachers is a community crisis, and it is going to take the community to end it. (Hawaii Education Association Accent Hawaii, April - June 2017, Joan Husted)

The HEA proposes to support a "grow our own" solution by supporting existing and creating and enhancing new pathways, academies, and clubs in Hawaii public high schools to inspire and encourage Hawaii students to choose teaching as a profession and return to their communities to serve in Hawaii public schools.

A major focus will be creating Communities of Care that connect aspiring, emerging, and in-service teachers along with those higher education faculty who prepare our future teachers to offer support and avoid burn-out and desertion of the profession.

4. Describe the target population to be served; and

Direct recipients of this grant are Hawaii DOE and Charter School high school students and teacher sponsors in education clubs, academies, and pathways. However, all Hawaii schools and communities will be served by increasing and retaining qualified Hawaii "home grown" teachers.

5. Describe the geographic coverage.

Hawaii public Department of Education and Charter School high school students and teachers participating in education clubs, academies, and pathways on all islands will be eligible to participate.

III. Service Summary and Outcomes

Under the leadership of the HEA Board of Directors, the Hawaii Education Association will use funding to support teacher recruitment and retention in Hawaii public schools:

- Collaborate with the Hawaii DOE and Hawaii Charter Schools to develop new Teaching as a Career (TAAC) clubs, CTE Education Pathways, and Education Academies on public high school campuses;
- Provide financial and leadership support for existing Hawaii DOE and Charter School TAAC clubs, CTE Education Pathways, and Education Academies on public high school campuses;
- Incorporate the work of the national organization Educators Rising in bringing expertise and excitement to high school students aspiring to become educators by sponsoring EdRising membership for interested Hawaii clubs, academies, and pathways;
- Provide scholarships to Hawaii public high school students in TAAC clubs, academies, and pathways to attend the national EdRising Conference to connect with other exemplary students who are also future teachers;
- Incorporate the work of subject matter experts in the Model Code of Ethics for Educators which connect TAAC clubs, academies, and pathways with teacher preparation programs and the public high schools they serve to create Communities of Care to support the well-being of emerging teachers;
- Conduct a TAAC Symposium on Oahu, Kauai, Maui, and Hawaii Island to highlight the importance of education as a profession, spotlight the work of

- TAAC students and teacher sponsors, and inspire other students to choose education as a career. These symposia will also connect high school students with faculty and teacher candidates in Hawaii teacher preparation programs to form a connection for our "grow your own" future teachers.
- Provide scholarships to Hawaii students who are enrolled in or have completed a
 Hawaii state approved educator preparation program who are employed in a
 Hawaii public school and to public high school students intending to become
 educators who are participating in a dual enrollment program at their high
 school in collaboration with a Hawaii institution of higher education;
- Create and disseminate a brochure to public high school and university students highlighting routes to becoming an educator in Hawaii public schools.
- Associated administrative cost of the grant activities.

- August 2023 Provide scholarships to students who are preparing or have completed a preparation program which will enable them to become licensed teachers in Hawaii's public schools.
- September 2023 Provide tuition support for Hawaii public high schools which have partnerships with University of Hawaii system campuses dual enrollment programs for early college credit for high school students intending to become teachers in Hawaii public schools.
- November 2023 Conduct an annual TAAC Symposium in each county for TAAC clubs and high schools with Education Pathway or Academy programs of study. Incorporate Educators Rising and Model Code of Ethics for Educators experts for the formation of Communities of Care within the clubs, pathways, and academies. These experts will continue to work with the clubs, academies, and pathways through the school year.
- December 2023 Provide grants to TAAC clubs and schools with Education Pathway or Academy programs of study.
- January 2024 Create and disseminate a brochure to public high school and university students highlighting the importance and routes to becoming an educator in Hawaii public schools.
- February 2024- Deploy scholarship applications for Hawaii high school students and teacher sponsors to attend the Educators Rising annual summer conference.
- March 2024- Award Educators Rising scholarships for a team of students and teachers from each county to attend the annual conference.

The HEA will evaluate and monitor quality assurance by:

- Surveying Symposium attendees to strengthen the connection between Hawaii educators and stakeholders who benefit from a quality public education system.



- The Executive Director has supported the association for thirty plus years and has responsibility for all administrative and operational duties of the HEA office and supports the Board of Directors.
- The Program Manager has responsibility for developing quality professional development for Hawaii educators. This staff person has a doctorate in education and decades of experience working with educator preparation, licensure, and professional development.
- The Clerk/Receptionist has responsibility for clerical duties as well as website and social media account maintenance.
