

## II. Background and Summary

This section shall clearly and concisely summarize and highlight the contents of the request in such a way as to provide the State Legislature with a broad understanding of the request. Please include the following:

1. A brief description of the applicant's background;

In the late 1940's, as outrigger canoe paddling continued to become more popular, a group of Oahu folks from different clubs would get together to talk about organizing a level of competition between the clubs. The discussions would include the places to hold the competition, the ages and distances, the officiating needed, and what to call the organization.

The list of people involved in the planning was impressive. John Lind, Samuel Fuller, Bob Fischer, Bill Capp, Duke Kahanamoku, Sarge Kahanamoku, John Kapua, John D. Kaupiko, Wally Froiseth and Stu Kalama were a few of the contributors among others.

In 1950 the Hawaiian Canoe Racing and Surfing Association was formed. Samuel Fuller, of Outrigger was the first president, and John Lind, of Waikiki Surf was the second.

Competition between Oahu clubs continued until 1963 when the Hawaiian Canoe Racing Association was registered as a not for profit corporation in the state of Hawaii. Neighbor island clubs began to join the association beginning in 1966.

In 2010, The Hawaiian Canoe Racing Association was registered as a nonprofit corporation with Dunne and Bradstreet.

2. The goals and objectives related to the request;

The goal of this request is to secure funding in order to successfully host the 2024 IVF World Sprints which is a prestigious international va'a event showcasing the Hawaiian culture, people and land. The International Va'a Federation is the governing body of the international va'a sport. It was founded in 1981 to establish pathways for va'a competion at the highest level. The intent was a steppingstone to one day have outrigger canoe paddling in the Olympics. The first World Sprints was held in 1984 in California. Like the Olympics the World Sprints are held every two years with different host countries submitting bids to win the privilege of

being the host. The last time Hawaii hosted the World Sprints was in 2004 in Hilo, Hawaii.

3. The public purpose and need to be served;

Outrigger canoe paddling is an essential part of the Hawaiian culture. The public purpose is to preserve, perpetuate and pass down knowledge from one generation to the next. This is needed to ensure the longevity of this Hawaiian practice and sport. The high cost associated with competing internationally limits the talent and number of competitors for Team Hawaii. Hosting this event in the islands that they were created, allows our paddling community and supporters to participate and cheer for the home team. Due to the financial burden of traveling internationally there is usually a much smaller delegation for Team Hawaii especially amongst the younger age divisions of 16 to 19 year old. Hosting this event will probably be a once in a lifetime opportunity to be able to compete at this level for our youth in the 16 to 19 age range.

This event also serves a secondary purpose in having a ripple effect within our local economy by helping to support major industries such as travel, hospitality and tourism and local businesses and local families.

4. Describe the target population to be served;

The target population is paddlers, ocean lovers, supporters, and spectators of Hawaiian canoe paddling. The Hawaiian Canoe Racing Association has approximately 10,000 paddlers with ages ranging from 9 to 83. We believe if you live in the State of Hawaii that outrigger canoe paddling should be in your life in some shape or form. This could mean you are a paddler, a spectator, a coach, or a supporter. By hosting an event at this magnitude, we have an opportunity to build the strongest Team Hawaii. We wish to inspire younger generations to seek a healthy lifestyle while also keeping hold of our traditions and sharing them with the world. Similar to other sport teams from Hawaii like the 2022 Little League Championships, this will help to instill a sense of place and responsibility to Hawaii.

5. Describe the geographic coverage.

Currently there are 35 countries that make up the Internal Va'a Federation. Previous hosts for the World Sprints include California, Tahiti, New Zealand, Samoa, New Caledonia, Fiji, Australia, Canada, Brazil and this past 2022 was held in London. There were 19 countries in attendance in London with the biggest teams being Team Hawaii, New Zealand, Great Britain, Brazil, and Canada. Historically Tahiti has the largest delegation of paddlers and are planning to attend in Hawaii in 2024.

## III. Service Summary and Outcomes

2024 will mark 20 years since the last IVF World Sprints were held in Hawaii. The purpose of this proposal is to assist HCRA in hosting this International event for thousands of paddlers. This event attracts racers from all Hawaiian islands, the mainland, and up to 35 other countries. This race helps perpetuate the Hawaiian tradition of canoe racing, an activity at the heart of the islands' indigenous culture. Our goal is to inspire a younger generation of paddlers who are rooted in their culture, the land and the sea. In addition this is an opportunity to unify all of Hawaii paddlers throughout the State. Each paddler who qualifies for this event will represent Team Hawaii.

1. Describe the scope of work, tasks and responsibilities;

Once Hawaii was awarded the bid for the 2024 International Va'a Federal World Sprints in 2020 the planning process began. Hawaii Canoe Racing Association (HCRA) has previously hosted this event in 1988 and 2004. Several board members are still active now and serve as a resource of knowledge. There is also a binder containing the planning documents from 2004. The scope of work was identified shortly after winning the bid and the tasks along with responsibilities were assigned out. We have been meeting on the last Friday of each month since March 2022 and quarterly prior to that to review details associated with each task. Below is a brief description of each committee. I have also included a detailed excel spreadsheet which includes the tasks and responsibilities for each committee.

Merchandise – Create logo and colors for the event. Determine items to be sold, quantities to be ordered and pricing. Place order to ensure timely delivery of product to Hilo. Rental truck needed to store overstock and workers needed to sell all 10 days.

Website & Social Media – Find company to create website specifically for this event. Website has to be up no later than 1 year from the start of event. Social media posts to also begin 1 year out.

**Finance & Grants** – Find funding opportunities, submit grants be deadlines, document grants submitted and track any received. Follow up on grant report updates if needed.

Advertising & Marketing – Obtain sponsors banners and logos. Determine where certain sponsors will be showcased. Order advertising and marketing items such as banners, awards banners, flyers, etc.

**Course** – Bids to be submitted for lane setters. Determine specifications and equipment needed to meet IVF requirements. Order now in case there is a delay in shipping or items need to come internationally.

**Canoes – V6** Bids have been accepted for both V1 and V6 canoes. Contracts for funding of canoes needs to be established. Deadlines for canoes to be in Hilo. Coordinating delivery of canoes after event to clubs or individuals who have purchased canoes.

**Officials** – Determine how many land and water officials are needed and how many days they are available. There is also a certain number of IVF officials required who will need flights, lodging and transportation.

**Culture Night** – Determine when Culture Night will take place, where, and time. Determine the order of countries and length of time each.

**Practice Schedule** – Create schedule for each country for days and times to practice prior to the official start of racing.

**Logistics Equipment & Supplies** – Create list of all supplies needed for each committee. Determine how much equipment can be borrowed and or obtained on Hawaii Island. If items need to be shipped in determine length of time to arrive in Hilo and storage facility.

**Food Vendors** – Publish announcement for food vendors along with criteria, calendar and price associated with being a food vendor.

**Craft Vendors** – Publish announcement for craft vendors along with criteria, calendar and price associated with being a craft vendor. Planning to have craft vendor similar to Merrie Monarch set up and possibly that same group of craft vendors.

**Transportation** – Create listing of local transportation. Meet with County of Hawaii regarding adding more shuttles in the Hilo area to accommodate the influx of paddlers and spectators.

**Lodging** – Reach out to local hotels and inquire on group rates. Block off rooms for officials. Meet with County of Hawaii to discuss other possible lodging opportunities.

**Opening Ceremonies** – Planning of the parade of nations on the water. Determine what Team Hawaii will do, who, how, and how long. I envision something like the kapa commercial from Kamohalii who I believe is from Big Island.

**Closing Ceremonies** – Planning for the closing ceremonies. Where will it be held, how long will it last.

Volunteers – Reach out to different groups for volunteers from other local nonprofits or organizations such as Rotary club, Lions club, YMCA/YWCA, Hawaiian Kokua, First Hawaiian Kokua, etc.

**Medical** - Work with County of Hawaii on recommendations similar to Iron Man race held and who coordinates and handles their medical.

**Media** – Ocean 16 and Live Stream probably from Air Tahiti. Need to create credentials and count of authorized media people for each county. Need to determine designated area for media. Create media packages.

**Sponsorship** – Secure funding for hosting of event. If monetary funds are not available also seek in kind donations to lower expense costs.

**Commentors** – Locate and coordinate commentors for the 10 days. Reach out to local news stations to inquire on guess commentors. Reach out to UH Hilo to see if there are students able to assist with this.

**Translators** – Locate and coordinate translators for countries with the highest delegation of team members. Reach out to UH Hilo to see if students are available to assist.

**Program/Race Schedule** – Put together and print approximately 1,000 programs for sponsors. A digital online version also available.

**Awards** – Design and order within timeline to ensure timely delivery before event. Give sponsors the opportunity to be guest award presenters is a great promo and photo opportunity.

**Security** – County of Hawaii suggested reaching out to local Motorcycle club as they are economical and have been doing security for several other large events.

Activities/Cultural Experiences – Work with local businesses and non profits and what is available for promotion to visitors. The Hawaiian Voyaging Society has already signed up to offer workshops.

**Communication** – Securing sound system for the event is critical. Walk Talkies for all land and water officials is also necessary. A team of people to create communications to be posted online or on social media as well to ensure all countries are kept in the know.

**Beach Master** – Team of volunteers to designate racers to the appropriate canoes prior to race.

Water Officials – There seemed to be a lot of water officials and they would rotate shifts. We should ensure the water officials do not provide guidance on lane assignments.

**Parking** – Coordinate with County of Hawaii designated parking areas and possible restrictions. Ensure there are adequate handicap stalls. Probably need security and possible volunteers to monitor parking is uniformed.

**Facilities** – Determine and mark designated facilities for various groups such as Medical, VIP, Officials, Racers, Media, etc. Create signage and communication to ensure facilities are only used for those it is designed to.

VIP – Create and host a designated area for all VIPS such as Sponsors, Politicians, Actors/Actress, Sport Athletes, etc.

## V. Experience and Capability

## 1. Necessary Skills and Experience

The current HCRA executive board is as follows:

President - Dana Miyake first joined Hawaiian Canoe Racing Association (HCRA) as the Kauai Outrigger Association (KOA) delegate in 2014. She is a paddler of 42 years. Dana has coached Na Opio and adults for the last 30 years. She served as President for Kukui'ula Outrigger Canoe Club from 2009 to 2013, President for Kauai Hoe Wa'a 2010 to 2022. Race Director for KOA from 2014 to 2019. HCRA Vice-President in 2019 and newly elected HCRA President as of 2022. She was integral in coordinating the 2019 HCRA State Championships on Kauai. In her role as Race Director for KOA she also organized the Na Pali Challenge. She was able to help secure a grant from Hawaii Tourism Authority in 2019 for HCRA State Race on Kauai in 2019 and Hawaii Community Funding contract number CON 19055 for \$30,000. She also assisted with the grant writing for rebuilding of Hui O Mana Ka Pu'uwai Canoe Club after flooding in 2019. Hui O Mana Ka Pu'uwai was granted from Hawaii Community Funding grant 11175 for \$30,000 and Youth 2022 00001071 for \$20,000. The first grant was for repairs to canoes from the flooding and the second was to assist with the High School Program for Kapa'a High School which Dana is the currently Varsity Girls coach in addition to also being an assistant coach to the Hui O Mana Ka Pu'uwai Na Opio program where several of her high school paddlers are also members.

**Vice-President/President Elect** – Keri Mehling – Has been a part of the paddling community for over 22 years. Her first year she was trained as a stand official, leading to serving every year since as a stand or water official and even a stint as MCHCA's race director. That in turn led to participation representing Maui at the HCRA level, and learning the ropes as an Association and club representative. In 2020, she was elected as HCRA President and served in that role in addition to HCRA secretary, on the Bylaws, Merchandise and Insurance committees and handling HCRA's litigation.

**Race Commissioner -** Samantha Moikeha – Samantha is also the current IVF Vice-President. She has been involved in the paddling community in Hawaii for close to 40 years. Throughout her life she has gained experience, knowledge, and background in participating, coaching, operations, safety, officiating, training, and networking. Prior to her current position as Race Commissioner, she served as the HCRA Race Secretary charged with managing and facilitating the racing matters of HCRA. Her passion is in working with younger generation participants who are eager to learn more about the leadership and operational needs of our races.

Secretary - Heather Murakami – Has been involved in outrigger canoe paddling for over 30 . She is a member of Lokahi Canoe Club and was their club representative a decade or so ago. She is also a member of and sometimes officer for the Hawaii State Association of Parliamentarians, Democratic Party of Hawaii (DPH), and Oahu College Band/Kukui High Alumni Band. Rules are here area of expertise.

(HCRA, Hui Waa), party and convention rules (DPH).

**Treasurer** - Barbara Querry - Barbara has been involved with HCRA and MCHCA since 2004. In

2004, she served as HCRA Treasurer until 2007 and is the current HCRA treasurer. She also served as HCRA Merchandise Chair from 2008 to 2012. At the Maui level, she served as the MCHCA treasurer from 2004 to 2007 and the MCHCA President/HCRA representative from 2008 to 2011. She is also active at Hawaiian Canoe Club where she has served as director/secretary from 2006 to present. Barbara is a Certified Public Accountant and has been practicing in public accounting since 1996.

**Race Secretary** – Noe Fox -Extensive background in Race Secretary duties as they relate to the sport of outrigger canoe paddling in Hawaii. Noe has served in various positions from a club level, association level, and most recently a state level as the Assistant Area-Coordinator. Starting as a club representative has helped her gain an understanding of what works for clubs of different sizes and then implementing procedures and processes that keep registration tasks accessible to everyone involved. Her most recent process streamlined registration and results for the HCRA: World Sprints Time Trials in February. This process moved registration to 100% online, mimicking the procedures that she put in place at Hui Wa'a as their Race Secretary for almost 6 years. She has been instrumental in making the crew entry process at State Race more efficient and also serves as the current registrar (Race Secretary) for the Na Opio Canoe Racing Association, which she has been a volunteer for many years. From club rep to registrar, to Race Secretary, her background working in different associations helps Noe work well with others to make sure we can get as many paddlers on the water as possible (when it is safe!).
