II. Background and Summary

A brief description of the applicant's background;

The educational non-profit corporation (50lc3) of Ho'oulu Lāhui was formed in 1995 through a community grassroots effort with the vision of restoring the 600 acre ancient Hawaiian village of Pu'ala'a as an educational opportunity for the youth and families of Hawai'i Island.

Since its creation Ho' oulu Lāhui has offered successful programs for our community youth, families and community members. We believe that investing in the education of our community is the key to changing the trends of destitution facing our community currently. Our programs are culturally driven; yet support the skills necessary to succeed in today's technological world and challenging economic conditions. Practical skills with real world application offer a successful combination. Ho'oulu Lāhui strives to support and develop local access to, and coordination of services and programs which safeguard the education, our environment, as well as the health, cultural well-being, and economic self-sufficiency of our community.

From 1995 until today many deep partnerships have been formed within the community. When our local programs became established, we extended our program reach statewide, nationally and internationally.

In 1998 the Charter School legislation was passed and the Hawaiian focused Kua O Ka Lā Charter School (KOKL) emerged as a result of the successful programs run by Ho'oulu Lāhui. Ho'oulu Lāhui is an independant non-profit but one of its key missions is to support Kua O Ka Lā through facilities development, grant funding, programmatic support and also is Board approved as it's fiscal sponsor. Ho'oulu Lāhui will be the fiscal sponsor for Kua O Ka Lā for this application.

In 2018 the Kilauea eruption consumed the 600 acre campus developed by and for Ho'oulu Lāhui and also the home campus to the Hawaiian focused Kua O Ka Lā Charter School. Kua O Ka Lā's main campus has now relocated to the 22 acres at Nani Mau Gardens located in Panaewa. Our satellite sites are located in Nanawale, Puna and Miloli'i in Ka'u serving grades Pre K-8.

We are working to stabilize the facilities and programs since the eruption, for our non-profit, school and community and to expand our services by establishing the resilience hubs and learning environments and facilities that support keiki to kupuna learning provide capacity building opportunities, and realize our mission. This project 'Ho' oulu Hou- To Thrive Again" will provide a big step in addressing this vision through 2 overarching goals.

The goals and objectives related to the request;

This project has 2 overarching goals and objectives to include:

• Goal #1:Community Resilience Hub Strategic Plan Development: (3 Sites)
Objective 1a) Develop a strategic project and implementation plan for
community resilience hubs (3) that address community education/learning,
workforce development, entrepreneurship, food security/sustainability, innovation,
technology, and community partnerships.

This plan will include the following elements:

- Disaster preparedness and response
- Foster lifelong learning, K-12 and beyond (upskill, reskill)
- Empower residents to become entrepreneurs
- Address food insecurity, and explore value-added product production
- Expose residents to technology and design thinking as a tool to address long-standing community challenges
 - Community Collaborations

Objective 1b) Pilot the Resilience Hub Strategic Plan Initiatives: Pilot strategies within the resilience hub plan to establish proof of concept, and sustainability. Link the 3 resilience hub sites Islandwide with resources, food distribution, training and support.

• Goal #2: Complete the Steps Required prior to the Purchase of 6 acres of the (22 acre) facility at Nani Mau for both KOKL Charter School Long Term stabilization and the Central Community Resilience Hub (non-construction related initiatives)

Objective 2a) Special Use Permit Amendment: Submit a special use permit revision for the community resilience hub for uses of programs and facilities within Ag zone that require a use permit as identified in the Resilience Hub Strategic Plan.

Objective 2b) Nani Mau Rezone of the current 22 acres from Ag. 10 to Ag. 5 in order for the purchase of 6 approved acres for purchase to proceed

Objective 2c) Nani Mau Subdivision to a 6 acre piece within the 22 acres.

The Nani Mau facility has been brought into county and state compliance to operate as a school in Agriculture zone and now has the opportunity to ensure its long term existence and realize their vision for providing Hawaiian culturally based education through the public charter school as well as well as community education, capacity building and resource support as a Resilience Hub. The (3 sites) key resilience hubs will address disaster preparediness & response, food security, technology, internet and other community resilience needs. Starlink Sattelite will be established for school and community access as Internet access continues to be a challenge in this location and for this community and is essential in times of disaster.

This collaborative effort with identified community partners is designed to meet the education, job creation, workforce training, college-ready, and internship/mentorship

aspirations of the community. It is intended to be inclusive in educating and empowering people across the lifespan through the integration of traditional and modern practices, programs, and facilities that enhance community resilience.

The public purpose and need to be served;

RESILIENCE is the ability of people and their communities to anticipate, accommodate and positively adapt to or thrive amidst changing conditions and hazard events. Resilient communities enjoy a high quality of life, reliable systems, with educational and economic vitality, and they conserve resources for present and future generations. The term resilience is often used interchangeably with emergency preparedness and response, but these elements only address part of this important concept. Resilient communities build community capacity through keiki to kupuna education, facility development and resources support and allocations.

The County established a "Recovery and Resilience Plan" <u>Kīlauea Recovery and Resilience Plan</u> as a guiding strategic document that facilitates recovery in the short and long term from the 2018 Kilauea eruption. The plan identifies recovery strategies and projects that support the impacted areas which extend Island wide. The Recovery Team facilitated, collaborated, and coordinated with the public, and federal, state and county stakeholders to ensure the Plan was developed through broad stakeholder engagement throughout the entire recovery planning process which included members of Ho'oulu Lāhui and Kua O Ka Lā Charter School. The Implementation of the Plan requires continued collaboration across government, community and private sector stakeholders.

Resilience and capacity areas were identified in targeted areas which include; Establishing a Network of Resilience Hubs; Food Security & Resilience and Agriculture Development; Youth Development and Resilience as key areas of focus and support.

The following is taken from the County Plan which directly identifies the HO'OULU HOU COMMUNITY RESILIENCE HUB. This project involves purchasing a 6 acre portion of the facility at Nani Mau Gardens by Ho'oulu Lāhui to reestablish Kua O Ka Lā Public Charter School to PreK-8 public school education and broaden the reach to serve as a resilience hub to address disaster response and keiki to kupuna community resilience capacity needs. This collaborative effort is designed to meet the education, job creation, workforce training, college-ready, and internship/mentorship aspirations of the community. It is intended to be inclusive in educating and empowering people across the lifespan through the integration of traditional and modern practices, programs, and facilities that enhance community resiliency. Community Partnerships include: Ho'oulu Lāhui, Kua O Ka Lā Public Charter School, EA Ecoversity, Kū-A-Kanaka, Vibrant Hawai'i, Rotary Club of Pāhoa Sunset and others.

This project is prioritized by and directly addresses these County plan goals and serve the public purpose by 1) planning for the Resilience hub and piloting action strategies within the plan for feasibility and sustainability 2) securing all the rezone, subdivision and (non construction) revised use permits to include resilience hub (non ag allowable) uses at Nani Mau in Panawea, Ag rezone from Ag 10 to Ag5, and subdivide the 22 acre piece to carve out the 6 acres to be purchased at a later date. We need multi purpose community spaces that addresses some of the gaps in service with a comprehensive plan to design the resilience hub project implementation. This project will plan for and establish the facility for enhanced opportunities, training and resource deployment to uplift our community at large.

Describe the target population to be served; and

Ho'oulu Lāhui has been established to support the education for our community over the past 26 years. Our programs initially focused on our local schools, prison and mental health population, all areas with a high percentage of native Hawaiians. We expanded our reach to serve the Island wide community at large.

One of our primary goals was to support the establishment and continued financial support and partnership initiatives (including facilities) for Kua O Ka Lā Charter School. Kua O Ka Lā is a Hawaiian focused Charter School and as a public school, welcomes all students. The school has historically and predominatly served our Native Hawaiian population with a focus on our 'at-risk- population. Currently the school has approximately 65% Native Hawaiian students. Students from all walks of life who will be enriched by this completed initiative. We are a community school, we engage 'ohana and community members in our events and have extensive community collaborators and partners that we engage with. This initiative, through our resilience hub pilot program will target individuals, families and community organizations in 3 Districts including Puna, Hilo and Ka'u.

Both organizations have developed extensive collaborations and public partnerships, many of whom will be engaged in this Resilience Hub initiative. These include EA Ecoversity (adult & cultural education), Ku-A-Kanaka (social enterprise & training), Rotary Club (community projects), Vibrant Hawai'i (Resilience Hub support, resources and planning), Food Bank (food distribution), County of Hawai'i (Recovery and Resilience Action committees).

Describe the geographic coverage.

This project will service the entire Island of Hawai'i. The non-profit and charter school support 3 school sites including predominately, lower Puna (Nanawale facility), South Hilo (Nani Mau Garden facility) and Miloli'i in Ka'u. Our online Hipu'u Academy has a site in Miloli'i which services all of West Hawai'i including Oceanview but also has may students in Hilo, Ka'u and Puna. Students, families, community members and organizations from across the Island will convene to participate in the Resilience hub planning and pilot initiatives, and benefit from the initial steps identified here resulting in the long term stabilization of this important public community facility at the Nani Mau Gardens in Hilo.

We will contract with a Community Regional Planner to convene and facilitate community conversations that inform the strategic plan to be developed and piloted resulting in a Resilience Hub Strategic Plan

Approach: The Regional planner and Project Director will convene project team members monthly and periodically meet with community stakeholders including individuals and organizations to provide input, review and evaluation of the developing plan.

The Plan elements contain the following components

- Capacity: staffing, training,
- Intended uses and services
- Project Implementation: Actionable Items: how & who will it? Resources needed?

Goal 1b) Outcome/Results: Pilot demonstration of idenfified elements of the Resilience Hub Strategic Plan

Approach: During the planning process and with input from community stakeholders, the project team and contractors will identify initial action steps from the developing Resilience Hub strategic plan to pilot. The `ohana/community coordinator will work with the team to plan and coordinate the pilot initiatives including the flyers, communition, supplies needed, evaluation and input for revisions. The following action items will also be included in this pilot:

- Food Distribution
- Internet availability for enhanced educational opportunities (see budget)
- Cultural Demonstation and hands-on opportunities
- Training/workforce development: i.e. CPR certification

A 15 passenger van will be purchased to support and ensure the success of this initiative as people, resources and food need to be consistently transported Islandwide to the Puna and Ka'u sites from the main hub in Hilo.

Goal 1: Measures of Effectiveness

Multiple strategies will be in place to measure the effectiveness of this goal including:

- Feedback from Stakeholder input sessions will be documented
- Development of a Logic Model identifying short and long term outcomes
- Surveys of individuals and organizations participating in the pilot initiatives
- Resilience Plan revisions will occur based upon stakeholder input and surveys

Goal 2: Outcome/Results: Successful submission of the Special use permit, rezone application and subdivision application to the County of Hawai'i.

Approach: The Project Director will work closely with the Land use Planning Consultant to secure all of the information required to complete and submit the applications for the above listed permits. The use permit revision application will be informed by the developing Resilience Hub Strategic Plan identified long term initiatives to ensure that we will be compliant over the next decade at least. The subdivision will require community neighboring input and all plans will require testimony to the Agency including the Windward Planning Commission.

Measures of Effectiveness: Securing the approval for the 3 initiatives will be the ultimate measure of effectiveness but due to the lengthy process distal to our control for each initiative, we may not see all three with completed agency approvals by the end of the project year, but we will have the submittal of the applications completed and in process.

Goal 3:Outcome/Results: Successful grant management

Approach: The Project Director will work closely with the 'ohana/community coordinator, fiscal officer, the contractors and the community stakeholders to ensure that all goals identified in this project are moving forward, on time and on budget. She will work with the fiscal officer to ensure all budget items are in line with identified expenditures and that all narrative and budget reporting for the grant requirements are completed on time.

V. Experience and Capability

1. Necessary Skills and Experience

The applicant shall demonstrate that it has the necessary skills, abilities, knowledge of, and experience relating to the request. Grant Management: Ho'oulu Lāhui has developed and operated community programs, developed facilities, developed a school and managed 17 million dollars in grants over the past 26 years. We have never defaulted on a grant or missed any timelines. We are nearing the third year of managing a 1.3 million dollar Federal grant developing culturally based curriculum and providing professional development and community education. We are also currently County fundeded to engage with multiple community partners in an environmental project to learn about and utlize effective microorganisms to clean up a community pond with over 250,000 users annually.

Planning: Most of our long term sustainable initiatives have commenced with developing strategic action plans to guide our successful implementation of projects, facilities development and program sustainability. We have developed Organization Master Plans, Forestry Plans, Building plans. We feel confident that in collaboration with a professional planner, we can convene and develop a resilience hub strategic action plan that is functional, practical, engages community collaborators, and addresses short and long term sustainability of the project.

Community Partnerships: We have developed deep community partnerships over the years and many of these relationships will be engaged in this planning and pilot resilience hub initiatives now and moving forward.

Facilities: In the last 3 years we have raised the funds (\$625,000.00) and brought the partnering KOKL Charter School into county compliance with fire and building codes in order to secure our E occupancy. This required working with multiple contractors over several years. Prior to this, we built the entire facilities at Pu'ala'a in puna, replete with greenhouses and school classrooms for 282 students, which included securing SUP, and all necessary permits. We have also maintained our facilities over the past 20 years. We are fully capable of working with the Land use planner to guide and complete all the processes

required to proceed with these non construction related initiatives including a revised SUP, rezone and subdivision.

Kua O Ka Lā NCPCS has a 3 campus sites for our school at the Nani Mau gardens, Nanawale and Miloli`i. The main campus has four buildings that include the classrooms for the students, the administrative office, a SPED classroom and a large 150 x 40 foot newly renovated greenhouse.

The greenhouse was renovation this past summer with 5 F/T paid Interns awarded to Ho'oulu Lahui by KUPU and overseen by Development Director Susie Osborne who will also oversee the successful management of this project. The greenhouse facility includes a large area with a kitchen, freezers, sinks, solar hot water and stainless tables all set up for our award winning culinary program offered to our students. Starter agriculture tables are laid out with irrigation. Large areas are dedicated for project based initiatives such as the current 20 x 20 mural being done by the elementary students which reflect our new place and our school value of Kulia I Ka Nu'u (strive to reach your highest potential) This was funded by another grant award through Ho'oulu Lāhui. These facilities will centralize and support our resilience hub food distribution initiatives for our islandwide distribution.

While nothing can replace our 600 acre original home of Pu'ala'a in Puna, we are working hard to stabilize the non-profit and school with facilities that meet the learning needs of the students, families and community and are safe, and allow us to fulfill our mission which has a strong focus on our Hawaiian culture, our environment and our community relationships. These facilities are conducive for piloting our Resiliece Hub initiatives and we will enjoy facility expansion upon completion of the SUP and future purchase.

We are always ontime and on budget with our grant reporting and our audits are all clean.

Contract: Dr. James Miller (See Resume Attached) Dr. Miller will work with the Project Director and community stakeholders in the development of the Strategic Action Plan for the Resilience Hub (3 sties) Dr. Miller, a native Hawaiian, has been working with the County of Hawai'i and Vibrant Hawai'i on Recovery and Resilience planning and is very familiar with the work of and need for Resilience Hubs. He has also worked with the Micronesian and Native Indian communities with resilience initiatives. He is an architect, and a regional planner and brings great expertise to this project.

Contract: John Pipan (See Resume Attached) Land Consulting: Owner: Land Planning Hawaii LLC Land Planning Hawaii, Hilo HI We will contract this Hilo based firm which has extensive experience in planning. They will work with us in addressing the rezone, subdivision and special use permit applications and processes for completion. This company was previously owned by Kern Associates and John Pipan has in both organizations has coordinated projects with government agencies and stakeholders. They also prepares technical environmental review reports for administrative and discretionary land use permits.


