#### 3. Public Purpose

The Paukukalo Coastal Wetlands is owned by the County of Maui and it is utilized as a public park and outdoor classroom for Maui residents and visitors. The State funding will be used towards this public purpose project.

## II. Background and Summary

#### 1. A brief description of the applicant's background;

KAEHU is a nonprofit organization managing 64-acres of coastal wetlands on the island of Maui in the district of Wailuku. KAEHU's goal is to restore the land, shoreline and natural resources of the area and perpetuate traditional Hawaiian culture using a community-based, inclusive, family-oriented approach to environmental and cultural stewardship. KAEHU currently provides cultural education and career exploration programs in natural resources management intertwined with Hawaiian culture and values of land and shoreline stewardship.

The Paukukalo Coastal Wetlands are bordered by Iao and Walehu Streams. This area was once filled with ancient taro patches, native flora and fauna, native trees, productive fishponds, two streams of fresh clean water, fresh water springs throughout the property, a bountiful ocean with plenty of limu (seaweed), and fish and ocean wildlife. There are significant cultural sites, including Makahiki grounds, throughout the property and this area was known for the "sacred lauhala grove". This area was a playground for the ali'i and was deemed kapu, sacred.

After years of mismanagement, toxic dumping, overgrowth of invasive flora and fauna, and neglected ancient taro patches, cultural/archaeological sites, fishponds and 'auwai (irrigation) systems, the area is overgrown and in a poor state of disrepair.

In 2009, community members requested assistance from the Trust for Public Lands to secure the parcel to avoid future development of high-end homes and a hotel. With help and support from

Hawaiian Homesteaders, community organizations and leaders, politicians, and cultural practitioners, in 2012, The County of Maui and Trust for Public Lands worked together to secure the Ka'chu Bay 64-shoreline acres in Paukukalo, Wailuku, Maui. The Paukukalo Coastland Wetlands is an undeveloped parcel that is rich in natural and cultural resources, along with native flora and fauna. The area provided agricultural crops that helped sustain the district. The offshore area is an estuary necessary for spawning fish, a place for monk scals to rest and play, and a birthing place for green sea turtles to nest and lay their eggs.

Over the last 6 years, KA'EHU has been working to restore the area through partnerships, community and volunteer kokua, and culturally-grounded and STEM-based educational workshops to train individuals in natural resource management skills integrated with the traditional Ahupua'a stewardship values and wisdom.

The goals and objectives related to the request;
 30X30 Conservation & Restoration of the Paukukalo Wetlands located at Ka'ehu Bay.

Goal: Help restore the Paukukalo Coastal Wetlands to its optimal state.

Objective 1: Provide Natural Resource Management training to K-12 students, college students, and community volunteers to empower them with the skills needed to care for the natural resources in their communities.

Objective 2: Removal of Invasive Flora, Fauna and driftwood from the wetlands and shoreline.

Objective 3: Create paths to access more of the coastal wetlands for the staff, public and scientists.

Objective 4: Collect Baseline data needed to develop a mitigation plan to restore the shoreline and coastal wetlands,

The public purpose and need to be served:

Ka'ehu Bay, aka Paukukalo Coastal Wetlands, was purchased by Trost for Public lands and sold to Maui County utilizing Open Space Funds to help conserve and protect the area for future generations. Currently, the public is restricted to utilizing just a few acres of the coastal wetlands due to the excessive overgrowth and no trails to access the entire parcel. This project will help to remove overgrowth, invasive flora and fauna, and help to clear trails for the public to access more of the area.

The public currently utilizes the area for:

- a) Fishing & Camping
- b) An Outdoor Classroom
- c) Cultural Workshops and Classes
- d) STEM-based educational workshops in natural resource management
- e) Community Events & Training

KA'EHU services community members of all ages, from newborns to kupuna from all backgrounds and ethnicities.

Annually, KA\*EHU is projected to serve over 1,200 public and private school students, along with community organizations, businesses, government agencies and individual volunteers.

Restoring the area and clearing trails for the community to access more areas of the coastal wetlands will help KA'EHU to expand it's outreach, events and community support.

This data proves to be very informative and helpful in showing the impacts of an outdoor classroom and education program.

Pre- and Post-tests, evaluations and questionnaires are given to college students and adults participating in KA'EHU's programs. On-going qualitative data is also collected through in-person interviews.

Staff and mentors will review the data on the feedback and make necessary adjustments to improve the program.

#### V. Experience and Capability

#### 1. Necessary Skills and Experience

KA'EHU is a nonprofit managing 64-acres of coastal wetlands with the goal to restore the land and perpetuate traditional Hawaiian culture using a community-based, inclusive, family-oriented approach to environmental stewardship and sustainable agriculture.

KA'EHU partners with public and private schools, community orgs, cultural practitioners, businesses and government agencies to help to manage, maintain and restore marine ecosystems and coastal wetlands.

The KA'EHU staff currently implement multiple community cultural and educational programs for Maui students, youth and families, kupuna, and community volunteers. Over the last 6 years, the staff has developed, coordinated, and implemented various culturally-grounded and STEM-based programs to over 5,200 Maui residents of all ages.

Community programs include:

Community Environmental Stewardship Program, funded by Maui County, which provides an outdoor classroom for public and private schools and community organizations to learn about traditional cultural practices and STEM-grounded subjects in natural resource management.

Ka'ehu Youth Enhancement & Mentoring Program, funded by the Admin. for Native Americans from 2019 - 2022, provided an after-school and summer career exploration training program in the areas of marine biology, water quality testing, archaeology and traditional stewardship practices of the Ahupua'a system.

Mālama 'Ae Kai Project is a partnership with Jean-Michel Cousteau and the Ocean Futures Society to help restore marine ecosystems and living shorelines at Ka'ehu Bay. This is a 3-year partnership started in July 2022, with a site visit. The Mālama 'Ae Kai Program will implement a community-based, socio-ecological program that will utilize community volunteers, students and youth, and interested individuals to restore the marine ecosystem at Ka'ehu Bay. The community volunteers will work directly with the marine biologists, oceanographers, water quality testing specialists, and cultural experts for hands-on learning in data collection, testing, analysis and assessment and restoration of the 64-acre coastal wetlands and shoreline.

KA'EHU will continue working with cultural practitioners, consultants and specialists knowledgeable in shoreline restoration:

The Long-term Project Goal is to restore the living shoreline of Ka'ehu Bay to its' optimal health.

#### 2. Facilities

The Paukukalo Coastal Wetlands, aka Ka'ehu Bay, is owned by the County of Maui and KA'EHU has the right of entry. The 64-acre coastal wetland includes the Wailuku River, the Waichu Stream, ¼ mile of shoreline, along with streams and underground springs, 40+ archaeological/cultural sites, ancient taro patches, and an ancient fishpond. A small portion of this area, approximately 2-4 acres are being used as an outdoor classroom and educational space.

The outdoor classroom includes storage for supplies, 2 portable toilets, 2 hand-washing stations, 3 outdoor showers, and a tent-area with tables and chairs.

#### 1. Proposed Staffing, Staff Qualifications, Supervision and Training

Executive Director Kahulu Maluo-Pearson will be responsible for the oversight of the program, Maluo-Pearson has been managing KA'EHU since 2021 and implementing the Ka'ehu Youth Enhancement & Mentoring Program, the Community Environmental Stewardship Program, and the Mälama 'Ae Kai. She is also coordinating the Maui Police Department KALO Family and Youth program along with other culturally-grounded educational workshops for community organizations.

Mālama 'Aina Specialists Hanoa Pua'a-Freitas and Jess Nathensen have been working with scientists and cultural practitioners over the last 3 years in help with data collection practices and reporting. They will continue to do water quality testing, invasive species removal, sedimentation discharge studies, and fish monitoring and surveys throughout the project.

Director of Sustainable Planning Ku'uleinani Maunupau handles all of the grant reporting, oversight and alignment, and project development. She has extensive experience managing projects and programs and has been with KA'EHU over the last 6 years.

The Land Restoration Manager will have extensive experience in landscaping, native flora and fauna management, oversight of the land restoration team, and will work with the Executive Director in the planning and implementation of the land restoration program.

The Land Restoration Assistants must have experience in landscaping and traditional land stewardship practices and is willing to work outdoors in the sun with hot and windy conditions.

The Program Manager & Project Coordinator are currently implementing the Community Environmental Stewardship Program and works well with youth, teachers and community volunteers.

All of the staff will attend Professional Development Training courses in data collection in :

- A) Marine Biology: Fish surveys and monitoring, coral surveys and monitoring
- B) Marine Biology: Plastic Marine Debris Removal, Sort & Weigh
- C) Water Quality Testing
- D) Sedimentation Discharge Study
- E) Invasive Species Removal mongoose/rats


