Ko`olauloa Health Center (KHC) is recognized by the IRS as a 501(c)(3) nonprofit, since its inception, the health center is solely dedicated to providing quality primary medical, dental, behavioral and pharmacy services to the Ko`olauloa region.

In 2022, KHC approached a landowner to inquire whether the landowner's property was available to purchase. After several months of communications, both parties have entered into a non-binding agreement for a parcel of property in the region. The purchase agreement is being drafted and will go through review in the near future. It is KHC's intent to move forward with the purchase as the board of directors has approved the purchase. KHC plans to use this property for a new health center including facilities for patient and community use.

II. Background and Summary

1. A brief description of the applicant's background

Ko`olauloa Health Center was designated a Medically Underserved Area the Health Resources and Services Administration in 2003. The health center started in a trailer on the old sugar mill site and later purchased its Kahuku location. The health center saw the need to serve patients closer to Hau`ula and is currently renting commercial space at the Hau`ula Kai Shopping Center. Hau`ula has one of the largest per capita Native Hawaiian populations. In 2013, KHC open Hawaii's first school-based health clinic at Kahuku High and Intermediate School which has since been named the Red Raider Health Center. Since the start of the pandemic in 2020, that site has been closed and KHC is collaborating with the principal to assist the DOE's nurse assigned from the Hawaii Keiki Program

2. The goals and objectives related to the request.

KHC has been challenged with revenue generation since the pandemic due to decrease in patients and encounters. The Hau`ula location's commercial rent is over \$7,000 per month and space is limited with very little room for current needs. We have reached capacity. With the purchase of the property, KHC is planning to renovate current space within that facility by converting a portion of current space to clinical exam rooms. Other maintenance repairs may be needed as the facility has not been used for several years.

In addition to clinical space and office space. The facility has a kitchen which KHC plans to use as a certified commercial kitchen. As part of KHC's health initiative, the facility includes a large storage space. KHC plans to do basic renovations and purchase exercise equipment. The region lacks a fitness facility that is readily available to KHC patients and the community.

3. The public purpose and need to be served.

The purpose of this request is to allow KHC to renovate the property and convert the current facility to meet the needs of KHC's primary role-to ensure the health and well-being of its patients and the community. Our mission statement carries that message, "Improving the quality of life for all, IMUA!"

4. Describe the target population to be served; and

The 2020 census indicates that there are 22,527 residents in the Ko`olauloa region. Based on KHC's 2022 report to HRSA, approximately 48% were Medicaid patients; 26% were at or below the Federal Poverty Level. KHC patient population included approximately 38% who identified themselves as Native Hawaiian.

5. Describe the geographic coverage.

As a federally qualified health center, KHC serves the population between Kualoa to Haleiwa, approximately thirty miles of coastline.

III. Service Summary and Outcomes

KHC is seeking the GIA to assist it with renovations to the property. The project will involve upgrading plumbing to convert space to clinical space for medical and dental services. This conversion requires running water in or near the clinical rooms; upgrading ventilation to ensure proper airflow to prevent spread of COVID-19 and other airborne diseases; converting a large storage area into a fitness center; and conducting other repairs to ensure proper operations of the facility.

KHC plans to use the design build concept for its primary renovations so that the facility is operating as soon as possible.

2. Provide a projected annual timeline for accomplishing the results or outcome of the service;

The purchase agreement is currently being drafted and will take at least a month for review and negotiate any changes needed. Early 2023 will be focused on the purchase including obtaining the loans and fundraising necessary to obtain the funds for the purchase. KHC anticipates that the renovation project will most likely start near the end of 2023 and will take at least one and a half years to complete due to the permits required before construction may begin.

3. Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results; and

KHC is required to collect data on patient numbers, patient encounters and measure certain diagnostic treatments. KHC is also required to implement a quality improvement plan to monitor certain health issues like hypertension and diabetes. KHC conducts needs assessment as a federally qualified health center. KHC's board of directors and management work closely to see its projects completed in a timely and efficient manner. With the renovated property, KHC will be able to serve the community with a stand-alone facility that will have sufficient space for current and future needs.

The projects include: renovating the pharmacy; building out one portion of the facility; closing the atrium area to convert it to meeting/office space; and reconstructing the parking area.

In addition, the last three single audits resulted in no findings by the auditor.

Isabella Gary, KHC's Chief Operations Officer, holds a M.B.A., and has seen several renovation projects to successful completion, and is currently involved with the expansion/renovation of the Kahuku clinic site. She has been with KHC for over 10 years and started as a pharmacy technician.

Zachary Johnson is the Chief Financial Officer and is the newest member of the executive team. Mr. Johnson is a C.P.A. and graduated from BYU-Hawaii with an accounting degree.


