MAPA's Performing Arts Education programs will benefit 10,000 people in FY24.

Maui Academy of Performing Arts (MAPA) has a rich history of providing educational performing arts programs in service to its mission of *enriching individuals*, *building community and connecting our world through the performing arts*. From humble beginnings as an after-school drama program in 1974, MAPA has grown into one of Hawaii's largest nonprofit performing arts organizations. Since its inception, MAPA has served more than one million participants spanning three generations. MAPA's highly acclaimed programs include:

Uncommon Stages Theatrical Productions

MAPA produces high-quality theatrical productions performed across the island of Maui, from intimate and immersive pop-up performance venues to large traditional theatrical venues.

Academy Classes & Camps

MAPA is highly regarded for its performing arts classes for all levels and ages, from keiki to kupuna, offered throughout the year. Students ages 5-18 also participate in fall, spring and summer break camps. Programs culminate in informal sharings and theatrical performances.

K-12 Classroom Residencies

Taught by professional teaching artists in public school classrooms, MAPA's performing arts residencies integrate with the schools' curricula to enhance reading comprehension and speaking skills through drama.

- Theatre for Young Audiences Educational Theatre Tour
 MAPA brings live theatre directly into Maui's preschools and elementary schools.
- Community Engagement Programs

MAPA provides performing arts programming throughout the community designed to engage residents and visitors with activities such play readings, poetry slams, post-show talkbacks, and book club programs that bring literature to life by exploring stories through the eyes of an actor.

In addition to the programming, MAPA is also currently renovating two buildings in the heart of Wailuku to create the Main Street Arts Project, a comprehensive performing arts campus with classrooms, rehearsal studios, production facilities and a state-of-the-art black box theatre. The Main Street Arts Project houses MAPA's Performing Arts Education Programs.

2. The goals and objectives related to the request;

The goals of MAPA's Performing Arts Education Programs are to:

Provide access to performing arts activities both during and after school
for students from all economic backgrounds. Research shows that lowincome students who are highly involved in the arts are twice as likely to
graduate from college as their peers with no arts education
(https://www.arts.gov/sites/default/files/Arts-At-Risk-Youth.pdf, p. 11.) In addition,
students with high arts participation rates and low socioeconomic status have a

4% dropout rate—five times lower than their low socioeconomic status peers. (https://www.arts.gov/sites/default/files/Arts-At-Risk-Youth.pdf, p. 14.)
By offering arts education programs to all Maui schools, including Title I schools, MAPA provides opportunities for students from every economic circumstance to build the skills that will help them lead healthy, productive lives.

- Build a robust community through the arts. Community members of all ages
 develop life skills like communication, collaboration, and empathy through
 MAPA's educational programming. These skills benefit the participants
 individually and enhance their capacities to contribute to shaping a stronger,
 more connected community.
- Leverage the Performing Arts to Revitalize Wailuku. As a cornerstone of the burgeoning Wailuku Arts District, MAPA's Main Street Arts Project and the diverse arts education programs housed in MAPA's facilities foster a cross-pollination of educational and performance opportunities that attract more Maui residents and visitors to Wailuku, generating additional economic activity in town.
- 3. The public purpose and need to be served;

MAPA's Educational Performing Arts Programs fill the need for access to high-quality performing arts classes and camps for participants of all ages, ethnicities, and abilities in order to enrich and strengthen our community. In addition to building skills in the performing arts, the program also enhances life skills like empathy, self-esteem, confidence, teamwork, perseverance, creativity, self-discipline and leadership.

The public purpose is twofold:

- a. The programs provide community access to high-quality educational performing arts experiences that enrich and strengthen our community. Experiences in the performing arts nourish the qualities that contribute to a thriving community -- empathy, creativity, collaboration and innovation. By helping us grapple with complex and ambiguous ideas, the performing arts teach us how to find meaning in our complex world and visualize new possibilities for the future of our community. Last year, the World Bank issued a strong call to communities around the world to include the arts in their pandemic responses: "Arts and culture offer critical tools for narrative expression, community engagement, and creating experiences of collaboration. This helps post-crisis communities generate a collective capacity for heating, resilience, and social cohesion."
- b. The programs contribute to **diversifying Maui's economy by deepening capacity in Maui's creative arts industry**. Strengthening this industry has both short- and long-term benefits. Immediately, the program retains and creates jobs in the creative arts sector, helping to diversify our tourism-dependent economy. Long-term, by developing flexible and creative thinkers, the program contributes to a future local workforce capable of thriving in an ever-changing global economy. The skills participants gain through participation in the performing arts such as creativity, communication, and collaboration enhance their capacities

to be effective in the workplace, whether they work in the creative industries or any other field.

4. Describe the target population to be served;

The target population served by MAPA's Performing Arts Education Programs reflects the diversity of Maui's population as a whole. From creative movement classes for three-year-olds to the kupuna acting program, MAPA's educational programming attracts a wide cross-section of Maui residents and visitors of all ages, ethnicities, abilities, and economic circumstances.

5. Describe the geographic coverage.

MAPA's Performing Arts Education Programs serve every corner of the island of Maui, including the remote town of Hana.

III. Service Summary and Outcomes

The scope of work for MAPA's Educational Performing Arts Programs includes designing curriculum, securing funding, scheduling, ensuring appropriate staffing, registering students, teaching, and evaluating each program upon completion. Specific tasks and responsibilities for each program include:

Academy Classes & Camps

- Artistic Director and Executive Director work with Teaching Artists to design curriculum reflecting MAPA's artistic and educational philosophies.
- Executive Director and Director of Programs hire and train new teaching artists.
- Director of Programs and teaching artists collaborate to create schedules for each term that best serve the needs of the families and MAPA.
- Director of Programs sets up and executes online registration system for each class and camp through JackRabbit Technologies.
- Executive Director works with scholarship committee composed of Board and community members to award needs-based scholarships.
- Marketing Director designs and executes the marketing plan to promote classes and camps through social media, email, print ads.
- Director of Programs communicates with students and their families about logistics such as studio location, parking, etc.
- Teaching Artists teach the classes and camps.

- Teaching Artists prepare students for end-of-the-term sharings and performances.
- Production teams prepare sets, costumes, props, and lighting for the camps that culminate in a full production of a musical or play.
- Director of Programs and Executive Director design and implement postprogram evaluations that include feedback from students, families, and Teaching Artists. Information gleaned from the evaluations is used to design adjustments to the programs in the future to best meet the needs of the participants.

• K-12 Classroom Residencies

- Executive Director works with Teaching Artists and classroom teachers to design the curriculum for each residency to ensure learning objectives in both the arts and language arts are embedded in the lesson plans and unit plans.
- Executive Director hires and train new Teaching Artists.
- Director of Programs works with school administrations to schedule residencies.
- Teaching artists conduct the residencies in school classrooms.
- Teaching Artists teach professional development workshops for classroom teachers to share arts instructional strategies for the teachers to utilize after the residency.
- Director of Programs and Executive Director design and implement postprogram evaluations.

• Theatre for Young Audiences – Educational Theatre Tour

- Artistic Director, Executive Director, and Director of Programs identify annual theme for the program reflecting topics currently relevant to students ages 3-12 (for example: friendship, bullying, diversity, etc.).
- Artistic Director hires local playwright to write an original script reflecting the theme with age-appropriate humor and language.
- o Artistic Director hires local musicians to write original music.
- Artistic Director casts and directs the show.
- Marketing Director designs and executes a marketing plan to promote the show to preschools and elementary schools.
- Director of Programs works with school administrators and teachers to schedule the performances.
- Actors rehearse and perform the show in schools across Maui.
- Director of Programs and Executive Director design and implement postprogram evaluations.

• Community Engagement Programs

- Director of Programs works with local artists to book events in MAPA's Living Room, a pop-up performance venue in the heart of Wailuku, such as poetry writing workshops, poetry slams, improv shows, play readings, etc.
- Artistic Director and Executive Director host talk-backs following select productions in MAPA's Living Room to explore the themes, artistic processes, and more with audience members.

- Executive Director designs and teaches artistic literacy workshops for local book clubs. Sessions are scheduled to coincide with any MAPA plays and musicals that are based on literature. Participants explore the story through the eyes of an actor to better understand character motivations and intentions with the goal of deepening and enriching their experience as audience members when they see the shows.
- All Community Engagement Programs are offered to the community free of charge.

MAPA is seeking funding to complete its \$14.2 million capital campaign for the Main Street Arts Project in FY24. (92% of the funding for the Main Street Arts Project has been secured.) In addition to a grant-in-aid CIP request for equipment for the black box theatre, MAPA is also seeking funding from private philanthropic sources to complete the capital campaign.

For MAPA's educational programming in fiscal year 2024, MAPA has secured \$37,500 in grant funding for the programs to date and will seek additional private philanthropic funds. Program fee revenues (\$160,000) are expected to cover remaining expenses not covered by this grant-in-aid request.

With 49 years of experience providing successful performing arts education programs on Maui, MAPA is highly qualified to implement the programming related to this request. Staff leaders have a combined 128 years of experience in arts education. With a master's degree in Theatre/Directing, David Johnston has worked in the field for 50 years. Carolyn Wright has a master's degree in education and has worked as an arts educator for 37 years. Hoku Pavao has a degree in musical theatre and a decade of experience as a performer, teaching artist, and director. Kathleen Schulz, MAPA's lead teaching artist has 30 years of experience teaching dance and drama at MAPA. MAPA's roster of part-time teaching artists are highly trained, and each has at least 10 years of experience in the field.

Related performing arts education projects over the past 3 years include:

2020

When the pandemic hit in March 2020, the following education programs were in full swing:

- Academy Classes and Camps: MAPA provided 103 dance and drama classes with an enrollment of 1,500 students per week. During the shut-down, MAPA pivoted to online dance and drama classes with a schedule of 25 classes per week due to reduced demand. Two 2020 Spring Break Camps were fully enrolled: Make Believe Camp (dance camp for ages 3-5) and Shining Stars Camp (drama camp for ages 5-12), however, the pandemic forced the cancellation of these camps. MAPA offered a Summer Theatre Camp on Zoom for ages 8-18 that culminated in an online performance of original monologues and scenes written by the students called Still We Will Love.
- K-12 School Residencies: In the 2019-20 school year, MAPA's professional teaching artists conducted residencies in the following schools: Wailuku Elementary, Haiku Elementary, Pomaikai Elementary, Hawaii Technology Academy Maui Campus (elementary and middle school), Montessori School of Maui (elementary and middle school), and King Kekaulike High School. The program served 2,781 students.
- Theatre for Young Audiences Educational Theatre Tour: When the pandemic hit, MAPA had just concluded a tour of the original musical Birds of a Feather written by Maui playwright Kathy Collins. With the theme of respecting differences and celebrating diversity, the show was seen by 7,532 students and 382 teachers in 36 Maui preschools and elementary schools.

2021

Due to the ongoing pandemic, MAPA's educational programming was limited in 2021.

• K-12 School Residencies: MAPA provided both in-person and Zoom residencies in the following schools: Wailuku Elementary, Hawaii Technology Academy Maui Campus (elementary and middle school), Montessori School of Maui (elementary and middle school), and King Kekaulike High School.

• **Academy Classes and Camps:** MAPA offered the Kupuna Acting Class on Zoom throughout the year, culminating in a video of original monologues written and performed by the kupuna called *Brave Acts*.

2022

- Academy Classes and Camps: MAPA's dance and drama classes returned to in-person programming in newly renovated classrooms in Wailuku. The program served 462 students and their families in 2022. MAPA's camp programming served 212 students in 11 five-day camps during spring, summer, and fall breaks and a six-week Summer Musical Theatre Camp culminating in a production of Shrek The Musical performed by students ages 8-18.
- K-12 School Residencies: MAPA's school residencies served 1,205 K-12 students at the following Maui schools: Wailuku Elementary, Hawaii Technology Academy Maui Campus, Montessori School of Maui, and King Kekaulike High School
- Community Engagement Programs: MAPA's Living Room, an intimate pop-up performance venue in Wailuku, began hosting new free community engagement programming with two poetry events in 2022, a writing workshop and a slam.

2. Facilities

MAPA owns three buildings in the heart of Wailuku, two of which currently comprise MAPA's Main Street Arts Project. The facilities provide ample space to conduct MAPA's Performing Arts Education Programs:

- 2027 Main Street MAPA purchased the former National Dollar Store property in 1998 and is currently renovating the building into a new black box theatre with lobby, dance and drama studios, dressing room, restrooms, and support spaces.
- 2050 Main Street Known as MAPA's Promenade, this property was purchased by MAPA in 2016. The three-story structure contains 27,888 square feet, two thirds of which is used by MAPA for classrooms, offices, and storage.
- 2020 Main Street This parcel includes a retail/warehouse building built in 1924 and a concrete parking lot with 17 stalls. Due to its deteriorated condition, the building is currently used only as storage. Future plans for this property include renovations to build a scenery/prop workshop and costume storage.

The project is led by MAPA's Artistic Director David Johnston and Executive Director Carolyn Wright, who have successfully created and administered in-school and after-school arts education programming on Maui for the past 30 years. With Johnston directing the artistic components of the program and Wright overseeing the curriculum development, pedagogy, and teaching artist training, MAPA's education programs provide in-depth arts education experiences designed to empower each student to find and develop their own unique creative voice. MAPA's administrative staff are among the most experienced arts educators in the state and are highly capable of supervising, training, and providing administrative direction for MAPA's arts education programs.

The programs are administered day-to-day by Director of Programs/Assistant Artistic Director Hoku Pavao. Born and raised on Maui, Pavao has worked in MAPA's education administration department for the past decade, efficiently managing the registrations, scheduling, scholarship programs, and more.

The front line of MAPA's education programs are the highly trained corps of teaching artists who plan and teach age-appropriate classes in alignment with the organization's artistic and educational philosophies. While simultaneously building performing arts skills and fostering individual creative expression, the programs also develop life skills like communication, collaboration, and leadership. MAPA is proud to provide programs intentionally designed to develop what choreographer Alonzo King calls "masterpieces of humanity." The teaching artists are skilled in creating quality learning experiences using effective classroom management strategies and varied instructional techniques that meet the diverse needs of all types of learners.

The applicant shall provide a plan for sustaining after fiscal year 2023-24 the activity funded by the grant if the grant of this application is:

- (a) Received by the applicant for fiscal year 2023-24, but
- (b) Not received by the applicant thereafter.

After the pandemic paused a significant portion of MAPA's programming for almost two years, the rebuilding process has proven to be slower than originally anticipated. This grant request is projected to be a one-time request to bridge the short gap until MAPA's new black box theatre opens in 2024. As the centerpiece of MAPA's Main Street Arts Project, the theatre is expected to generate additional revenues in ticket sales, tuitions, and contributions that will supplement the education programming revenue to meet the overall fiscal needs of the organization.
