II. Background and Summary

1. A brief description of the applicant's background;

The Maui Family YMCA was organized in August 1960 out of an office in Wailuku. With startup funding from the local community, the first camp on Maui was opened in 1962.

The Y managed the initial facility construction at our current location in 1991 with an additional expansion in 1994. Additional capital improvements including a swimming pool and 2008 major facility renovations were all completed successfully.

Maui Family YMCA is open to everyone in the community regardless of their ability to pay. The Y focuses on providing services to the community and a place where the essence of community lives through Healthy Living. Youth Development. and Social Responsibility.

During the pandemic, the Y was able to quickly pivot our services. The Y provided blended learning centers at three locations in Central Maui, Upcountry, and South Maui and at the Y facility. The Y became a food distribution center and launched a program that gave out over 6,000 starter plants to encourage home-based edible gardens.

Today, Maui Family YMCA operates a full range of fitness and healthy living programs at our facility including workout facilities, a racquetball court, swimming and swimming classes, yoga, pilates, latin dance, RIPPED, TRX Training, Hula Fitness, martial arts, and Parkinson's fitness. The Y also runs after-school programs at five Maui elementary schools and intercession camps throughout the year at the Y facility.

The Y works with intention to continue to provide high quality services and programs for Maui's expanding needs.

2. The goals and objectives related to the request;

The goal of this request is to increase the health and fitness of the community, to re-establish lost connections and feelings of isolation created during the pandemic, and to educate our children on the importance of agriculture and food sustainability.

The Y will accomplish these goals by again pivoting in a new direction in response to the needs of the community. Building a multi-purpose covered children's pavilion will increase our total facility space by 25%. The pavilion will be at the heart of the Y's spring, summer, fall and winter camps and increase our camp capacity by 40%. Students will gather for fitness programs, arts and crafts, music classes and other group activities.

The surface of the pavilion will accommodate two pickleball courts. These courts can be used by students at camp and by our community members every day. Pickleball is the #1 growing sport in the country and is a sport for all ages and a sport that all ages can play together. The pavilion can also be used for any fitness program such as yoga, pilates, hula fitness, Parkinson's fitness, martial arts and more providing a covered, open-air alternative to inside classrooms.

Surrounding the children's pavilion will be the farming program and the farm education space. The farm education space will be created by renovating an existing permitted 20 ft. container into an office and covered classroom area. This will be the hub of the farming project where the Wellness/Farm Director will manage volunteers and hold classes for all ages with an expanding curriculum as the farm progresses.

The farming program. Farm the Future was launched in 2021 with funding provided by Red Cabin Foundation and a partnership with Grow Some Good. The initial phase of the project was completed in 2022 which included planting the first edible garden. creating additional farm plots, and building 17 raised garden beds. The first Y farm camp was held in December 2022 where students learned about the plants and soil, weeded, harvested and even prepared food from the garden.

The raised beds will be available to community members and volunteers, allowing individuals and families who do not have outside space the opportunity to plant, grow and harvest their own food. The expanding farm plots will be planted with Grow Some Good and other partners, and Y volunteers. The long-term collaboration between Maui Family YMCA and Grow Some Good is evolving to assure sustainability and volunteers from both organizations will maintain the farm when camp or classes are not in session. All food produced will be made available to the community.

3. The public purpose and need to be served;

The pandemic highlighted many existing issues and created some new ones. Food insecurity became a bigger problem. The sense of belonging and mental well being suffered as we all became more isolated. Physical well being declined and fitness and exercise either stopped or drastically changed.

In 2022, YUSA commissioned a study with Triangle 2 to identify the needs of members post-pandemic. Data was collected and analyzed from a national survey of over 66,000 members. The study found that "In the minds of consumers." wellness" now encompasses a whole lot more than just being in shape. It's reducing stress. It's finding a sense of community and belonging. It spans mental, physical, and spiritual dimensions—and consumers actually prioritized mental wellness above them all."

Notable statistics from the study include: 55% of members want adult programs and exercise to be outdoors or in a covered open-air space; 54% want outdoor activities and programs for children. Of the most important needs of children post covid: 62% of respondents said a sense of belonging: 59% said a return to play and socializing with others. 68% said the most important learning for children are STEM (science, technology, engineering, mathematics) skills.

The Y's children pavilion expands the capacity to provide fitness and learning programs in an open-air environment at a space that will serve multiple purposes.

The decision to create two pickleball courts in the pavilion is intentional. Data from the Sports & Fitness Industry Association shows the generational breadth of pickleball's popularity. Approximately 21% of the sport's more than 4.8 million participants in 2021 were between 6 and 17 years old. Close to 30% were between 18 and 34, with another 20% between 35 and 54 and another 30% ages 55 and up. The Y believes not only in

fitness but in a strong sense of community and pickleball is a unique sport because it is a group activity in which different ages can play together.

Food insecurity is a real issue in Hawaii. Statistics from the non-profit organization Feeding America cite 1 in 10 people and 1 in 6 children in Hawaii face hunger. Community gardens are a key component of sustainable living and a key factor in making Hawaii more food secure.

Additionally, instructional school gardens convey an array of benefits that include promoting healthy eating habits among children, upping physical activity, increasing awareness of STEM (science, technology, engineering, mathematics) concepts and ultimately enhancing academic achievement, according to the National Farm to School Network.

The Y's farm and education project is designed for the long term. Additional classes and services will evolve naturally as the gardens and farm plots mature and more people go through the program. Farm the Future will become the model for sustainable agriculture that the entire community can participate in and enjoy.

4. Describe the target population to be served; and

The Maui Family YMCA serves all regardless of age, income, gender, gender identity, sexual orientation, housing status, ethnicity and religion. In 2022, 15.5% of Y members and participants were awarded scholarships of financial assistance for Y services and programs.

5. Describe the geographic coverage.

The Maui Family YMCA serves members and participants from its facility located in Central Maui, and provides after school programs in Central. South and North Maui. The geographic composition of Y members and participants is; 70% Central, 10% Upcountry, 7% South, 6% North Shore, 1% West and 6% out of state.

III. Service Summary and Outcomes

The Maui Family YMCA is working with professionals to finalize the architectural plans. obtain the necessary permits for construction. The scope of the work is the construction of a multi-use children's pavilion of approximately 4.500 square feet including the installation of two pickleball courts, the renovation of an existing permitted container converting it into an office and covered education space of approximately 320 square feet, the installation of approximately 1.500 feet of fencing around the area, and the complete installation of existing farm plots including additional soil and starter plants.

The Maui Family YMCA CEO will serve as the project manager responsible for the project completion.

The cost of Phases I - III of the project is estimated at \$650,000.00 with funding coming from State and private individuals and foundations. The Board of Directors and CEO will be responsible for raising the additional funds from County and private individuals and foundations.

The Maui Family YMCA CEO will act as the project manager. All expenses will be reviewed by the CEO and the Facility Committee, and ultimately approved by the Board of Directors. Progress will be monitored by the CEO and Progress Reports will be submitted at least monthly to the Facility Committee and Board of Directors. Additional resources, including YUSA, will be consulted as needed.

The Maui Family YMCA has a proven track record with its programs and services since it opened in 1960. These services include a wide variety of fitness training and classes. an aquatics program that ranges from beginners to experts and serves all ages, and wellness programs educating on the benefits of overall health. The Y has 81 employees, both full-time and part-time, and utilizes both local resources and YUSA programs for training and professional development of all staff.

In addition to the wide range of services offered at the Y facility, Maui Family YMCA currently is contracted by the Department of Education to administer the A+ after school program at 5 Maui elementary schools.

The Maui Family YMCA has successfully completed multiple construction and renovation projects at the current site. The Facilities Committee is composed of leadership and volunteers knowledgeable in the construction industry. Maui Family YMCA also has access to the resources of YUSA with over 170 years of experience and 2,800 facilities nationwide.

2. Facilities

The applicant shall provide a description of its facilities and demonstrate its adequacy in relation to the request. If facilities are not presently available, describe plans to secure facilities.

The Maui Family YMCA original building was constructed in 1991 as a fitness center including locker rooms and staff office. An additional building was constructed in 1994 that expanded the fitness facilities. Today the facility consists of over 16,000 sq. ft. of inside facility space, an outdoor pool and two storage containers.

The funds requested will provide a much needed outdoor expansion with the addition of a covered children's pavilion. The pavilion will serve as the center for spring, summer and fall student camps. Any Y fitness or wellness program can utilize the space when

available and the pavilion will be surfaced with two pickleball courts making this a multipurpose space. The renovation of a storage container to an education space will increase capacity for wellness classes and serve as the hub for the farming program expansion.

All current Y facilities meet ADA requirements, as will the new construction.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

Nationally, the Y has over 170 years of experience in building facilities. The Maui Family YMCA has successfully managed the construction and maintenance of the current facilities for over 30 years.

Management of the project will be a partnership between the Maui Family YMCA CEO. Mike Morris, a 37 year veteran with the Y, Y USA, the Facility Committee that includes contractors and construction specialists, and Grow Some Good. a 501(c)3 organization. Grow Some Good will assist in the development of the edible gardens and will be a partner with the Y in the long term sustainability of the farm program.

In addition to the existing Fitness Coordinator and Youth Director, the project will create 1 full-time position with the hiring of a Wellness/Farm the Future Director to manage the farming project, expand the Parkinson's program and implement new wellness programs like diabetes prevention and management, arthritis care, and healthy food education and preparation. The project will create 8 part-time positions and 24 volunteers to service the programs and maintain the farm space and edible gardens.

It is estimated that the project will result in a 35% increase of total members and participants within the first year of completion and grow to 45% as the farming project matures.

A major component of the project is the construction of the children's pavilion. This structure, along with the renovated education space, will allow the Y to expand the capacity for student camps by 40% from current levels. When not being used for student camp, the pavilion will be used as two pickleball courts. With the popularity of this sport, the Y will have an increase in revenue from an estimated 35% increase in membership as well as a new revenue stream from pickleball classes.

The Maui Family YMCA, in collaboration with Grow Some Good, will recruit a volunteer group to maintain the Farm the Future program. This group will be responsible for ongoing upkeep of the garden areas including weeding, pruning, harvesting, soil maintenance and replanting.

The volunteer group will include individuals and families who work their own garden plot and share responsibilities for the common farm plots and student education gardens. Collaboration between the parties will ensure that the farm will continue to thrive between student learning camps. The collaborative group will also evaluate options for additional program initiatives including food preparation. food distribution and the basics of running an agriculture-based business as the gardens mature.

Revenues generated from increased membership, student camps, public and private donors, and in-kind partnerships will be used to continue the work into the future.

The very nature of the project is sustainability. Revenues from increased membership, student camps, expanded classes and projects, public and private donors and in-kind contributions will keep the children's pavilion and education space maintained. The established volunteer group will maintain the farm plots and keep the gardens growing.
