## 3. Public Purpose

The Special Education Center of Hawaii (SECOH) requests capital support for the public purpose of providing individuals with disabilities with education, job training, recreation, community integration activities, and skills to develop independence and improve their quality of life. This purpose is in compliance with Section 42F-102, Hawaii Revised Statutes.

## II. Background and Summary

### 1. A brief description of the applicant's background;

The Special Education Center of Hawaii, dba SECOH, (SECOH) is a nonprofit organization founded in 1965 with the mission to provide personalized services to individuals with disabilities in the spirit of enriching their lives. Our vision is for all people to be valued and treated with dignity and respect.

SECOH began as a school for children with special needs, and expanded in the 1980s when Waimano Home was deinstitutionalized, and many of their residents were admitted to SECOH for care. Today we continue to serve approximately 80 of these individuals, now age 50 to 70, with Adult Day Health (ADH) services.

In 2015 SECOH expanded with the establishment of the Pathways Program to address the demand for services to the population of young adults with disabilities that are aging out of the Hawaii Department of Education (DOE) public schools. SECOH currently serves 65 adults in the Pathways Program with 36 adults currently on the admission waitlist.

Services provided by SECOH through DOH DDD contracts include:

- ADH at DH provides group activities for seniors and older middle-aged adults. (44 enrolled; 18 waitlisted) These clients require more intensive services and support to keep them socially, physically, and mentally engaged. Without ADH, they would have little or no interaction with peers, and many would lack any community integration opportunities.
- ADH PATHWAYS at DH and SALC serves young adults that have recently aged out
  of the public school system. Pathways DH currently has 53 clients enrolled (10
  waitlisted) and SALC has 28 enrolled (17 waitlisted). Pathways clients are more
  capable, and many have the potential of developing life and job skills and
  participating in community activities such as volunteering.
- **Personal Assistance Services (PAB)** SECOH provides individualized services designed to improve self-help and independence skills.
- **Community Learning Services (CLS)** SECOH provides individualized services to improve skills necessary for community integration.
- Respite SECOH provides respite to families that are caregivers of individuals with disabilities.

### 2. The goals and objectives related to the request;

**Goal:** This project will increase SECOH's capacity to serve more clients and also expand its array of life and job skill-building activities.

**Objective 1: Senior dining room.** Currently SECOH serves seniors in a single room where they engage in social and recreational activities and eat their meals. This project will create a dedicated senior dining room out of a space that was vacated 10 years ago

and is currently unsafe and unusable. A senior dining room (674 sq ft) will be created in an unused space. SECOH currently serves 12 seniors and has a list of 18 seniors for the ADH program at DH.

**Objective 2: Program spaces.** The interior of the Administration Building will be reconfigured to create two "great" rooms for group activities and a conference/meeting room, and an exterior patio will be created for outdoor group activities. These spaces will enable SECOH to address the wait list of 10 individuals for the ADH Pathways program at DH.

**Objective 3: Job training center.** A new job training center will be created in the Administration building and enable SECOH to provide new Independent Employment Supports (IES) and Discovery & Career Planning (DCP) services, both Medicaid Waiver job skill-building programs.

**Objective 4: Pool house.** The plumbing, electrical, and lighting systems will be updated. SECOH has one of the few swimming pools on the island specifically constructed for individuals with disabilities: it has a ramp into the water so that individuals may walk into the pool; and those who use wheelchairs may remain seated in a water chair and pushed down the ramp and into the pool.

## 3. The public purpose and need to be served;

State priorities – SECOH provides services that are a priority of the Department of Health, Developmental Disabilities Division (DDD) strategic plan goals, which states individuals with disabilities: have opportunities to receive quality services in the most integrated settings, engage in community life, and control personal resources; have opportunities to seek employment; and quality person-centered planning, services and supports are avaiilable for participants to live full lives in the community and have greater opportunities for self determination.

**Need to among individuals with disabilities** - Recreation, employment, and community integration for individuals for disabilities are services are the core services of SECOH. These activities are also evidence-based methods that improve the quality of life of our clients. By enhancing and improving our programs, we are able to better individualize our services to meet the needs and interests of each client. Development of job and volunteer skills will enable our clients to better integrate into community activities, and also fosters a sense of purpose and achievement.

There is a shortage of services on Oahu for the target population of adults with disabilities. SECOH is only one of two service providers in East Honolulu, both working at capacity. However, there are some communities on Oahu where there are no choices or unacceptable choices for families. As a result, SECOH serves clients from Hawaii Kai to Kapolei, including Waimanalo, Kailua, and Kaneohe. They are willing to travel to the Diamond Head campus because of the quality of SECOH's programs. The current wait

list for services is 29, most of them are young adults that recently aged out of the Hawaii public school system.

**Need and impact on families** - Services not only improve the independence and quality of life of persons with disabilities, but also improve the quality of life of their family. Many of the families we work with are vulnerable to caregiver burnout, and for most of our families, SECOH services are also provide economic benefit. If services were unavailable, they would be required to be caregivers, and unable to retain gainful employment to support their household.

*Impact on the community-at-large* - Services to persons with disabilities positively impact the community at large: assisting them to be independent and reach their greatest potential will reduce or prevent the need for more intensive levels of care, such as institutionalization.

### 4. Describe the target population to be served; and

**Current clients of SECOH** - SECOH currently serves 184 and has a wait list of 45 adults with disabilities that are not receiving any services. Our clients have physical and cognitive disabilities including Down's syndrome, Autistic Spectrum Disorders, Cerebral Palsy, developmental disabilities, and other conditions that require specialized support. They range in age from young adults that recently aged out of the public school system to seniors up to age 85. Their skills span a wide range:

- Communication 46% are verbal; 15% are partially verbal; 20% are non-verbal; and 17% use another form of communication; and 2% sign or use a communication device.
- Mobility 62% walk on their own; 17% are wheelchair bound; 18% walk with assistance; and 3% use a walker or gait belt.
- Independence 33% require line of sight supervision; 20% require 1:1 supervision; 16% must never be left unattended; 11% require arms-length supervision; 13% require assistance or supervision for personal care; and 6% require assistance for everything.

Job training services to a gap group of individuals with disabilities. This renovation project includes creation of a new job and life skills training center. This new resource will enable SECOH to serve a gap group of adults with disabilities that are capable of developing job skills but require more time and support than they receive from other job training programs. These clients are able to learn job tasks, however, they have difficulty meeting the demands of a typical job in the general public. For example, one client of SECOH's is able to successfully complete her job responsibilities but has been through five different employers. SECOH's IES and DCP Medicaid Waiver services will provide these clients with the opportunity to learn job skills in the safe environment of the SECOH campus, along with skilled SECOH staff. New DCP services will help individuals to complete a career plan and develop the skills needed to be employed; while new IES services will include job coaching, working with employers, and other supervisory activities.

Pool house serves SECOH, Variety School, and the ARC of Hawai'i. This project requests funds to renovate pool house. SECOH has a pool that is used by clients from both locations on Oahu, students from Variety School (a nonprofit school for 20-25 children with learning disabilities), and clients of from the ARC in Hawaii (a nonprofit residential and day health program for 40-50 adults with disabilities). On the weekday evenings and weekends, it is used by Leahi Swim School, a program that serves approximately 300 children on Oahu. The pool is the only recreational pool on Oahu that was specifically constructed for individuals with disabilities.

**Future clients of SECOH** - There is a growing need to increase services to individuals with disabilities, as the number of young adults with special needs is outpacing the inventory of programs and slots currently available. Renovations will enable SECOH to meet the current and growing demand for services for adults with disabilities.

### 5. Describe the geographic coverage.

SECOH serves individuals with disabilities that reside on the island of Oahu.

## III. Service Summary and Outcomes

## 1. Describe the scope of work, tasks and responsibilities;

This project will increase SECOH's ability to serve more clients, and expand its array of life and job skill-building activities. Outcomes include:

**Outcome 1: Senior dinnng room**. A 674 sq ft dining room will be created in an unused space. SECOH currently serves 12 seniors, and has a list of 18 seniors for the ADH program at DH.

**Outcome 2: Program spaces.** The renovation will create new spaces that increase the capacity of SECOH to serve 20-30 more clients (depending on the intensity of each client's needs and available staffing). The Administration Building will be reconfigured to create two "great" rooms for activities, a small conference/meeting room, an outdoor patio, and the ADA bathrooms will be updated and improved.

**Outcome 3: Job training center.** A new job training center will include a "store" for ADH Pathways clients to stock and "sell" items to other clients, staff, and family members; a kitchen to practice life skills and job skills; a conference group for individualized and small group training, family meetings, and staff meetings.

**Outcome 4: Pool house.** The pool house will be renovated to update the plumbing, lighting, and electrical systems. The pool house was constructed in 1983, and since that time no improvements have been made. The structure is in dire need of improvements.

# 2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

The timeline has been scheduled in phases to minimize the disruption of services throughout the Diamond Head Campus.

Months 1 - 2: Retain contractor(s), secure renovation materials.

Months 2 - 4: Renovate space to create the senior dining room.

Months 4 to 6: Renovate the former Administration Building to create a conference/meeting room, two great rooms, and improve the ADA bathrooms.

Months 7 to 10: Create the job and life skills training center and outdoor.

Month 10: Install a new patio at the job training center for outdoor activities.

Month 11 to 12: Renovate the pool house.

Note: No permitting is required as the renovations will not change the footprint of the buildings.

- Weekly status meetings between the CEO and the contractors to go over progress and address any unanticipated challenges in the renovation and ensure that the renovation is proceeding as planned and in compliance with State of Hawaii and applicable code.
- Quarterly reports by the CEO to the Board of Directors.
- The CEO will work with the finance and accounting consultant on an ongoing basis to monitor the budget expenditures to ensure timely and appropriate distribution and reporting of funds.

### Senior dining room

Demo the four small rooms to create two great rooms.

- Install drywall, vinyl flooring, and hurricane resilient windows.
- Install wheelchair accessible trough sinks.
- Replace lighting fixtures with LED energy efficient lights.

### Program space and job training center

- Demo interior walls to create two great rooms, store, kitchen, and conference room
- Install drywall, vinyl flooring, and hurricane resilient windows.
- Improve the ADA bathrooms.
- Replace lighting fixtures with LED energy efficient lights.
- Create kitchen with energy efficient appliances.
- Build the store" with areas for sales and inventory.
- Create an exterior patio deck for outdoor activities.

### Pool house:

- The electrical system was built to applicable code at the time of construction and will be brought up to current standards.
- A solar photovoltaic system will replace the electric heating and pump system.
- The lighting system is dated and will be improved with energy efficient fixtures.
- New toilets, showers and changing areas will be installed in compliance with ADA standards.

In November 2022, SECOH submitted a proposal to the Honolulu City and County Grant in Aid program to support the Diamond Head renovation and will submit requests to several private foundations to support this project. However, most private foundations require that over 50% of the necessary funds be secured before an application is submitted. Award of a State GIA grant will enable SECOH to fulfill the requirements necessary to submit requests to private foundations.

REVENUES: SECOH requests \$300,000 of the total amount required for this project. The remaining funds will be requested from the Atherton Family Foundation. Private foundations require that at least 50% of the funding be in place before they will accept a renovation proposal, so an award from the Honolulu GIA will be leveraged to secure the additional necessary funds for the project.

All of the funds received from the Honolulu City and County Grants in Aid program will go towards the renovation. SECOH will not allocate any funds to administration or indirect costs.

**Experience providing services to individuals with disabilities** - SECOH has over 53 years of experience serving individuals with disabilities in the State of Hawaii. It has secured multiple contracts to provide services from the DOH DDD and Honolulu County DTS, and a successful track record of meeting or exceeding contract objectives.

Today SECOH has 79 employees that serve over 170 clients out of two service locations: Diamond Head and Leeward. We currently have contracts with DOH DDD to provide ADH, PAB, CLS, respite, and employment training. The current Medicaid Waiver is valid through 2025, and SECOH is committed to continuing these services in the future.

**Experience managing funds.** SECOH has sufficient funds to cover project expenses in advance of reimbursements from the State of Hawaii for this project. Finance and accounting are managed by Custom Bookkeeping Solutions, a contractor with SECOH for the past four years. ProService Hawaii manages all payroll and human resource activities, and we work with a consultant grant writer to raise the funds necessary for renovations, program improvements, and other expenses not covered by DOH DDD and Honolulu County DTS contract reimbursements for services.

**Experience completing capital improvements** – In the past three years SECOH has completed several renovations at the Diamond Head campus. Each of these capital renovation projects were completed on time, and within budget.

## 2. Facilities

SECOH has two service locations and an administrative office. All service locations are ADA compliant and have sufficient parking for visitors and the SECOH vehicles.

### Founder's Center, Diamond Head

The Diamond Head facility has four single level buildings and a pool for recreational activities. This site serves 98 individuals with disabilities through both ADH and Pathways programs.

### Sister Agnes' Leeward Center

2045 Lauwiliwili Street, Kapolei, Hawaii, 96707

The Sister Agnes' Leeward Center (SALC) is a single-story facility that was purchased and renovated in 2019. The ADH program at SALC currently serves 67 individuals with the most intensive needs.

### Kapolei Administrative Office

1001 Kamokila Blvd, Suite 136, Kapolei, HI 96707

The Kapolei Administrative Office houses all of SECOH's administrative staff.

## VI. Personnel: Project Organization and Staffing

## 1. Proposed Staffing, Staff Qualifications, Supervision and Training

**CEO experience and qualifications** - President/CEO Bridget Panee will direct this project. She has been with SECOH for 26 years, starting as a Program Instructor. In 2010 she was appointed Vice President of Operations, and in 2015 she was appointed President/CEO. In 2017 Bridget was named a Weinberg Fellow by the Harry and Jeanette Weinberg Foundation.

At the time Bridget began working at SECOH, its sole program was to care for a population of individuals that required services due to the deinstitutionalization of Waimano Home. SECOH's ADH program continues to serve 80 of these persons with disabilities, all of them older adults.

In 2014 Bridget saw the growing need for services for young adults with disabilities aging out of the DOE and created the ADH Pathways Program. To accommodate these new services, she planned and oversaw a \$125,000 renovation of 1,400 sq. ft. in three rooms on the Diamond Head Campus. Pathways was opened in January 2015, and within a short period of time, was filled to capacity. Each week SECOH receives inquiries from parents looking for an ADH program for their young adult child. There is a clear need to expand the capacity of this program.

**Responsibility for capital improvements** - CEO Bridget Panee will be responsible for this project and ensuring that the goals and objectives are met on a timely basis, and within budget. SECOH has a full-time accounting clerk, and contracts with Custom Bookkeeping to manage its finance and accounting. SECOH has worked with Custom Bookkeeping for five years.

**Supervision of capital improvements** – A contractor with experience in projects of similar size and scope will be retained. CEO Bridget Panee with work with the contractor and meet weekly to ensure the renovations proceed on time, as planned and within budget.

### 3. Compensation

The annual salary range of the highest paid managers are between \$50,000 and \$60,000. The annual salary range of the President/CEO is between \$120,000 and \$150.000.

Funds are requested for a capital renovation project. Once all of the necessary funds are secured and the renovations are completed, no further funding will be required for this project.

The renovation will contribute to the long-term sustainability of SECOH by increasing the capacity of the Diamond Head Campus to serve more persons with disabilities and extend the array of services to include job skill-building activities.

- Once the senior dining room is completed, SECOH will have the capacity to admit some or all of the 18 seniors currently on the wait list. (Note: The number of individuals that will be accomodated in the new space is dependent on the intensity of client needs, staffing, and other resources.)
- Upon completion of the job training center, SECOH will apply for approval to secure reimbursements to provide IES and DCP in the Medicaid Waiver program. This will diversify the service array and funding streams for SECOH.
- The new air conditioning system, kitchen appliances, and LED lighting fixtures will be energy efficient; new windows will improve the security of the buildings and hurricane resilience; and the trough sinks, vinyl planking, and interior walls and trim will help maintain a sanitary environment for SECOH's clients.
