served in our nation's longest war, the Global War on Terrorism (GWOT), 2001-2022, and show that numerous crisis hotlines, prevention/awareness programs and VA counseling have done little to significantly decrease GWOT veteran suicides.

This Grant in Aid request would fund an exploratory survey and study for a Global War on Terrorism Memorial and Statuary Retreat by asking GWOT veterans and Gold Star families what GWOT icons/symbols they would like to be included in the Memorial and Statuary Retreat to honor the fallen as well as provide a solemn sanctuary for veterans and families to reflect, meditate and heal.

In the past, a handful of veterans made the decisions relating to the planning, design, and construction of their war memorials decades after their war ended. It is readily apparent that GWOT veterans and Gold Star families need to honor the fallen and provide a retreat to help restore their hope and love for life. The urgency of the situation requires a full-time effort with fully dedicated resources to help the State identify the remembrance preferences of this generation of young veterans and families. There are approximately 35,000 GWOT veterans and 82,000 other veterans from previous conflicts/wars in Hawai'i. Below are the iconic images of the GWOT:



II. BACKGROUND AND SUMMARY

Organization Background: VFW Post 8616 is a 501(c)(19) nonprofit veterans organization chartered on June 3, 1984 and in good standing with the State of Hawai'i Department of Commerce and Consumer Affairs. The Post has more than 120 members who have served in a combat area or foreign theater of operation during a conflict. Some are single-tour/enlistment veterans, active-duty or retired military servicemembers. The Post is also affiliated with the Student Veterans of America at the University of Hawaii at Manoa. The Post is one of 21 VFW Posts on all major Hawaiian Islands and American Samoa with more than 4,000 members under the VFW Department of Hawaii (state headquarters). If this GIA is approved, the Post will reach out to the VFW state headquarters and other Posts, veterans organizations and veterans service providers for input and/or volunteer assistance statewide.

Applicant's Background: Wayne N. Yoshioka, commander of VFW Post 8616, started his career as a television reporter for KITV-4 News covering City Government. He was then given a direct commission by Governor George Ariyoshi and went on to serve for 24-years as a public affairs officer for the Hawaii National Guard and National Guard Bureau at the Pentagon, Washington D.C. He was the State Department of Defense public affairs officer and was deeply involved in establishing the State Office of Veterans Services (OVS) in 1988. He also spearheaded the community and media relations effort for the planning, design and construction of the State's Korea and Vietnam War Memorials, dedicated in July 1994. He served a combat tour in Afghanistan, 2005-2006, where he commanded a public affairs detachment. He retired from active duty in 2007 and worked as the political reporter for Hawaii Public Radio, 2007-2019.

Goals and Objectives: The GWOT started on Sept. 11, 2001, in Afghanistan, and then included Iraq in 2003. After 21-years of combat, the GWOT was officially ended by the U.S. Department of Defense on Sept. 11, 2022.

A new joint study published on September 17, 2022, by the America's Warrior Partnership (AWP), Duke University and the University of Alabama indicated that the number of veteran suicides could be as high as forty-four (44) suicides per day. In the AWP's findings, 22-24 veterans ages 18-64 commit suicide each day and 18-20 veterans in the same age group die per day by self-injury. Combined, this points to at least 40-44 veterans taking their lives every day (2.4 times higher than Veterans Administration estimates). The VA, in a separate report, noted that from 2001 to 2020, suicides among 18–34-year-old veterans increased more than 94 percent. According to a recent Rand Study, nearly 20 percent of military service members and veterans reported symptoms of post-traumatic stress disorder (PTSD) and 10 percent of women experienced sexual trauma while in the military. The 2020 State of Hawai'i Homeless Point in Time Count tallied 356 unsheltered veterans on O'ahu and 132 for Hawai'i, Maui and Kaua'i.

Suicide Crisis Hotlines, Awareness and Reduction Programs, and VA counseling have not and are not working to decrease GWOT veteran suicides. A Memorial and Statuary Retreat gifted by the people of the State of Hawai'i would be dedicated to honor the fallen and provide a solemn retreat for veterans and families suffering from the emotional and physical trauma of modern warfare and the feelings of isolation because of their service and sacrifice in the nation's longest war. All of Hawai'i's previous combat veterans have war memorials constructed for them but the planning and design ideas were decided by only a few veterans. The GWOT Memorial and Retreat would seek input from GWOT veterans and Gold Star families to provide their input on design elements and underscore their importance to the State and emphasize the urgency of this recognition. Ultimately, it will promote a cause for all veterans to rally around, unite and reach out to one another.

This Grant in Aid (GIA) request would fund one fulltime employee to complete a statewide survey and exploratory study of Global War on Terrorism (GWOT) veterans, GWOT Gold Star Families as well as involve other veterans service organizations (VSOs) to provide a measure as to the extent of community support for the planning, design and construction of a GWOT Memorial and Statuary Retreat in the vicinity of the Korean and Vietnam Memorials on the grounds of the State Capitol at the far West-end of the property adjacent to Richards Street. The project would also seek input from GWOT veterans and Gold Star Families about their preferences for the basic design elements to be included in the Memorial and Statuary Retreat, starting with the 4 major iconic symbols of the GWOT: Battlefield Cross, a mourning Marine, a mourning Army soldier and Gold Star family. Based on GWOT veterans' and families' inputs the first four elements could be eliminated, modified or added to, based on the levels of preferences.

The acute need for this GIA project is twofold: 1. Decisions for all of Hawai'i's past war memorials were made by a few without consultation or involvement by other fellow combat veterans. 2. The alarming suicide rates among GWOT veterans, the isolation of families who suffer in silence must be addressed. The latter must be emphasized and repeated: crisis hotlines, awareness/reduction programs and VA counseling have done little to lower veteran suicide rates. A sanctuary chosen by the GWOT veterans and gifted by the State of Hawai'i for honoring the fallen, and a solemn retreat for remembrance, introspection and meditation will instill hope and pave the way to recovery, redemption and the love for life.

There are currently an estimated 117,000 (10 percent of the state's population) military veterans in the State of Hawaii – 105,000 men and 12 thousand women – of which nearly 35 thousand served in Afghanistan or Iraq or both theaters of operation. (Source: U.S. Senator Maize Hirono's Office)

III. SERVICE SUMMARY AND OUTCOME

1. Scope of Work, Tasks and Responsibilities: The initial effort will require hiring of a fulltime/high-quality associate who is a self-starter, is computer-literate, digitally-adept, and capable of performing the tasks to complete the project requirements in one year (preferably a VFW member/retiree with a computer, printer and home office). The salary and compensation level will be negotiable and pay up to \$5000/month (\$31.25/hour for 40-hour week). A \$1,000 monthly allowance will be available for documented purchase of ZOOM commercial account, computer external hard drive for data storage, USPS postage, commercial printing, mileage for official business and home office allowances. The individual would work primarily at home with some visits to the State of Hawaii Office of Veterans Services (OVS) to conduct outreach to GWOT veterans and Gold Star families as well as contacting and surveying nearly 100 registered veterans service organizations listed in the state to develop partnerships and encourage volunteerism. This full-time position would initially encompass the following:

Job Title: GWOT Memorial and Statue Committee Chair

Job Requirements:

- Cannot be a VFW officer or staff member (this is a full-time effort)
- Must be able to commit to a 40-hour work week and attend monthly VFW Post 8616 meetings for status reports and provide quarterly updates to VFW state headquarters
- Must have a computer, letter-quality printer, home office with physical file storage and vehicle
- Must be fluent in digital communications, Zoom and social media
- Must be proficient in Microsoft Office suite: Word, Excel and Power Point
- Must collect and maintain GWOT eligibility documents of veterans and Gold Star Families
- Must be able to document daily activities and provide weekly reports to VFW Post leadership.
- Desirable: VFW member; GWOT veteran/military retiree; public speaking skills; able to commit 1 year to the project and, if further funding is available, commit for another year.

The incumbent will contact and involve community, state leaders and stakeholders. The published end-product will provide the State with a list of GWOT veterans, GWOT families, supporters, volunteers, and potential donors who are committed to building a GWOT Memorial and Statuary Retreat. The statewide outreach effort will also require documented GWOT verification documents for veterans and families as well as multiple mailouts (USPS and electronic), distribution of pamphlets/brochures, face-to-face meetings with stakeholders as well as digital, social and news media coverage and publicity.

If this GIA is approved, VFW Post 8616 will work with the Office of Veterans Services (OVS) to develop/sign a Memorandum of Agreement for the execution of this project. The project would also provide a written status report to the State Legislature (House Finance Committee and Senate Committee on Ways and Means) before the start of the 2024 Legislative Session.

If any GIA or State funds are provided, Post Quartermaster (QM) will open a separate bank account, and, Post officers authorized to do so will issue checks as needed. Disbursements of \$50 or more will require Post QM approval; air travel, if any, will be minimal and ZOOM meetings will be utilized as much as feasible.

V. EXPERIENCE AND CAPABILITY:

1. As described in paragraph II, above, the VFW Post 8616 commander served as the State Department of Defense public affairs officer and was involved in the establishment of the Office of Veterans Services at every step and had a working relationship with Mr. Lawrence S.K. Lee (Lt. Col. Retired), the first director of OVS as well as the administration of Governor John Waihee. He was also involved with the planning, design, and community outreach for the building of the Korea and Vietnam War Memorials and worked extensively with Mr. Alfred Los Banos, a Korean War veteran, who spearheaded the veterans' efforts to have a Memorial built. This exploratory study is the first step in that process to build a lasting GWOT Memorial for the fallen, the living veterans and Gold Star Families. Other state agencies (OVS) can then take over and conduct design contests, requests for proposals, contracting and construction. The commander's knowledge of state government and the legislative process as well as public affairs will greatly help launch this effort to honor GWOT veterans; memorialize those who lost their lives and have a gathering place for the veterans and Gold Star families to touch the boots of the field memorial (helmet, M-16 and boots) that might be depicted.

The single full-time employee will have a home office and printing capabilities. If additional space is required, the Post will seek a no-cost option to fulfill that need.

VI. PERSONNEL: Project Organization and Staffing

1. Qualifications, Supervision and Training: see paragraph III. Service Summary and Outcomes, item 1. The incumbent will be a high-quality candidate who will have demonstrated abilities and will be a self-starter and results-oriented individual.

2. Organization Chart. The Post commander, senior vice commander, junior vice commander, quartermaster/adjutant and other volunteer Post members will provide GIA project oversight, and all Post members will provide aid/assistance and advice to the Chair as requested or as needed. The Post commander will exercise ultimate authority.

3. Compensation. The single full-time employee, GWOT Memorial and Statuary Retreat Committee Chair, will be paid \$5,000/month for a 40-hour work week (\$31.25/hour). Reimbursements will also made for documented mileage, office supply receipts and other small expenditures with spending over \$50 requiring post officer approval.

VII. OTHER

1. Litigation: There is no pending litigation for the Post or any of its officers

2. Licensure or Accreditation: As a military retiree, the Post commander has access to all military facilities. If a military retiree is selected for the full-time job, he or she will also have equal access.

3. Private Educational Institutions: GIA funding will not be used to support or benefit a sectarian or non-sectarian private educational institution.

4. Future Sustainability Plan: The VFW Post intends to provide the Legislature and State Office of Veterans Services the exploratory results in a written report. The State can then initiate legislative requests, design contests, private-public partnerships, requests for proposals and build the GWOT Memorial and Statuary Retreat.
