## DEPARTMENT OF PUBLIC SAFETY SECTION 134-16 (d), HRS ANNUAL REPORT TO THE 2023 LEGISLATURE

Chapter 134-16(d) of the Hawaii Revised Statutes states:

The county police departments of this State, the department of public safety, the department of land and natural resources, and the army and air national guard shall maintain records regarding every electric gun in their custody and control. The records shall report every instance of usage of the electric guns; in particular, records shall be maintained in a similar manner as for those of discharging of firearms. The county police departments, the department of public safety, the department of land and natural resources, and the army and air national guard shall annually report to the legislature regarding these records no later than twenty days before the beginning of each regular session of the legislature.

The Department of Public Safety (PSD) has 25 Axon Taser 7 conducted electric weapons in its inventory.

PSD's conducted electric weapons are currently being carried in the field under a limited pilot project in its Law Enforcement Division. Based on the safety provided by these weapons when they are carried, PSD has respectfully requested, via a separate budget request, that the Legislature consider an appropriate level of funding so that its pilot project can be expanded to provide for a conducted electric weapon to be issued for all of its law enforcement officers.

During 2022, PSD had three (3) incidents of its conducted electric weapons being used in the field during confrontations with resistant subjects, which are summarized below.
