A BILL FOR AN ACT

RELATING TO COFFEE PEST CONTROL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1 | SECTION 1. In accordance with section 9 of article VII of |

| 2 | the Hawaii State Constitution and sections 37-91 and 37-93, |
| 3 | Hawaii Revised Statutes, the legislature has determined that the |
| 4 | appropriations contained in H.B. No. 300, H.D. 1, S.D. 1, |
| 5 | C.D. 1, and this Act will cause the state general fund |
| 6 | expenditure ceiling for fiscal year 2023-2024 to be exceeded by |
| 7 | \$1,063,917,367 or 11.0 per cent. This current declaration takes |
| 8 | into account general fund appropriations authorized for fiscal |
| 9 | year 2023-2024 in H.B. No. 300, H.D. 1, S.D. 1, C.D. 1, and this |
| 10 | Act only. The reasons for exceeding the general fund |
| 11 | expenditure ceiling are that: |
| 12 | (1) The appropriation made in this Act is necessary to |
| 13 | serve the public interest; and |
| 14 | (2) The appropriation made in this Act meets the needs |
| 15 | addressed by this Act. |
| 16 | SECTION 2. The legislature finds that coffee is one of the |
| 17 | largest agricultural crops in the State and is a highly valued |

1 berry borer, a small beetle, has infested coffee crops in the Kona and Ka'ū regions of Hawai`i island, and more recently has 2 been detected on O'ahu, Maui, Kaua'i, and Lana'i. In 2020, coffee 3 leaf rust, caused by a fungal pathogen, was discovered for the 4 5 first time in the State on Maui and Hawai'i island. These two 6 pests threaten the viability of the State's entire coffee 7 industry. Efforts to control coffee berry borer and coffee leaf 8 rust, including the use of United States Food and Drug 9 Administration-approved pesticides, are critical to the local 10 coffee industry, and it is incumbent upon the State to continue 11 to support these efforts.

12 The legislature further finds that in response to these 13 threats to the industry, the coffee berry borer pesticide 14 subsidy program was established by Act 105, Session Laws of 15 Hawaii 2014 (Act 105), to assist Hawai'i coffee farmers with 16 offsetting the cost of pesticides containing the fungus 17 Beauvería bassiana, which is known to control coffee berry 18 borer. Due to a longer-than-anticipated implementation of Act 19 105, in 2017, the legislature extended the pesticide subsidy 20 program from its original sunset date of June 30, 2019, to June 30, 2021, via Act 65, Session Laws of Hawaii 2017 (Act 65). 21

After continued programmatic success and the initial discovery
 of coffee leaf rust in the islands, in 2021, the legislature
 extended the pesticide subsidy program for another two years,
 adding a subsidy for coffee leaf rust pesticides.

5 As of December 9, 2022, the department of agriculture has 6 received nine hundred eighty receipts for reimbursement under 7 the coffee berry borer pesticide subsidy program, expending a 8 total of \$812,319.99 for the mitigation of coffee berry borer 9 and coffee leaf rust throughout the State. The legislature 10 finds that, as illustrated by program demand, coffee berry borer 11 and coffee leaf rust continue to pose a severe threat to the 12 State's coffee industry, and it is incumbent upon the State to 13 continue supporting farmers' mitigative efforts, including 14 through reducing the financial burden of having to purchase 15 certain pesticides at market value.

Accordingly, the purpose of this Act is to:
17 (1) Extend the pesticide subsidy program to June 30, 2025;
18 (2) Extend the pesticide subsidy manager position,
19 including the position's exemptions from civil service
20 and collective bargaining laws, until June 30, 2026;

19 (2) Manage the day-to-day coordination for the pesticide20 subsidy program.
