A BILL FOR AN ACT

RELATING TO RESTRICTIONS ON AGRICULTURAL USES AND ACTIVITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 205-4.6, Hawaii Revised Statutes, is 1 amended by amending subsection (a) to read as follows: 2 "(a) Agricultural uses and activities as defined in 3 sections 205-2(d) and 205-4.5(a) on lands classified as 4 agricultural shall not be restricted by any private agreement 5 contained in any: 6 Deed, agreement of sale, or other conveyance of land 7 (1)recorded in the bureau of conveyances after July 8, 8 2003, that subjects the agricultural lands to any 9 servitude, including but not limited to covenants, 10 easements, or equitable and reciprocal negative 11 servitudes; provided that any private agreement 12 contained in a conveyance of land recorded on or 13 before July 8, 2003, that: 14 Limits or prohibits agricultural use or activity; 15 (A)

20	easements shall not be subject to this section."
