A BILL FOR AN ACT

RELATING TO CRIMINAL PROPERTY DAMAGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that vandalism of local 2 businesses has become a common occurrence. Reports of 3 "smash-and grab" crimes, in which thieves aggressively smash a 4 door, window, or display case and grab as much merchandise as 5 possible before fleeing the scene, are on the rise. The legislature also finds that these crimes are especially 6 7 concerning when perpetrated against small businesses. Many of 8 these businesses are locally- or independently-owned and survive 9 month-to-month on thin profit margins. Given the importance of 10 small businesses in a vibrant and diversified economy and their 11 continued survival, the legislature believes that greater 12 protections for small businesses are needed.

13 The legislature further finds that small businesses are 14 disproportionately burdened by the amount of time required to 15 make a complete report of criminal property damage with 16 supporting documentation to law enforcement authorities. When a 17 business owner is unable to obtain an estimate to repair or

replace damaged property within the short time frame typically 1 2 requested by law enforcement authorities, the alleged offender 3 may receive more lenient treatment, especially if being held in 4 custody pending the initial court appearance. More 5 specifically, the crime that is ultimately charged may be the 6 petty misdemeanor offense of criminal property damage in the 7 fourth degree, which does not account for the dollar amount of 8 property damage committed. Although it is more expedient to 9 initiate a prosecution for this lesser offense due to the need 10 to prove fewer elements, especially when the case may be 11 resolved quickly by sentencing the alleged offender to credit 12 for time served, this outcome has less deterrent value. 13 The purpose of this Act is to reduce the burden on business 14 owners in the State by amending the misdemeanor offense of 15 criminal property damage in the third degree to include 16 intentionally or knowingly damaging the property of another that 17 is used in a business operation, without the other's consent, in 18 any amount.

19 SECTION 2. Section 708-822, Hawaii Revised Statutes, is 20 amended to read as follows:
