A BILL FOR AN ACT

RELATING TO CORRECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that a civil lawsuit in 2 federal court alleged that a group of women at the women's 3 community correctional center were sexually assaulted at least 4 fifty-three times from 2013 to 2016. A similar case, Smith v. 5 State of Hawaii, resulted in a \$100,000 settlement, with \$50,000 coming from the State and another \$50,000 coming from the adult 6 7 correctional officer who pled quilty. These lawsuits pointed specifically to the lack of cameras in the correctional center's 8 9 control rooms, where a majority of the sexual assaults allegedly 10 occurred. According to court documents, in some cases, staff offered food, makeup, crystal meth, and special privileges to 11 12 inmates in return for compliance with sexual demands and punishments for noncompliance. Any sexual contact between an 13 14 inmate and staff is a felony under existing law because 15 prisoners cannot legally give consent.

16 The legislature further finds that additional cameras in 17 control rooms and body cameras for all adult correctional

officers would help deter sexual assaults and contraband, 1 thereby building a defense against future lawsuits and 2 protecting inmates from rogue adult correctional officers. 3 4 The purpose of this Act is to appropriate funds for: The purchase and installation of digital cameras in 5 (1)all adult correctional officer control rooms at state 6 7 correctional facilities; and 8 (2) The purchase of body cameras for adult correctional 9 officers to wear while on duty at state correctional 10 facilities. 11 SECTION 2. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 12 or so much thereof as may be necessary for fiscal year 2023-2024 and 13 14 the same sum or so much thereof as may be necessary for fiscal 15 year 2024-2025 to purchase and install digital cameras in all 16 adult correctional officer control rooms at state correctional 17 facilities and to purchase body cameras for adult correctional 18 officers to wear while on duty at state correctional facilities. 19 The sums appropriated shall be expended by the department 20 of public safety for the purposes of this Act.
