
A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF LAND AND NATURAL RESOURCES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. There is appropriated out of the general
2 revenues of the State of Hawaii the sum of \$ or so
3 much thereof as may be necessary for fiscal year 2023-2024 and
4 the same sum or so much thereof as may be necessary for fiscal
5 year 2024-2025 to establish one full-time equivalent (1.0 FTE)
6 homelessness coordinator position within the department of land
7 and natural resources; provided that the position shall:

- 8 (1) Be based on Maui; and
9 (2) Coordinate activities across all divisions of the
10 department of land and natural resources to respond to
11 homeless individuals on department of land and natural
12 resources lands on Maui.

13 The sums appropriated shall be expended by the department
14 of land and natural resources for the purposes of this Act.

15 SECTION 2. There is appropriated out of the general
16 revenues of the State of Hawaii the sum of \$ or so
17 much thereof as may be necessary for fiscal year 2023-2024 and



1 the same sum or so much thereof as may be necessary for fiscal
2 year 2024-2025 to establish one full-time equivalent (1.0 FTE)
3 homelessness coordinator position within the department of land
4 and natural resources; provided that the position shall:

- 5 (1) Be based on Oahu; and
- 6 (2) Coordinate activities across all divisions of the
7 department of land and natural resources to respond to
8 homeless individuals on department of land and natural
9 resources lands on Oahu.

10 The sums appropriated shall be expended by the department
11 of land and natural resources for the purposes of this Act.

12 SECTION 3. There is appropriated out of the general
13 revenues of the State of Hawaii the sum of \$ or so
14 much thereof as may be necessary for fiscal year 2023-2024 and
15 the same sum or so much thereof as may be necessary for fiscal
16 year 2024-2025 to establish one 0.5 full-time equivalent (0.5
17 FTE) homelessness coordinator position within the department of
18 land and natural resources; provided that the position shall:

- 19 (1) Be based on Kauai; and
- 20 (2) Coordinate activities across all divisions of the
21 department of land and natural resources to respond to



1 homeless individuals on department of land and natural
2 resources lands on Kauai.

3 The sums appropriated shall be expended by the department
4 of land and natural resources for the purposes of this Act.

5 SECTION 4. There is appropriated out of the general
6 revenues of the State of Hawaii the sum of \$ or so
7 much thereof as may be necessary for fiscal year 2023-2024 and
8 the same sum or so much thereof as may be necessary for fiscal
9 year 2024-2025 to establish one 0.5 full-time equivalent (0.5
10 FTE) homelessness coordinator position within the department of
11 land and natural resources; provided that the position shall:

- 12 (1) Be based on Hawaii island; and
- 13 (2) Coordinate activities across all divisions of the
14 department of land and natural resources to respond to
15 homeless individuals on department of land and natural
16 resources lands on Hawaii island.

17 The sums appropriated shall be expended by the department
18 of land and natural resources for the purposes of this Act.

19 SECTION 5. This Act shall take effect on June 30, 3000.
