A BILL FOR AN ACT

RELATING TO STATE WATER CODE PENALTIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that in 1987, the state water code was adopted to protect the precious water resources of the State. To better enable the department of land and natural resources and commission on water resource management to carry out that mission, the legislature further finds that the water code's penalties and fines must be amended and increased to serve as an effective deterrence to violators.

8 The purpose of this Act is to ensure that all violators of
9 the state water code are held accountable for their violations
10 by creating a minimum penalty of \$50 for every violation.

SECTION 2. Section 174C-15, Hawaii Revised Statutes, is amended to read as follows:

13 "\$174C-15 Penalties and common law remedies. (a) The
14 commission may enforce its rules and orders adopted pursuant to
15 this chapter by suit for injunction or for damages or both.
16 (b) Any person who violates any provision of this chapter,
17 [or] violates any rule adopted pursuant to this chapter, [may]
