

### A BILL FOR AN ACT

RELATING TO ANIMALS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State's pet 2 overpopulation issue must be addressed. Every year, thousands 3 of unwanted animals arrive at state animal shelters and rescue 4 organizations. The Hawaiian Humane Society alone receives 5 approximately four thousand unwanted dogs and puppies each year. 6 Sadly, this is a national trend - approximately two million 7 homeless pets are euthanized in the United States every year. 8 The legislature further finds that animals sold in pet 9 stores are often obtained from unregulated commercial breeders 10 who do not provide sanitary and humane living conditions for the 11 animals. Additionally, many of the puppies sold in pet stores 12 are obtained from mass breeding operations known as puppy mills. 13 In Hawaii, these puppy mills are often hidden from public view 14 on lands that are designated for agricultural use and exempt 15 from a law that limits dog ownership to a maximum of ten dogs.

16 The legislature also finds that there are responsible and 17 ethical breeders who only sell animals directly to private

1	individuals. These breeders often spend more time and resources
2	on their animals than other breeders, and they play an important
3	role in maintaining healthy lines for purebred animals.
4	Therefore, it is not the legislature's intent that this Act
5	impact these ethical and responsible breeders.
6	The purpose of this Act is to encourage animal adoption by
7	prohibiting pet stores from selling dogs, cats, and rabbits
8	unless the animal was obtained from certain humane sources.
9	SECTION 2. Chapter 142, Hawaii Revised Statutes, is
10	amended by adding a new section to be appropriately designated
11	and to read as follows:
12	" <u>§142-</u> Sales of dogs, cats, and rabbits in pet stores.

2	(B) Any person or entity meeting the description
3	under paragraph (1), (2), or (3).
4	(b) Each pet store operator shall maintain records
5	sufficient to document the source of each dog, cat, or rabbit
6	obtained by the pet store for at least one year following the
7	date that the pet store obtained the animal.
8	(c) Each pet store operator shall post, in a conspicuous
9	location on the cage or enclosure of each dog, cat, or rabbit
10	offered for sale, a sign displaying the name and address of the
11	person or entity listed under subsection (a)(1) through (4) from
12	which the pet store obtained the dog, cat, or rabbit.
13	(d) A pet store operator that violates this section shall
14	be subject to a civil penalty of \$500. Each animal offered for
15	sale in violation of this section shall constitute a separate
16	offense.
17	(e) Upon request from the department, a pet store operator
18	engaged in the sale of dogs, cats, or rabbits shall provide the
19	records maintained under subsection (b).
20	(f) The department may adopt rules pursuant to chapter 91
21	necessary to carry out the purposes of this section.

1	(g) For purposes of this section:
2	"Pet store operator" means the owner of a place or premise
3	where birds, mammals, or reptiles are kept for the purpose of
4	offering the animals for sale.
5	"Rescue group" means an organization that is tax exempt
6	under section 501(c)(3) of the Internal Revenue Code and that
7	does not obtain animals from breeders or brokers for
8	compensation."
9	"Sale" includes wholesale and retail transactions involving
10	animals; the import or export, or both, of animals; and the
11	disposition of animals by barter, gift, or exchange."
12	SECTION 3. This Act does not affect rights and duties that
13	matured, penalties that were incurred, and proceedings that were
14	begun before its effective date.
15	SECTION 4. New statutory material is underscored.
16	SECTION 5. This Act shall take effect upon its approval.
