### A BILL FOR AN ACT

RELATING TO PURCHASES OF HEALTH AND HUMAN SERVICES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to amend the 2 procurement laws relating to purchases of health and human 3 services by abolishing the community council on purchase of 4 health and human services. The community council was 5 established in 1997 by section 103F-202, Hawaii Revised 6 Statutes, for the purpose of providing input and advising the 7 state procurement administrator in developing the rules, 8 infrastructure, and procedures for procuring health and human 9 services. More than twenty-five years later, the rules are well 10 established and both providers and purchasing agencies are 11 accustomed to the procurement process. Any further rule changes 12 can be managed through the procurement policy board. 13 SECTION 2. Section 103F-202, Hawaii Revised Statutes, is

14 repealed.

16 established a community council on purchase of health and human

1	than nine voting members, and one non-voting, ex-officio member
2	of the interagency committee on purchase of health or human
3	services designated by the majority of the members of the
4	committee. There shall be a member from each county, except the
5	county of Kalawao, and up to five members interested in health,
6	human services, employment, or the provision of services to
7	children and youth.
8	(b) Voting members shall be appointed by the governor and
9	serve for four years. Each voting member shall serve until the
10	member's successor is appointed. Section 26-34 shall apply
11	insofar as it relates to the number of terms and consecutive
12	number of years a member may serve on the council.
13	(c) Members shall serve without compensation, but shall be
14	reimbursed for actual expenses, including travel expenses,
15	necessary for the performance of their duties.
16	(d) The community council shall advise the administrator
17	about or assist the administrator in:
18	(1) Market or business conditions facing providers;
19	(2) Securing input-from providers to facilitate agency
20	decision-making to assess needs, plan, budget, and
21	purchase health and human services;
