16 WHEREAS, on August 26, 2022, under agenda item D-4 of a 17 meeting of the Board of Land and Natural Resources, the Board 18 approved a grant of a 25-year non-exclusive easement to resolve 19 the boat ramp and concrete wall encroachments, to run with the 20 land and to inure to the benefit of the abutting real property; 21 and

WHEREAS, as determined by the property owner, the total
encroachment area was 319 square feet, which is subject to
review and approval by the Department of Accounting and General
Services' Survey Division; and

28 WHEREAS, the grantee shall pay the State the fair market 29 value of the non-exclusive easement as consideration of the use

of state submerged lands to be determined by an independent 1 2 appraisal; and 3 WHEREAS, section 171-53, Hawaii Revised Statutes, requires 4 5 the prior approval of the Governor and prior authorization of 6 the Legislature by concurrent resolution to lease state 7 submerged lands; now, therefore, 8 9 BE IT RESOLVED by the House of Representatives of the 10 Thirty-second Legislature of the State of Hawaii, Regular Session of 2023, the Senate concurring, that the Board of Land 11 and Natural Resources is hereby authorized to issue a term, non-12 exclusive easement covering a portion of state submerged lands 13 fronting the property identified as Tax Map Key: (1) 4-5-047: 14 15 seaward of 051, Kaneohe, Koolaupoko, Oahu, for the existing boat ramp and concrete wall, and for use, repair, and maintenance of 16 the existing improvements constructed thereon pursuant to 17 18 section 171-53, Hawaii Revised Statutes; and 19 20 BE IT FURTHER RESOLVED that a certified copy of this 21 Concurrent Resolution be transmitted to the Chairperson of the Board of Land and Natural Resources. 22 23 24 25
