## HOUSE CONCURRENT RESOLUTION

URGING THE CITY AND COUNTY OF HONOLULU DEPARTMENT OF PARKS AND RECREATION TO CONDUCT NECESSARY REPAIRS AND MAINTENANCE OF FACILITIES LOCATED AT PATSY T. MINK CENTRAL OAHU REGIONAL PARK.

1 WHEREAS, Patsy T. Mink Central Oahu Regional Park is a 269  
2 acre public park located in Waipio, Oahu, and operated by the  
3 City and County of Honolulu Department of Parks and Recreation;  
4 and

6 WHEREAS, the Patsy T. Mink Central Oahu Regional Park was  
7 opened in 2001 as the Central Oahu Regional Park and was renamed  
8 after United States Representative Patsy T. Mink in 2007; and  
9

10 WHEREAS, the park complex includes a tennis center with  
11 twenty courts, the K. Mark Takai Veterans Memorial Aquatic  
12 Center, four youth baseball diamonds, four regulation size  
13 baseball diamonds, a four diamond softball complex, other  
14 multipurpose fields, and a twenty-lane archery range; and  
15

16 WHEREAS, in March 2021 the park complex added a 12,800  
17 square-foot dog park; and  
18

19 WHEREAS, the park complex is a globally recognized  
20 recreation facility that hosts various national and  
21 international sporting events; and  
22

23 WHEREAS, aspects of the park complex have fallen under  
24 disrepair, including broken water fountains, overgrown grass,  
25 and trash accumulation; and  
26

27 WHEREAS, volunteers have conducted certain repairs and  
28 maintenance around the park complex; and

1 WHEREAS, in October 2022, the Department of Parks and  
 2 Recreation completed a park complex field maintenance proposal,  
 3 which outlines certain maintenance issues and proposes new  
 4 preferred practices to enhance the life, use, and enjoyment of  
 5 everyone that uses the park complex; now, therefore,  
 6

7 BE IT RESOLVED by the House of Representatives of the  
 8 Thirty-second Legislature of the State of Hawaii, Regular  
 9 Session of 2023, the Senate concurring, that the City and County  
 10 of Honolulu Department of Parks and Recreation is urged to  
 11 conduct necessary repairs and maintenance of facilities located  
 12 at Patsy T. Mink Central Oahu Regional Park; and  
 13

14 BE IT FURTHER RESOLVED that the City and County of Honolulu  
 15 is requested to act on the existing Department of Parks and  
 16 Recreation Park complex field maintenance proposal; and  
 17

18 BE IT FURTHER RESOLVED that the Department of Parks and  
 19 Recreation is urged to reimburse volunteers, who have conducted  
 20 repairs and maintenance at the park complex; and  
 21

22 BE IT FURTHER RESOLVED that certified copies of this  
 23 Concurrent Resolution be transmitted to the Mayor of the City  
 24 and County of Honolulu, Chair of the Honolulu City Council, and  
 25 Director of the Department of Parks and Recreation of the City  
 26 and County of Honolulu.
