HOUSE CONCURRENT RESOLUTION

AUTHORIZING THE ISSUANCE OF A TERM, NON-EXCLUSIVE EASEMENT COVERING A PORTION OF STATE SUBMERGED LANDS AT HAUULA, KOOLAULOA, OAHU, FOR THE EXISTING RIPRAP REVETMENT, RAMP, AND ROCK GROIN, AND FOR USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS CONSTRUCTED THEREON.

WHEREAS, portions of the existing riprap revetment, ramp, 1 and rock groin fronting the property identified as Tax Map Key: 2 (1) 5-3-008:seaward of 012, Hauula, Koolauloa, Oahu, were placed 3 on state submerged lands; and 4 5 WHEREAS, about April 2022, the Department of Land and 6 7 Natural Resources' Office of Conservation and Coastal Lands worked with the property owners, Steven Ernest MacBride and 8 9 Valerie Jean MacBride, Trustees of the Steven and Valerie MacBride Revocable Trust dated October 30, 2018, to resolve the 10 11 encroachment; and 12 WHEREAS, the Office of Conservation and Coastal Lands 13 indicated that it supported a non-exclusive easement to resolve 14 the encroachment; and 15 16 WHEREAS, at its meeting of August 26, 2022, under agenda 17 item D-5, the Board of Land and Natural Resources approved a 18 grant of a twenty-five-year non-exclusive easement to resolve 19 the riprap revetment, ramp, and rock groin encroachment, and 20 such non-exclusive easement shall run with the land and shall 21 inure to the benefit of the abutting real property; and 22 23 WHEREAS, the total encroachment area was determined to be 24 1,900 square feet, more or less, subject to review and approval 25 by the Department of Accounting and General Services' Survey 26 27 Division; and 28

1 WHEREAS, the grantee shall pay the State the fair market 2 value of the non-exclusive easement as consideration of the use 3 of public lands, to be determined by an independent appraisal; 4 and

6 WHEREAS, section 171-53, Hawaii Revised Statutes, requires
7 the prior approval of the Governor and prior authorization of
8 the Legislature by concurrent resolution to lease state
9 submerged lands; now, therefore,

11 BE IT RESOLVED by the House of Representatives of the Thirty-second Legislature of the State of Hawaii, Regular 12 Session of 2023, the Senate concurring, that the Board of Land 13 14 and Natural Resources is hereby authorized to issue a term, nonexclusive easement covering a portion of state submerged lands 15 fronting the property identified as Tax Map Key: (1) 5-3-16 008:seaward of 012, Hauula, Koolauloa, Oahu, for the existing 17 18 riprap revetment, ramp, and rock groin, and for use, repair, and 19 maintenance of the existing improvements constructed thereon pursuant to section 171-53, Hawaii Revised Statutes; and 20 21
